s.22, paid to enter the BC LEH draw for moose, near Prince George. s.22 were lucky enough to have their group chosen, so we all bought our tags, and had our truck and trailer serviced and started other preparations to go at the end of September. In the end, we have spent a lot of money to go hunting and are scheduled to leave in two weeks.

On September 6th, we were notified by a friend in Prince George, that a first nations group is putting a ban on all LEHs.

I called Ian Leeson, at the Ministry of Forests, Lands, Natural Resource Operations and Rural Development, as his number was on the public website. He was not aware of the issue and told me there would be no problem with us going.

September 7th, I found out about the Prince George Citizen news report so I called Pam Martins @ 778-698-9229 email: Pam.Martins@gov.bc.ca (Ian was away) regarding the ban and blockade the first nations groups planned to put on the BC Limited Entry Hunt.

She was aware that they were “blocking all limited-entry hunts from a plot of land...” as reported in the Prince George Citizen.

Pam stated the Ministry has posted an “Important Notice” on their website stating that they are aware of this ban and they do not recognize it so all of our authorizations and licences are still valid.

I asked if we could get our tag moved to an area north of the ban (ex: 7-15) as we’re concerned about putting our daughter in a potentially dangerous, volatile situation, but Pam stated that the Ministry will not do that as they do not recognize the blockade and we might not even run into one. She also told me that if we do come across a blockade, that we are to call the local RCMP detachment.

I called the PG detachment @ 1-250-561-3300 and spoke to a constable and explained the situation. I asked if they would respond to our call and safely take us passed any blockades we encounter. He was not aware of anything, so he investigated what was reported and called me back. He stated that I “would not be happy.” He explained that they follow the direction of the “higher ups” in the government and would have to wait until they received that direction. I explained that we live on

Vancouver Island and this is a long way to drive, and therefore, very expensive, and don't want to be turned away at the last minute. He said to call a few days before we are leaving to ensure there are no blockades.

I asked if we could get our tag moved to an area north of the ban (ex: 7-15) as we're concerned about putting our daughter in a potentially dangerous, volatile situation, but Pam stated that the Ministry will not do that as they do not recognize the blockade and we might not even run into one. She also told me that if we do come across a blockade, that we are to call the local RCMP detachment.

I called the PG detachment @ 1-250-561-3300 and spoke to a constable and explained the situation. I asked if they would respond to our call and safely take us passed any blockades we encounter. He was not aware of anything, so he investigated what was reported and called me back. He stated that I "would not be happy." He explained that they follow the direction of the "higher ups" in the government and would have to wait until they received that direction. I explained that we live on Vancouver Island and this is a long way to drive, and therefore, very expensive, and don't want to be turned away at the last minute. He said to call a few days before we are leaving to ensure there are no blockades.

UPDATE: Notice to hunters: First Nations announced closures:

- Members of local First Nations have issued a news release suggesting they are closing portions of the Cariboo, Omineca and Skeena to all LEH hunting. The following LEH Areas within the boundary include:
 - 5-3, 5-4A, 5-4B, 5-4C, 5-5, 5-6, 5-10, 5-11, 5-12A, 5-12B, 5-13A, 5-13B, 5-13C, 5-14, 5-15B, 5-15C, 5-15D, 6-1, 7-4, 7-10, 7-11, and 7-12B, and
 - Portions of 5-2, 6-2A, 6-2B, 6-4, 7-3, 7-5, 7-6, and 7-8.
- The Province considers the licences of guides, resident hunters and non-resident hunters

to be valid.

- At this time we do not know what First Nations are planning with respect to enforcement of their announcement.
- We ask everyone to remain respectful of one another on the ground while we look at options to resolve the situation.
- Hunters seeking direction on what to do if they encounter a protest, or who wish to report any confrontation, should contact their local RCMP detachment.

Media inquiries:

- This government has a clear responsibility to protect and manage wildlife in the best interest of all British Columbians.
- The Province is committed to reconciliation and the United Nations Declaration on the Rights of Indigenous People.
- We are continuing to sit down with First Nations governments to build a more lasting collaborative approach to enhance moose numbers together.
- In the Cariboo for example, all resident hunting is managed through Limited Entry Hunt which is the most closely managed hunt opportunity, and throughout the Chilcotin the LEH hunt is further enforced with compulsory inspection to confirm harvest information and inform management.
- The Province's data on moose harvest management clearly shows LEH harvest managed does not lead to moose population declines.
- In the Chilcotin LEH hunting has been reduced by 60% from 2011 levels.
- On August 24, further closures and access restrictions were put in place after additional consultation with First Nations.
- We are not planning on expanding existing closures at this time.

What is the impact of wildfires on moose populations?

- Analysis of the effects of the 2017 wildfires are consistent with prevailing science that suggest that wildlife populations are not significantly impacted by wildfires, and any wildlife mortality directly related to fires is considered to be outweighed by the long-term benefits of wildfire to habitat and wildlife.
- For example:
 - The Province prescribes burns frequently in areas to improve wildlife habitat and thus benefit population growth.
 - The 2017 Plateau fires in the Chilcotin were aerially surveyed and show ungulates remaining in newly burnt landscapes. In Zone 5-13A (60% of which was in the fire perimeter), surveys comparing moose densities before and after the wildfire showed moose populations remained stable.
 - Surveys following the 2017 Elephant Hill Fire did not notice a change in moose numbers within the burn and some of the highest densities observed were within the burn.

- Nevertheless, as a precaution additional reductions to LEH in the Chilcotin were implemented to address the removal of security cover and the potential for increased hunter success as a result of the 2017 wildfires.

s.22, paid to enter the BC LEH draw for moose, near Prince Georges.22 were lucky enough to have their group chosen, so we all bought our tags, and had our truck and trailer serviced and started other preparations to go at the end of September. In the end, we have spent a lot of money to go hunting and are scheduled to leave in two weeks.

On September 6th, we were notified by a friend in Prince George, that a first nations group is putting a ban on all LEHs.

I called Ian Leeson, at the Ministry of Forests, Lands, Natural Resource Operations and Rural Development, as his number was on the public website. He was not aware of the issue and told me there would be no problem with us going.

September 7th, I found out about the Prince George Citizen news report so I called Pam Martins @ 778-698-9229 email: Pam.Martins@gov.bc.ca (Ian was away) regarding the ban and blockade the first nations groups planned to put on the BC Limited Entry Hunt. She was aware that they were “blocking all limited-entry hunts from a plot of land...” as reported in the Prince George Citizen. Pam stated the Ministry has posted an “Important Notice” on their website stating that they are

aware of this ban and they do not recognize it so all of our authorizations and licences are still valid.

I asked if we could get our tag moved to an area north of the ban (ex: 7-15) as we're concerned about putting our daughter in a potentially dangerous, volatile situation, but Pam stated that the Ministry will not do that as they do not recognize the blockade and we might not even run into one. She also told me that if we do come across a blockade, that we are to call the local RCMP detachment.

I called the PG detachment @ 1-250-561-3300 and spoke to a constable and explained the situation. I asked if they would respond to our call and safely take us passed any blockades we encounter. He was not aware of anything, so he investigated what was reported and called me back. He stated that I "would not be happy." He explained that they follow the direction of the "higher ups" in the government and would have to wait until they received that direction. I explained that we live on Vancouver Island and this is a long way to drive, and therefore, very expensive, and don't want to be turned away at the last minute. He said to call a few days before we are leaving to ensure there are no blockades.

We were so excited to FINALLY win the lottery as it takes 6-7 years on average to get a draw (mine actually took 9!)

What have we won? 2 tags for a disputed area that the government seems to have no position on as I have not received a response yet. The RCMP are also waiting for a response from the government in order to tell me what they can do.
