Thank you for your letter dated April 15, 2018, addressed to the Honourable Doug Donaldson, Minister of Forests, Range, Natural Resource Operations, and Rural Development, and your letter dated April 24, 2018, addressed to Linda Larson, MLA for the Boundary-Similkameen, regarding the recent decision to replace the general open season (GOS) for Black bear on Haida Gwaii with limited entry hunting (LEH). Minister Donaldson and MLA Larson have requested that I respond on their behalf, my apologies for the delay.

The Haida First Nation (HFN) have traditional and cultural values for black bears, and in 2005, the Province of British Columbia made a commitment to the HFN to review options to end the commercial (guided) and recreational (resident) hunt of Black bears on Haida Gwaii. In 2008, that commitment was further refined that if the HFN purchased the guide outfitting territories on Haida Gwaii and ended the commercial hunt of Black bears, that the annual resident harvest of Black bears would be capped at 4. This agreement was put into place to fulfill the mandate to maintain an effective and respectful relationship with the HFN and the commitment to represent the resident hunters of British Columbia.

In the spring of 2011, the HFN purchased the guide outfitting territories on Haida Gwaii, ending the non-resident hunt of Black bears. Government then fulfilled the 2008 commitment and implemented regulations capping the resident licensed harvest of Black bears on Haida Gwaii at 4 per year. The annual bag limit for Black bears on Haida Gwaii was also decreased from two to one to accommodate for the harvest cap.

Monitoring of Black bears harvested by BC residents has been completed through the Compulsory Inspection (CI) program. According to CI records, from 2011 to 2017 an average of 3.3 Black bears have been harvested by licensed hunters annually.

Since the harvest cap of 4 bears per year on Haida Gwaii, wildlife program staff have had challenges administering the harvest cap regulations, and some hunters have had challenges embarking on Black bear hunting trips to Haida Gwaii as it was difficult to determine if the 4 bear cap had been reached, or if it would be reached during their travel to the islands and be closed upon their arrival.

In your letter you reference text from the LEH Synopsis, note that the content of the LEH synopsis is not a policy document. However, the language in the synopsis supports the decision to replace the GOS with a LEH season as it limits the number of animals that may be harvested (i.e., the wildlife management objective) and the number of hunters (i.e., hunter opportunity). Further, using LEH as a tool to manage this hunt is appropriate as it reduces administrative burden, ensures that the harvest cap is not exceeded, and provides greater certainty to those hunters, in possession of a LEH authorizations, hunting Black bears on Haida Gwaii.

In your letter you also ask “what information was passed along to the Minister from the Province’s wildlife biologists that would lead you to authorize this LEH and eliminate the GOS?” The rationale provided to the Minister was as described in this letter; reduction of administrative burden, regulation simplification, and providing certainty to hunters and that it was not based on a conservation concern or sustainable harvest rates.

Thank you again for your letters, it is apparent through the effort you’ve put into your graphs and letter that you are passionate about wildlife management in the Province.

Resources: Firefighters - 17, heli - 1, heavy equipment - 9

What happened yesterday evening/overnight: Fire is burning Rank 2 – 3 in a Cedar Hemlock fuel type on flat to rolling terrain. Ground crews continued to plan and establish containment lines employing indirect attack tactics. **Objectives for today:** Ground crews and heavy equipment will continue to construct containment lines and improve access into the fire.

Evacuations: The closest structures are five kilometres to the Southwest. Alerts and/or Orders are not being recommended at this time

Other: Currently timber is the primary value threatened. There are large volumes of unburned fuel within the containment lines which will continue to produce significant smoke as it burns towards the fire guards. Expect an increase in wind speed and gusting due to a passing cold front moving from west to the east, away from the closest structures. Expect a decrease in visibility after the cold front passes due to lower wind speeds and possible inversions which could hold the smoke in the area.

Dear Raj, I have been a supporter of yours for years. I have volunteered with your campaigns in the past on the phones and door knocking.

Early winter my friend on Vancouver Island told us about the 9th largest Douglas fir in BC, estimated to be 800 years old, in the Nahmint Valley near Port Alberni so my husband and I finally went to explore. I was shocked to find out that it has been cut down AND the logging of this precious giant was done by our own BC Timber Sales!

Mike Stini, a Port Alberni conservationist, said he spoke with the mill owner responsible for the cut block and was told the contractor was specifically told not to fall this giant.

The Nanaimo Bulletin has reported that trees several hundred years old, "larger than those in Cathedral Grove" are "still coming down in the face of the B.C. government's new 'big tree policy' established in January", and that regional staff of the Ministry of Forests, Lands and Natural Resource Operations said the Nahmint cut blocks were laid out five years ago!

Raj, why are we allowing BCTS to auction off 300 hectares of our remaining ancient forest!? I am devastated this tree and others like it was cut down before I could take our future grandchildren to see it and be awed and humbled by nature.

PLEASE work see that our NDP government:

- orders BC Timber Sales to stop issuing old-growth cutblocks and to immediately implement a policy to protect the largest trees (with buffer zones) and grandest groves
- implements a science-based old-growth protection act
- supports First Nations sustainable economic development linked to their land use plans and old-growth protection/Tribal Parks/Indigenous Protected and Conserved Areas
- ensures a sustainable, value-added second-growth forest industry.

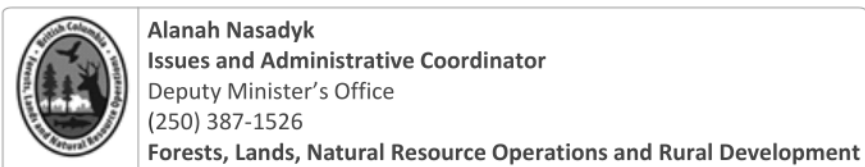

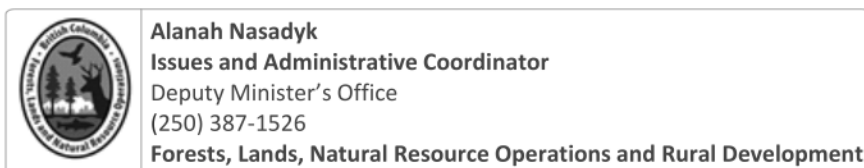

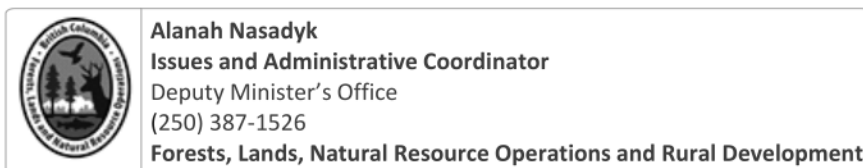
