My name is s.22 .s.22

s.22 I grew up picking pine mushrooms and riding horses in the bush. Now we have a family of our own here in Telegraph Creek, and we are trying to put our life back together after last year's fire.

s.22 We were affected greatly by the 2018 Alkali Lake Fire- it started approx s.22 and came straight for us. s.22

and it all burnt.

Right now, we have two major problems we are facing, the first one is our water situation- we get our water from a creek, which comes out of the mountain beside our property, but because all of the trees burnt, the creek is drying up. We need water for our home, for our business,

s.22, and to fight any future fires. We got a quote to get a well drilled, and the cost will be close to \$20,000 when all said and done.

Our second major problem, is the land cleanup. As I type this email, it is still burning underground on our property in spots. There is hardly any snow to speak of, so come spring time, there will be a re-burn. We have a TD15 Dozer, and there is only so much cleanup we can do with that, so we are needing to purchase an excavator, which will be in the \$60,000 range.

We lost a lot of smaller items(our haying equipment, snowmobile, Argo, truck canopy, etc), but obviously those items we will replace over time, as they are not that important in order to function right now.

WE haven't received any help, other than a small amount from Red Cross, for alternative heating(because we use Wood Heat), and a small amount from Horse Council BC, because we have horses(they had to get evacuated), and their fencing was destroyed when the fire came through, and fireguards were put in.

We live off the reserve, we have not seen any donation money. We have not received any help whatsoever, we have been on our own, and we are frustrated. The Tahltan Band has received much financial assistance/donations(and they are still receiving, according to the news), and we have not received anything other than what Red Cross, and Horse Council BC has given us, which is not very much at all, it is almost a joke.

Everyone in town was given firewood for the winter that was donated(18 logging truck loads were donated by Red Chris, to the Band). No one has to worry about their water drying up in town and no one has to worry about a re-burn in town, because everything got cleaned up and hauled away, and property's were landscaped.

We have contacted as many organizations and programs that we know about, with only (2) being able to help us- the others have told us we don't qualify.

It is very frustrating when we keep getting told that we can't be helped, and we are feeling very defeated these days. Just being outside, or looking out the window at this mess, is overwhelming some days.

Minister:

In terms of government policy that might be considered by an SDM when making decisions wrt salmon habitat here is what we have:

- On October 10th, Premier Horgan and Governor Inslee signed a Memorandum of Understanding on Advancing the Innovation Economy, Environmental Protection and Transportation Connectivity, where signatories committed to “work together, with Indigenous peoples, and with the Canadian and U.S. federal governments, to protect our iconic and endangered Southern Resident Killer Whales,” as well as “work with partners to restore and sustain the salmon population.”
- BC participates on a series of SRWK Technical Working Groups convened by the Federal government. The purpose is “To convene together policy, technical and scientific experts from the federal government, Indigenous Peoples/First Nations, environmental groups, industry and other areas to propose and advise on specific actions that deliver on the commitments made by the federal government to address imminent threats to the SRKW and facilitate their recovery.” Specific to habitat restoration the WG will “Contribute to identifying measures to rebuild wild Chinook stocks, prioritizing those of greatest importance to SRKW, in line with the objectives of Canada’s Wild Salmon Policy”
- The B.C. Cross Ministry Southern Resident KW Task Force is

composed of provincial ministries to “...ensure a coordinated provincial approach to engage and collaborate with external government partners (which could include: Government of Canada, State of Washington, U.S. Federal Government, Indigenous nations, First Nations, Tribal nations and local communities) to address the recovery of the SRKW.”

Requesting an interview about the 2019 provincial budget increase for fighting wildfires. (increase from \$64 million to \$101 million)

What will the funding be used for?

Even with the increase, that still doesn't seem like a lot given recent wildfire seasons. Why wasn't more budgeted

- As part of Budget 2019, the fire management vote has increased by 58%.
- Wildfire costs can be unpredictable, and historic fire costs have ranged from \$53.5 million in 2011 to \$649.5 million 2017.
- Regardless of the initial budget, the BC Wildfire Service has statutory authority to spend what is necessary on fire suppression. Public safety is our top priority.
- it's also important to note that in the case of a below average fire season, like 2011, money allocated to direct fire could be stranded and not used for other government priorities.
- There are several layers of prudence built into the budget, including contingencies and the forecast allowance, which allows government to manage

the cost of events, such as wildfires, that are challenging to budget for.

- The increase in base funding will also enhance the BC Wildfire Service's response capacity, for example, by hiring more crews.
- (if pressed) We'll be in position to provide more information on how we're preparing for the 2019 wildfire season within the next few weeks.
- In addition, we're committing \$60 million to the Community Resiliency Investment Program this year (2018/19). This funding assists local government and First Nations reduce wildfire risk around their communities.
- We've also increased funding under the Forest Carbon Initiative by \$13 million over the next three years. This will enable us to take advantage of matching funding from the federal government. Funds are used on reforestation and restoration initiatives, that not only capture carbon, but also reduce wildfire risk. This is in addition to the \$235 million Forest Enhancement Society funding.
