Core Examiner Application Process

The CORE Program is British Columbia's Hunter Safety Program as authorized by the *Wildlife Act* and the Hunter Safety Training Regulation, BC Reg. 53/98. Effective March 1, 1998, under the authority of BC Reg. 53/98, the British Columbia Wildlife Federation was appointed as the Designated Agency to operate the CORE Program.

As part of our ongoing commitment to have hunters meet acceptable standards of knowledge and skill for their safe and ethical participation in hunting recreation, we strive to ensure that every examiner has a high level of hunting, firearms and outdoor recreation knowledge, is skilled as an instructor, and has a high personal level of integrity and commitment.

To become a CORE Examiner, the applicant must:

- Be a BC Resident (as defined in the Wildlife Act)
- Hold a valid BC Resident Hunter Number and have a minimum of 5 years of hunting and firearms experience
- Hold a valid Possession Acquisition License (PAL)
- Have no convictions of a serious nature of a criminal act or infraction of the Wildlife Act, Fisheries Act (Canada), Migratory Birds Convention Act or Criminal Code of Canada within the last 10 years or a minor infraction with the last 5 years. Convictions include violation tickets.
- Have experience and/or training in teaching or group facilitation
- Consent to a Criminal Record Review for working with children or vulnerable adults at the applicant's expense (\$28 for new review; no cost to share an existing employment related review)

The responsibilities associated with the position of a CORE Examiner are:

- The cost of your training and certification as a CORE examiner
- The cost of obtaining a kit of disabled firearms for instructional and testing purposes
- Organizing, advertising and delivering individual courses
- Maintaining a full record of courses delivered
- Delivering a minimum number of one examination per year, depending on demand in your area.
- Ensuring that instructors brought in to instruct some or all of the course material has the appropriate knowledge and skill as an instructor.
- Although it is not a mandatory requirement, it is recommended that Examiners have (or have access to) a laptop and power point projector for instructional purposes.
- As well, it is preferable for Examiners to have email in order to receive newsletters and memos, and to be able to order supplies online.

Individuals interested in applying must complete and return the attached CORE Examiner application.

A number of factors will be taken into consideration in making our decision whether or not to certify the applicant as a CORE Examiner, including individual qualifications and the need for instructors in that area. Please note that it may take up to a year to be certified, from the time of receipt of the application.

The BCWF may or may not select you to proceed further in this process based on your application, background, geography, or operational needs. If during the training process, we see that you are not qualified or personally suitable to become a CORE Examiner, we reserve the right to cancel your training at any time.

If the initial application is approved, the applicant would then be required to be trained by a CORE Examiner Facilitator and attend a 2 day training course. The Facilitator will provide instruction regarding how to teach the course and how to administer the exams. The applicant will be given a written exam and must obtain 90% or greater to pass, in addition to creating a course plan and doing a class presentation. The Facilitator will review the paperwork with the applicant and in some cases may audit them teaching a course or class segment to actual students. Once this is completed, the Facilitator will submit the results of the training to BCWF. The applicant will be required to sign a letter of agreement, in which they commit to complying with the CORE Program Standards and consent to a Provincial Criminal Record Check. Once BCWF has received the signed agreement, the applicant will then be sent a CORE Examiner number and a package of supplies to get started.

In response to your recent inquiry regarding a letter of complaint received by the ministry.

How we direct someone to a core examiner.

When we receive a request from a customer on how to find a Core Examiner, we will direct them to our website where we have a complete listing of all qualified examiners and usually to help them further, we will ask where they are located so we can direct them to an instructor/s in their immediate area.

On \$.22 we did have an issue in our Surrey office where by we had removed our brochure rack with all the Core Examiner brochures on it that we receive and display, to put up a Christmas tree. A man came in \$.22 and asked where he could take his core program. Our receptionist at the time asked where the gentlemen was located and when he said the lower mainland, she grabbed a brochure she had sitting on her desk which happened to be for Silvercore. The same time this gentleman was in our offices \$.22 was in the office and flew into a rage. (please see attached documentation of the event as provided to our Director of Corporate Operations)

Core Instructors and Core Examiners

The way the Core program is set up presently is that anyone can teach the Core Program. School teachers, Hunter Education Online, etc.

Only a Core Examiner can give the exam to pass or fail a student.

Only a Master Core Examiner can train new Core Examiners.

Verifying the 5-year hunting experience

When someone wants to become a Core Examiner, they must apply. On this application one of the requirements is

 Hold a valid BC Resident Hunter Number and have a minimum of 5 years of hunting and firearms experience.

They must complete the application and sign off on the application saying all information is true. By signing the application, they give permission to the BCWF to conduct background enquiries and authorize the BC Government to disclose to the BCWF details of any charges and or offences laid against the person.

The second key process is

 The applicant must supply 3 references – a subpoint for the reference checker is printed on the form and states – We need to confirm they are a hunter – the reference should be able to attest to their hunting experience: 5 years practical hunting experience is required: and are they current? I.e. last time hunted Finally, to avoid family members as references it is printed on the application that the applicant will provide names addresses and telephone numbers of three non-family member references. One of the three references should be a CO, police officer, Core Examiner or Rod and Gun club Executive.

I would suggest that we (the BCWF) could do random checks with your department to verify BC Hunting History as another check point.

my relationship is professional. Silvercore is located in Ladner BC

I will say that of all our Core Examiners, Silvercore is the largest and is a strong member in the BCWF. Silvercore is an Affinity Partner and pay a fee for that standing. Thru my position I have learned that Silvercore is actually a leader in Training both Core and CFSC. Their client list boasts of the VPD, Justice Institute, RCMP and many others. I have talked to Silvercore about how we might standardize new Core Examiner Training classes, so every new instructor goes thru the same in-depth program.

Presently in my tenure we have hosted 3 Core Examiners Courses and all those courses were led by Master Core Examiner and S.22 is also a subcontractor for Silvercore.

I do in fact own a Silvercore mug, along with an IHEA mug, and many others (the bounty collected at various trade shows)

In the past Silvercore has provided Core and CFSC courses at no cost to the Federation for employee's only. S.22 from BC Outdoor Education has done the same for the Federation, as has Hunter Education On line. I see this as a benefit to our employees and a way for the BCWF to audit the teaching of the hosting company

Silvercore is a major sponsor of the 2019 AGM. They paid 5000.00 towards a co-sponsor with Capri Insurance (another affinity partner) to sponsor out AGM Gala Dinner.

I offered this sponsorship to other Core Examiners (who have a bigger customer base) like Safeshooter Academy S.22 who replied back via email (attached) and S.22 from BC Firearms Academy who became a coffee break sponsor for 1000.00

Most recently Silvercore and Cabela's had a meeting (the BCWF was not involved) and came to a deal that Silvercore would provide 4 weekend training sessions throughout 2019, hosted by Cabela's for Core and CFSC. It was also decided that all proceeds from these training sessions would be donated to the BCWF. Again the Federation was not involved in any way.

Shortly after this was announced at Cabela's I received this email

I hope your'e having a great day! I was hoping you could clear something up that has caused some confusion for us.

We became aware today from 2 other CORE providers that Silvercore Training is promoting a BCWF program that no other CORE examiner has been made aware of at a location that a we provide courses in.
