1.- Is the visit being rescheduled? If not what measures are being taken by your ministry to make the case for B.C. in China?

- As you may be aware the Minister of Forests traditionally leads a forest sector trade mission to Asia each fall to help expand the markets in Asian countries for B.C. wood products. Planning for these missions usually begins in the summer.
- B.C. values its relationship with China, our second-largest trading partner.
- Ministry staff in B.C. and in our four trade and investment representative offices in China continue to support trade and investment activities between B.C. and China.

3.-Why, exactly, did the minister decide not to proceed into China? Was there a security concern? We have the results of an FOI request that sheds a great deal of light on this situation, but were interested in your explanation of this?

Based on the information available at the time, the Minister made the decision not to proceed
to China. He didn't want his presence as a government minister to distract from the business
