- Incidents such as that of the raccoon found in the leg-hold trap in Delta are very unfortunate.
 - Whether a municipality has authority to make trapping related bylaws will depend what trapping issue the bylaw is addressing.
 - With respect to the legality of leg-hold traps in an urban environment, if they are least 200 metres from a residence, they can be used to control nuisance.
- General trapping guidelines are as follows:
- During regular trapping seasons, individual permits are not required beyond the usual trapping licence.
 - However, the municipality/landowner needs to give their permission. The ministry suggests contacting the municipality in question if trapping occurred inside their municipal limits.
 - It is unlawful to use a leghold trap which has teeth or other projections on the jaws of the trap.
 - A holder of a licence, permit or other authorization to trap commits an offence unless that person examines the holding or non-killing traps he or she has set on a trapline at least once every 72 hours, the egg trap(s) he or she has set for raccoons at least once every 24 hours, and killing traps or killing snares that he or she has set on the trapline at least once every 14 days.
 - A holder of a licence, permit or other authorization to trap on private property commits an offence unless that person examines the holding or non-killing traps he or she has set on private property at least once every 24 hours.
 - It is an offence to trap a furbearing animal, and if the animal is alive when the trap is checked, fail to immediately release or kill the animal.

Dear Ministers George Heyman and Doug Donaldson,

We are counsel for the Wilderness Committee. We are emailing to let you know that tomorrow, **Wednesday, May 8, 2019**, we will be sending a petition on behalf of the Wilderness Committee to the Hon. Catherine McKenna, Minister of Environment and Climate Change, demanding that she immediately initiate a process for identifying and protecting the Spotted Owl's critical habitat in BC through a *Species at Risk Act*-compliant action plan.

The petition will be accompanied by several documents, including an expert report that details BC's historic and continuing failure to identify – let alone protect – habitat necessary for the Spotted Owl's survival and recovery.

Ecojustice and Wilderness Committee will also be issuing a press release.

Can you confirm they have reached out to the Ministry of Forests?

Yes FLNRO staff have met a number of times with representatives of Arterran Renewables to discuss fibre opportunities and to outline how access to fibre is governed in BC by tenures.

Answer - The ministry recently introduced a Fibre Recovery Zone for Vancouver Island. The Fibre Recovery Zone is part of the Coast Revitalization process we introduced and it is designed to improve utilization and access to residuals from harvest. The FRZ's will help reduce the level slash pile burning and at the same time provide needed fibre for use in manufacturing a range of products such as pulp and paper, pellets and bio-fuels.

And Doug what do you think of the idea?

Answer – Our CleanBC framework establishes a path that will see BC use more clean and renewable energy in how we get around, heat our homes, and fuel our industry — setting us on the path to a cleaner, brighter future. Arterran Renewables technology appears to be in-line with achieving those objectives. I am not in a position nor is my staff in a position to evaluate the specific technology being employed by Arterran Renewables. My role and so is my staff's is to ensure sound forest management and through recent policy changes increase utilization of BC's timber resource to support economic development and jobs for rural communities.

Billions in money laundering increased B.C. housing prices, expert panel finds

- As public warnings on money laundering in real estate and casinos mounted over a period of years, the BC Liberals refused to take action. Our government is launching investigations, closing tax loopholes, and enforcing new laws to fight dirty money.
- A [report](#) released by government’s Expert Panel on Money Laundering in Real Estate estimates that more than \$7 billion in dirty money was laundered in B.C. in 2018, increasing the cost of buying a home by 5%.
- The BC Liberal refusal to act on dirty money [has cost BC families billions](#). With the composite price for homes in Metro Vancouver at just over \$1 million, 5% is an average of \$50,000 for every home purchase.

Province responds to housing task force with steps to protect renters, landlords

Planting:

I was not able to separate out the planting that has occurred in Esketemc territory only. In the district (which is their territory), in 2018; 300,000 seedlings were planted in the Cariboo-Chilcotin burnt areas. In 2019; of the 4.3 million trees to be planted 4.1 million will be in burnt areas. So far this season, there has been 0.5 million planted.

Regarding cutblock reforestation, Licensees are held to standard free-to-grow requirements, per their FSP. I recommend asking what the Chief specifically thinks or dislikes about that, and whether or not they've had input to FSP development.

Prescribed fire:

There are 5 approved burn plans. One more in progress for an understory burn in dry belt fir. This is important work to continue, there will be a lot more future work to reduce fuel loading. Thus, we appreciate Esk'etemc's engagement in this.

1 burn was completed this year (15ha): Hay meadow burn, eradicating spruce and willow. This is significant to the Esk'etemc community, they value getting this meadow back in production, to sustain their cattle. The burn was highly successful with only 2 FLNRORD staff. The rest were Esk'etemc crews.

Due to fine fuel deficient sites, no other burns occurred in Esk'etemc territory (due to early season grazing) this spring.

FLNRORD is working with 3 members of Esk'etemc, training to be burn bosses. Certification and qualification will allow them to develop plans, prepare and operationally carry out prescribed fire.

Additional info:

- Paul Rasmussen (with staff – District Manager, Regional Exec Director and Exec Assistant) spent a day with the Esk'etemc's Chief Fred Robbins, on the Alkali Reserve, on April 29. The Chief was very gracious and showed us many of the things he and his community is working on. Many infrastructure improvements for his members, and great participation / engagement in the forest sector. This is a very forest dependant community.
- Esk'etemc has been one of the most progressive communities involved in the TSA Silviculture committee and has contributed to improvements in silviculture practices and stocking standards with the district and other licensees. The ministry values and appreciates the involvement of community members with traditional knowledge to add to our projects.
- Forest Enhancement Society Projects: Esk'etemc has been very pro-active with FES projects and has actively engaged with district staff, regional habitat staff and the fire centre staff to

develop and implement a number of FES projects for wildfire hazard mitigation, stand improvement. Of special note is a project that was in Mule Deer Winter Range (MDWR) that helped develop prescriptions for treatments that have informed other habitat enhancement projects.

- FLNRORD provided temporary emergency access to MoTI to use gravel from our FLNRORD Gravel Reserve on the Chimney Lake FSR (AKA Enterprise road) to repair an impassable section of the Dog Creek Public Road frequented by both Esketemc and Canoe Creek Band members.
- Through the Tolko-Esk'etemc discussions of land base resilience, we are developing a more focussed and meaningful approach to protection of communities and restoration of ecosystem resilience.

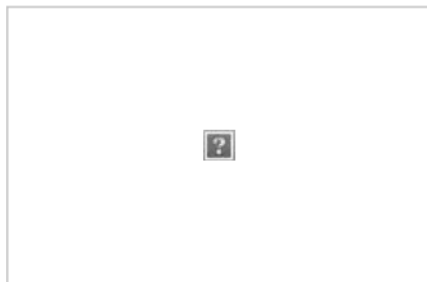
