Fugitive Emissions

Taxation of fugitive emissions under the *Carbon Tax Act* would face administrative difficulties. The carbon tax is collected by fuel suppliers at the top of the supply chain (the same as other fuel taxes); as such, applying the carbon tax to fugitive emissions would require the development of entirely new mechanisms for applying the carbon tax to emitters. In addition, expanding the scope of the carbon tax may impact the industry's competitiveness and jobs, as it would increase costs to industry.

Fugitive emissions reductions are achievable through other non-tax approaches.

The Oil and Gas Commission, with the support of the Ministry of the Environment and Climate Change Strategy and the Ministry of Energy, Mines & Petroleum Resources, has introduced regulations under the *Oil and Gas Activities Act* to reduce fugitive emissions. The regulations apply to the primary sources of methane emissions, which include pneumatic device, equipment leaks, compressor seals, glycol dehydrators, storage tanks surface casing vents. Implementing the proposed regulations will achieve the commitment to reduce methane emissions by 45 per cent by 2025 relative to 2014 levels.

The Government of Canada has set a reduction target of 40-45 per cent by 2025, relative to 2012 levels passed regulations to reduce methane in the upstream. B.C. is in the process of seeking equivalency on the methane regulations, which will result in the federal regulations being stood down for B.C.

Consultation on these regulations occurred in 2018 with informed stakeholders, including industry and environmental NGOs.

These regulations are consistent with the *Budget 2017 Update* commitment to consider implementation of "complementary carbon pricing measures to address emissions not currently

covered by the carbon tax, in particular fugitive emissions and emissions from slash pile burning”.

Slash Pile Burning

ENV and the Ministry of Forests, Lands, Natural Resources Operations and Rural Development (FLNR) are assessing the technical challenges related to calculating carbon emissions from slash piles and the impacts of this approach on different aspects of the forest sector.

Early analysis suggests that expanding the carbon tax to slash burning would be administratively complicated (i.e., similarly requiring new mechanisms for applying the carbon tax to burning piles of wood in the bush) and could negatively impact the industry’s competitiveness and jobs. Also, there is no data on where slash piles are located, when they are burned and what the resulting GHG emissions are, though ENV is analysing these issues.

Instead, ENV and FLNR emphasize that Government has taken action to reduce slash piles and diverting this wood fibre to other uses. For example, in February 2019, Government provided \$10 million via the Forest Enhancement Society to redirect wood waste to mills instead of leaving it to be burned.

Here are some bullets for your review/edit.

Background:

- There is a critical shortage of pressure treated wood fence posts across Western Canada as a result of the high demand for materials to rebuild from the last 5 years of wildfires.
- For the 2019 fence reconstruction season on Crown Range in BC, the BCCA is rebuilding 310km of fences.
 - Need 62,000 4-5" 7' posts and 4960 5-6" 8' brace posts. (Does not include the fence materials needed to rebuild on FN lands and private lands).
- Wood Pressure treat process facilities in BC have a limited supply of green logs and will run out by June 2019.
- The supply of green logs has historically been purchased from the timber industry. That supply is no longer available because that portion of the tree is now going into Wood Fiber Bio-energy.
- The continued reconstruction of wildfire fences is critical to the Beef Cattle Industry in BC after the 2017 and 2018 Wildfires. The federal/provincial Wildfire Agri Recovery program is coming to an end in 2019 and these ranchers need to get back out on Crown and private grazing areas.

- We appreciate the report and agree with the findings. We are already taking steps to bring in a new natural resource enforcement delivery model. It will create clear accountabilities and responsibilities and better serve the public.
- Natural Resource Officers (NROs) will move away from patrol work and focus on inspections and investigations.
- Conservation Officers (COs) will take on responsibility for campfire ban patrols, recreation site and trail patrols, and Wildlife Act area closures.
- Previously, there was overlap and duplication in the roles and duties of NROs and COs.
- The shift to inspections and investigations will allow NROs to focus on holding major licensees accountable.
- Through their partnership the two agencies will ensure a higher level of compliance and public assurance.

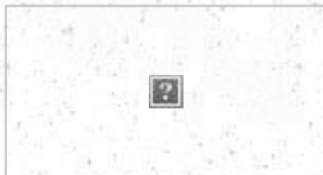
