



Subject: We can't kill the way out of wildlife conflict

Dear Ministers Donaldson and Heyman, and Chief Forsdick,

It is time to acknowledge the current manner of managing human conflict with black bears is failing. Killing bears because they are attracted to available food sources is unscientific and unethical, and what's more, doesn't address the actual problem.

While I appreciate the Conservation Officer Service must consider human safety, it must also act as a law enforcement agency: how is it possible that officers so routinely kill bears but aren't issuing hefty fines every time? As an armed law enforcement agency, I am also shocked to learn there is no third-party oversight of officers' actions, unlike virtually every other frontline emergency responder or armed law enforcement agency.

A simple look at the comments on media websites show that the current model is not just failing to prevent ongoing conflict, but is eroding public trust in a vital public agency. There are repeated comments of people saying they refuse to call the RAPP line in fear of officers killing wildlife, and even people not willing to call and report neighbours because they have to provide their contact information to municipal by-law or provincial agents.

There is no argument from anyone involved in wildlife conflict that attractants are the core problem, but the COS is not addressing it as such; they are responding and reacting to complaints and lethal control is, in the eyes of the public, too commonplace. I do not wish to receive a message that "we do not like killing" – I wish to receive your response to the three action items below that I expect you to take:

- 1. That conservation officers be directed to show preventative measures, fines, and other educational tools are utilized prior to lethal measures and that third-party oversight be put into place to review and advise the actions of armed law enforcement agents.
- 2. That funding be made available to any municipality to increase by-law enforcement activities, specifically related to wildlife feeding and attractants.
- 3. That both the RAPP line and by-law enforcement departments begin accepting anonymous information regarding by-law or provincial infractions that put wildlife and people at risk.

I look forward to your comments as to how you will resolve this ongoing issue – particularly as there are simple solutions, as outlined above.

Doug Donaldson, minister of Forests, Lands, Natural Resource Operations and Rural Development issued the following statement on the news of the closure of the sawmill in Vavenby about Canfor's closure of its Vavenby sawmill and the request to transfer tenures to Interfor:

"I was saddened to hear today's news that Canfor will be permanently closing Vavenby sawmill.

"The loss of any job is difficult, especially in a small community. My thoughts are with the workers and their families at this time.

Staff from the regional economic development branch of my ministry and staff from the ministry of Social Development will work with Canfor, the workers and the community to coordinate the delivery of provincial support programs. We will also work with the federal government to ensure supports are made available to impacted workers.

"With the passage of Bill 22, we will also ensure that the public interest is protected when companies seek to transfer public Forest tenures."

"With the recently passed amendments to the Forest Act (Bill 22), we will also ensure that the public interest is protected in considering the request to transfer public forest tenures from Canfor to Interfor."

The challenges facing the industry have been building for years and analysts have been predicting the reduction in milling capacity for some time, especially in the Interior. Declining timber supply – the result of the end of the pine beetle-killed wood, exacerbated by record-setting fire seasons the past two years – has left the industry scrambling to keep log yards full and keep people working. Weakened lumber markets and the ongoing softwood lumber dispute have contributed to this challenge.

Our government has been working to set a sustainable course for the forest industry in all regions of the province. Last year we launched the coast sector revitalization initiative, which led to policy and regulatory changes aimed at getting the best value and most jobs out of the fibre basket on the coast. And this spring the premier invited Interior forest sector CEOs to work with collaboratively with all their partners – First Nations, workers and local governments – on innovative solutions for the industry.

Our government believes in rural communities and we believe strongly in the resource sectors. The forest industry supports 140 communities across the province and, despite this recent bad news, I know that working collaboratively, British Columbians will find innovative solutions to ensure a competitive, high-value forest industry that creates jobs and produces economic stability and

benefits for First Nations and communities across the province."
