Hello Ravi,

Congratulations on your appointment as Parliamentary Secretary for Forests, Lands, Natural Resource Operations, and Rural Development.

I am writing to offer my assistance if that would be helpful to you. I started my career as a wildlife biologist in central BC in the 1970's focused on caribou. I remain actively involved in the effort to craft a caribou recovery strategy.

This government inherited a dreadful situation due to neglect by past governments but there is a growing risk of owning some of the blame. Consultations have not been handled well and a case has not been made that it's not jobs v caribou but rather decades of poor forest management put both at risk.

Therefore, it's not just about caribou. Unless we adopt a more sustainable resource management strategy caribou and bio-diversity will continue to decline across BC, indigenous rights will be further undermined and our fresh water supplies and climate strategy damaged and resource communities will continue to decline as resources are exhausted for short-term gain. I have some ideas about how to imbed the pending conservation agreements within a sustainable forest management plan offering long-term social, economic and environmental benefits.

The attached letters are but a few in ongoing communication with Ministers Heyman and Donaldson. I look forward to your reply. Best of luck
