Subject: A/T Strategy - Update, Reply Requested

Hello to all of the A/T Strategy partners.

Dave and I thought we would provide you with a bit of an update. We have been busy between a very busy ski season and fleshing out the details of our next steps. As always, we are both available if you have any questions or suggestions. As you know, seven of us (*Craig Campbell, Walt Judas, Scott Benton, Ian Tomm*,

Henry Tso, Dave Butler and I) met with six provincial ministers and staff in January to present the adventure tourism strategy that we built together. Ministers Bond, Thomson and Yamamoto were there in person, while Ministers Bennett, Rustad and Barnett connected by phone.

We were pleased that Minister Shirley Bond profiled our A/T strategy in her keynote speech at the Tourism Industry Conference in February (I know that some of you were there). She complimented the A/T coalition on developing the strategy, discussed helping move this forward and assigned an Associate Deputy Minister to work with us to move the A/T strategy forward. Minister Bond and most of the other ministers mentioned how impressed they were with our industry coming together as a unified voice. This cohesion is at the backbone of the attention gov't is paying us. The gov't has responded positively to our proposed A/T Strategy and have already answered some of our requests. Although gov't was very impressed with the diversity of our coalition, they have asked us to reach out to other groups (i.e. public rec, other users of the land base, etc.) in order to build even stronger support for moving ahead. We are in the midst of finalizing the outreach/engagement list now, along with developing strategies and tactics and messaging for that engagement. We have asked Scott Benton to serve as our point person on this initiative. On our collective behalf, he's going to take on the following tasks. Dave and/or I will continue to oversee the project, and continue to serve as the conduit to gov't.

- 1. Identify key organizations and primary contacts for our engagement.
- 2. Identify and work with our team to develop messaging, tactical approaches, key interests and common ground.
- Schedule and attend meetings with key reps from this A/T coalition (those who
  have the best relationships with each of the groups) to forward our messaging,
  understand their interests and concerns, attempt to reach common ground
  wherever possible, and build support for our initiative.
- 4. Report back to the A/T strategy group on the following:
  - Nature of conversations
  - Areas of concern expressed by groups
  - Areas of agreement/disagreement
  - Decisions we might need to make as a group based on that
  - o Identify positive supporters while being cognizant of negative responses and how to address them

We will need to compensate Scott for his time and any incurred expenses. To that end, we have put together a budget in support of these next steps. We need to raise around \$10,000.00 in order to fully and effectively see this process through. We are asking that all of the participating sectors provide funding in the amount that they are able. We need at least \$750.00/sector in order to reach our budgeted target. Please get back to me as soon as possible and let me know the amount that you are able to contribute. We will then let you know how to transfer your contribution to the coalition.

Timing and messaging are critical as we attempt to broaden our base of support for the A/T strategy. We ask that coalition members remain quiet about meeting with government and the strategy content. If you are questioned about this, your answer could be: "our adventure tourism collective of 18 organizations has developed a growth strategy for adventure tourism, and we will be consulting with key organizations about how to move that strategy forward."

Thanks for your attention, and we look forward to hearing from you as soon as possible.



It's really not that much, riders need to donate more!!

But we have not really done any promotion outside the links to donate on the Trailforks website and app.

Except for the promotion this summer in Sea 2 Sky with Whistler Brewing, \$1 from each 4-pack went to Trail Karma. There is talk about doing this again next summer with a much larger release.

We can do more on Trailforks to remind the user, which I will probably do this winter. Send out an email or site-message reminding them to donate and list the places they rode the most.

We also have push notification support in the Trailforks app now, which we have not really used except for a Red Bull Contest. Its mostly only Android users currently, as iPhone requires the user to give permission and we haven't been actively asking for it yet. But we could push some occasional Karma suggestions to users phones in future.

I have hoped we would do a big contest on Pinkbike to really promote Trail Karma, but its never been followed through. A bunch of false starts. PB guys were trying to go too big, with getting major brands backing it. I think just a normal kind of contest with a bunch of prizes like the Share the Ride promotion would be great. I just don't have the time personally to pursue it, so much on my development plate.

We have a new feature that would help with a BC localized contest promotion though. A contest gets promoted on homepage of TF website and the contests section of the app. And we can show a 1 time popup in the app for a contest, and this can be geo-targetted.



## **Mountain Biking and Public Land**

Dear Martin,

As part of the Western Spirit family, we know that public lands are what make mountain biking possible! From our city, county, and state parks to our Bureau of Land Management Lands and National Forests— public land is where the trails are!

Yet these lands are under increasing pressures from a wide variety of sources. Many trails have almost no protections and could be mined or drilled at any time, while many other places are simply being loved to death by too many visitors.

To help solve these problems, I partnered with Jason Keith, former attorney for the Access Fund (the climbing and mountaineering equivalent to the International Mountain Bicycling Association) to create a non-profit called Public Land Solutions. We are working to spread the word about how well managed public lands can be kept in their natural state, while simultaneously bringing economic development to rural communities that need a boost. Inspired by all the great places Western Spirit goes, we are using techniques that have worked in established recreation economies to help communities that are just getting started.

We have learned that cities and towns who were previously entirely dependent on resource extraction, like coal or oil and gas, can work with their local and federal land managers to invest in recreation assets of all types, from trails, to river access, to cliffs and canyons to attract not just visitors, but quality of life companies who can locate wherever they choose. And more and more they are choosing places where their employees can get outside.

Much of our current work at Public Land Solutions is covered by a variety of grants, but as we look forward to 2019, we are receiving more requests from communities than our staff can handle. These are places where folks are thinking hard about how to diversify their economies, but they need support to create a plan. You can learn more about our work at <u>publiclandsolutions.org</u> —and if you find this work as inspirational as we do, we would welcome a <u>donation</u>. We hope to grow our staff in 2019 to bring well designed policies to our public land and keep those trails coming!





Hello ORC representatives and supporters,

We have started to receive nominations for the four available outdoor recreation seats on the <u>Provincial Trails Advisory Body</u> (PTAB) and I just wanted to remind you to **get your nominations in before the end of September** if your organization would like to be present at this table. ORC's appointed representatives represent the broad outdoor recreation interests and this is a fantastic opportunity to work with other members of the outdoor recreation community and

government on helping to create a world class trail system for BC. Please see more info about the nomination process in my previous email below.

On behalf of ORC, I would like to thank 'expiring' PTAB members Orville Smith (Horse Council BC), Nick Heath (BC Marine Trails Network) and Bob Holland (Quad Rivers ATV Association of BC) for giving very generously of their time and knowledge to the PTAB since we got started in 2015. As all of ORC's seats have a 2 or 3 year term limit, the term is now up for these three seats (the same organizations are welcome to nominate new representatives).

Let me tell you a bit more about what's happening with the PTAB at the moment. The creation of the PTAB was a key action outlined in the 2015 <u>Provincial Trails Strategy</u> and it has turned an exciting new corner as we recently started a review of the current strategy in an effort to update and strengthen the strategy. The overall objective is to complete a detailed review of all aspects of the Trails Strategy and to make recommendations to the PTAB on improvements to the trails strategy. MNP LLP has been appointed by the Ministry of Ministry of Forests, Lands & Natural Resource Operations (FLNRO) to lead the review. While the contract with MNP and the management of its consultants rests with FLNRO, the PTAB as a whole oversees the project and will use the final report to make a number of recommendations to government.

These are the rough phases and timelines for the review:

- Mid September: Review of proposed project plan and deliverables, goals and objectives (PTAB)
- Until end of November: Trails strategy review, info gathering and targeted consultation (consultant)

Hello ORC members,

If your organization would like to help influence how recreation and trail planning is carried out in BC, consider nominating a member of your organization to join the Provincial Trails Advisory Body (PTAB). Preference is given to those of ORC's member organizations who have a provincial scope. The deadline for submitting a nomination is **Monday, September 30.** 

The PTAB got underway in 2015 and its main aim is to advise the BC Government on trails planning and management and provide recommendations on the implementation of the <u>Provincial Trails Strategy</u>. Secondary aims are to provide a collaborative forum for trails organizations and other interests to ensure that the Trails Strategy continues to meet the needs of all trail users and to help to resolve provincial issues in trails management by providing input from a trail user and stakeholder perspective. The PTAB recently began to undertake a review of the trails strategy.

Learn more about the PTAB by reviewing the <u>website</u>, <u>terms of reference</u> and <u>backgrounder</u>.

The PTAB has a membership of 15 (recently increased from 13), including six representatives that are appointed by ORC to represent the broader outdoor recreation interests. ORC is the co-chair (executive director) along with Recreation Sites and Trails BC. ORC's representatives were initially appointed for a 2 or 3 year period in 2015. These are the current ORC representatives:

- Dave Wharton (Federation of Mountain Clubs of BC) joined July 2019 after replacing Andrew Drouin who stepped down (will remain on PTAB)
- Kim Reeves (4WDABC) joined in 2017 after replacing the BC Snowmobile Federation when they stepped down (will remain on PTAB)
- Nick Heath (BC Marine Trails Network) initial member
- Robert Holland (ATVBC) initial member
- Orville Smith (HCBC) initial member
- New member added

Other members include Tennessee Trent and Daniel Scott (Recreation Sites and Trails), Alan Callander (Ministry of Transportation), Brian Farquhar (BC Parks and Recreation Association), Kirby Villeneuve (BC Parks), Ministry of Tourism (new rep, not named yet), Scott Benton (Wilderness Tourism Association of BC), David Oliver (BC Wildlife Federation) and myself (co-chair with Tennessee Trent).

Out of ORC's six seats, four of these are up for election this fall. We want to seek a good balance between outdoor recreation interests (non-motorized, motorized, equestrian and mountain biking). As well as being a member in good standing of a <u>provincial group member</u> of ORC, each applicant for nomination is requested to meet the following criteria:

- Be interested in more than one trails-related activity and demonstrate an appreciation and understanding of the views of multiple user groups;
- Have a history of collaborating with groups having a variety of interests and working for the greater good of the trails community;
- Have an interest in public policy issues.

- The skills/experience that make you a strong candidate for the position;
- Your capacity to commit to a volunteer role and why you are interested in joining the PTAB;

All nominations will be reviewed by ORC's Board of Directors who will elect the four individuals. We expect to reach a decision in October.

It's great to see this! Hopefully it encourages other bike brands to do the same and hopefully they give priority to the applicants that can leverage it!

### Here are some abbreviated notes from the call this morning:

Intro: The purpose of the call is to determine what role the MBTA can or should play in the on-going discussion around sustainable funding for trails in the province, trail maintenance being the primary concern.

At the symposium it was suggested that mtbers consider a user registration and permitting model like fishing or ORVs to raise funds. Grant – at the recent WORCA retreat the idea of a user pay model was discussed – concerns about how this would impact those with less financial means – could reinforce elitism – creates barrier to entry.

Public is currently contributing to trails through donations and club memberships – is this money being leveraged as well as it could be? If we were able to compile the public's support for trails through their donations, memberships and volunteer labour, etc could there be a mechanism to have it matched by private sector and government.

Many clubs lack knowhow or capacity to solicit funding. Best practices need to be shared. Government seems to be ok with volunteer groups working on trails on crown and park land without any support from the province — can be viewed as a form of downloading? E.g. Vernon/Kal Park Smaller communities, like Revy, trying to find stable long-term funding — need to have active advocacy role.

Easier to ask government for funding if funds from the public and private sector already in place. How to proceed? What other conversations on this topic are happening in the province? It is better to be a united voice — we need to work together. Grant will reach out to AJ Strawson at IMBA Canada and Radek Burkat at Pinkbike. Maja Tait - mayor of Sooke, president of UBCM, and trail advocate (recently received sustainable funding for trails in Capital Regional District Parks) — it would be good to get her involved and also get trails onto the UBCM agenda in 2020.

Let me know if I missed any key points that were brought up.

**Subject:** New DBC Corporate Strategy - Feb 20 meeting notes

Hello MBTA directors,

I wanted to share a few notes from the DBC meeting that I was invited to yesterday to preview DBC's new corporate strategy.

DBC will be launching their new corporate strategy at the Tourism Industry Conference in a couple of

weeks. This meeting was a preview to gather feedback from the sectors (skiing, golfing, sport fishing, Indigenous tourism and mountain biking) plus several DBC senior staff were also there. The goals of the strategy are:

- Maintain 6% annual growth for the tourism industry in BC This will be difficult if the Corona virus situation continues and barring no other major catastrophic events. Currently the tourism industry is at 4.5 for the current fiscal which was tracking higher until the outbreak occurred.
- Encourage Seasonal and Geographic Dispersion product development for shoulder and low seasons and more touring routes to promote travel to all regions of the province.

They plan is to develop iconic itineraries to drive dispersion that will be based on new place branding for at least 6 travel corridors in the province. We were asked not to disclose too much info about this before the official launch at TIC. I think it is a fairly sound strategy and they have done considerable research however I also believe our market is very much passion based and the new strategy will probably have a greater impact on leisure travelers mainly.

We had a very open discussion. Marsha Walden/CEO said that Tourism is not being given the credit it deserves and encouraged everyone to support greater lobbying efforts. She also believes that the current government is more pro-tourism than previous ones and that we have a good opportunity to make positive changes for the industry if we can build a strong voice. TIABC of course is the voice of the industry. There are over 12,000 tourism businesses in the province, but less than a quarter are members of TIABC (MBTA is a member).

Apparently government is starting to listen and would like tourism stakeholders to identify policies or regulations that may be impeding growth of the tourism industry. If any MBTA directors have any thoughts on this that pertain to specific policies or regulations, please let me know. I would be happy to compile a list to share with Marsha Walden at DBC and Walt Judas at TIABC.
