# GUIDANCE DOCUMENT FOR ADDRESSING THE COSTS OF EXTRA COVID-19 SAFETY RELATED REQUIREMENTS ASSOCIATED WITH TREE PLANTING

#### 1.0 Introduction

#### 1.1 Tree Planting during the Covid-19 Pandemic

Tree planting typically occurs in remote areas and near First Nation and rural communities throughout the province. It is important for BC to protect those who live in rural and remote communities and to ensure the safety of all forest workers.

The BC Centre for Disease Control has released *Protecting Employees, Contractors, and Employers Working in the Silviculture Sector During the Covid-19 Pandemic* which outlines safety requirements for tree planters. Additionally, guidelines for industrial camps have been released. For copies of these policies, please go to:

Following these new safety requirements is anticipated to increase costs associated with reforestation. Since major licensees are responsible for reforestation as part of their tenure obligations (*BC Forest and Range Practices Act*, Section 29), they will initially bear any extra costs.

#### 1.2 Objective

This note clarifies how any additional planting costs associated with compliance with the BC Centre for Disease Control's *Protecting Employees, Contractors, and Employers Working in the Silviculture Sector During the Covid-19 Pandemic* will be recognized in the Tenure Obligation Adjustment within the BC stumpage system.

#### 2.0 Recognition of Tree Planting Costs

Silviculture costs are adjusted annually as part of the *Coast and Interior Appraisal Manual's* update process. This process ensures licensees receive fair compensation for their tree planting costs. Costs incurred by licensees meeting Covid-19 related safety requirements will be factored into the silviculture cost estimates used in the stumpage appraisal system. This is consistent with current practice pre-Covid-19.

For any costs in a contract between licensees and silviculture contractors to be recognized in the appraisal system, they need to be realized costs. If a silviculture contractor experiences any unforeseen extraordinary costs during the planting season, the licensee and the contractor can report the event and associated costs incurred to the Area Director for Pricing and Tenures. The Director will work with Timber Pricing Branch on possible solutions.

It is expected that licensees will comply with the safety guidance and be able to provide evidence of compliance upon request. Timber Pricing Branch will use comparisons to extra costs experienced by BC Timber Sales as appropriate when adjudicating reported information.

#### BACKGROUND:

- The Covid-19 pandemic is causing a slowdown of the world economy.
   The price of lumber has dropped from above US \$400/mfbm (thousand board feet) to less than U.S. \$301/mfbm in a matter of weeks.
- In the B.C. Interior, companies have recently stock piled their "break-up" inventories (enough logs for several months worth of sawmill production).
- Due to the rapid fall in lumber prices, this sawlog inventory will need to be written down financially which will lead to a loss for the companies in the first quarter of 2020.
- Interior companies were just recovering from a challenging year financially in 2019 (caused by low lumber prices and scarcity driven high log prices).
- 2019 and early 2020 was also a challenging year on the B.C. Coast with Western Forest
  Products, controlling half of the coastal replaceable forest tenure and sawmill capacity, being
  on strike; the global export log prices fall which resulted from oversupply caused by a spruce
  beetle outbreak in Europe; and Mosaic shutting down harvest due to inability to export logs.
- The Coast industry had not recovered from 2019 when the Covid-19 slowdown occurred.
- Liquidity and credit availability have become challenging for many companies in the B.C. forest industry which is leading to increased production capacity reductions and job losses. This is evidenced by the current shutdowns of sawmills and pulp mills across the province.
- Major licensees are responsible for silviculture as part of their tenure obligations, and silviculture costs reduce stumpage through the appraisal system.
- Covid-19 safety requirement for tree planters are increasing tree planting costs.
- Extraordinary tree planting costs may be experienced by licensees if a tree planting camp become infected with Covid-19.

#### DISCUSSION:

Silviculture costs, including tree planting, are adjusted annually as part of the Coast and Interior Appraisal Manual's update process. This process ensures licensees receive fair compensation for their tree planting costs on average. Cost incurred by licensees meeting Covid-19 related safety requirements will be covered by average over the next two to three years through the appraisal



ISSUE: Crown Land Tenures During COVID-19 Pandemic

#### **BACKGROUND:**

 The Ministry of Forests, Lands, Natural Resource Operations and Rural Development (FLNRORD) – Corporate Services for the Natural Resource Ministries (CSNR) issues invoices for Crown Land Tenures, including leases, licenses of occupations, rights of way, and permits, on a monthly basis to cover annual rent.

- There are over 40,000 Crown land tenures across 28 land use activities on the land base ranging from agriculture to utilities, commercial recreation to alternative energy, quarrying to residential and oil and gas.
- The most recent revenue forecast for 2020/21 land tenure revenue is \$57M with upcoming billings estimated as follows:



- Crown Land tenure invoicing since COVID-19 has been put on hold.
- The Province employs an annual minimum rent (i.e. \$500) to offset the ongoing annual costs
  of administering a tenure in those cases where pricing would not produce enough rent to
  recover costs.

#### DISCUSSION:

- Although regions have received some inquiries from clients regarding payment of rent, to date there has not been an overwhelming number of clients seeking relief.
- The following tourism and recreation sector-specific requests have been received in writing to the Ministry of Tourism, Arts and Culture (TAC) and/Ministry of Forests, Lands, Natural Resource Operations and Rural Development (FLNRORD):
  - Tourism Industry Association of British Columbia (TIABC): tenure fee suspension or deferrals.
  - Canada West Ski Areas Association (CWSAA): reduction and deferral of land tenure fees
  - o Guide Outfitters Association of BC (GOABC): defer the fees payable to the Crown.
  - Commercial Bear Viewing Association (CBVA): waive all crown fees and taxes for 2020.





 Back Country Lodges of BC Association (BLBCA): Waive all rental fees for tenures/permits, property taxes and other related costs for a period of 2 years.

Fees are due at the end of May if the Angler Guide is already registered, or upon registration for new Angler Guides.



- Liquidity and credit availability have become challenging for many companies in the BC Forest Industry which may lead to increased production capacity reductions (job losses) and slow down the recovery of the sector post Covid-19.

#### DISCUSSION:

In response to the Covid-19 pandemic, Timber Pricing Branch (TPB) received direction from the Minister to defer the issuance of all bills, invoices or other financial statements with respect to agreements held under the *Forest Act* or the *Forest Practices Code of British Columbia Act* to April 20, 2020.

The direction explicitly includes deferring invoices for stumpage, waste, annual rent and other rents payable. Areas and Districts have been advised to continue regular billing procedures and TPB will take responsibility to defer invoicing at head quarters.

The Premier's office is currently reviewing options regarding stumpage payment deferrals to increase forest industry liquidity during Covid-19 pandemic.

TPB requires further direction regarding forest invoices if a final decision on stumpage deferrals is not made prior to April 20, 2020.



- Liquidity and credit availability have become challenging for many companies in the BC Forest Industry which may lead to increased production capacity reductions (job losses) and slow down the recovery of the sector post Covid-19.

#### DISCUSSION:

In response to the Covid-19 pandemic, Timber Pricing Branch (TPB) received direction from the Minister to defer the issuance of all bills, invoices or other financial statements with respect to agreements held under the *Forest Act* or the *Forest Practices Code of British Columbia Act* to April 20, 2020.

The direction explicitly includes deferring invoices for stumpage, waste, annual rent and other rents payable. Areas and Districts have been advised to continue regular billing procedures and TPB will take responsibility to defer invoicing at head quarters.

The Premier's office is currently reviewing options regarding stumpage payment deferrals to increase forest industry liquidity during Covid-19 pandemic.

TPB requires further direction regarding forest invoices if a final decision on stumpage deferrals is not made prior to April 20, 2020.

Hi Trevor,

I have participated in a number of teleconferences with industry leaders over the past 2 days and have learned a lot about the complexities of how government, licences and contractors are trying to sort out how to safely start the planting season. As we have discussed and similar to may other industries there are direct costs associated with trying to do business in light of COVID 19. The current roadblock to move the season forward is not about what health measures need to be in place but who is going to pay.

Prior to the PHO order the industry has had a proposal outlining their estimate of costs which has been submitted. Now that the PHO order is in place we have been able to map out a list of additional direct health measures that are needed. I have attached a draft outline of services necessary to meet the specifics of the order along with the costing model. This estimated cost is \$3.00 per planter per day. Whether or not my group delivers these services is secondary to the fact there is consensus that an enhanced support system is required. I would be interested in any approach you may have to support how we may be able to fund the services. I am aware that there are discussions regarding a large budget deploying security guards to monitor tree planters and would certainly be interested in discussing how the listed services would provide a more education based vs. enforcement approach vs. approach to achieve a much broader goal.

I would be happy to set up a time to discuss further.
