Good Afternoon Charlie and Gio,

Dan has asked that I forward you the attached proposed summary outlining FDMS' services in advance of our meeting tomorrow and our biographies for background.

Some of the expectations we considered when drafting this response include the following:

- We are assuming there will be 2 tables requiring facilitation:
 - Main table consisting of Ministers, Chiefs, and Deputy Ministers
 - Senior Officers table with ADM's, EDs, FN Senior Officials
- Facilitation of these tables is heavy and requires increased effort, prep, and recovery for Dan and the FDMS team which is reflected in the higher daily rates for facilitation services as compared to our standard daily rate
- Given the complexity of the issue and the interests all parties have for this process, expectations for its outcomes are heightened and as a result, FDMS has drafted the attached response with the expectation that we will be utilizing our full team to complete this important work.
- A legal or contractual firewall should be established to protect the independence and neutrality of FDMS as the third-party facilitator so as to ensure a safeguard for Dan and the team in the unlikely event any legal action is taken by either party.
