Reference is made to your application dated January 8, 2019, for an amendment of Road Permit (RP) No. R05413 associated within TFL 46.



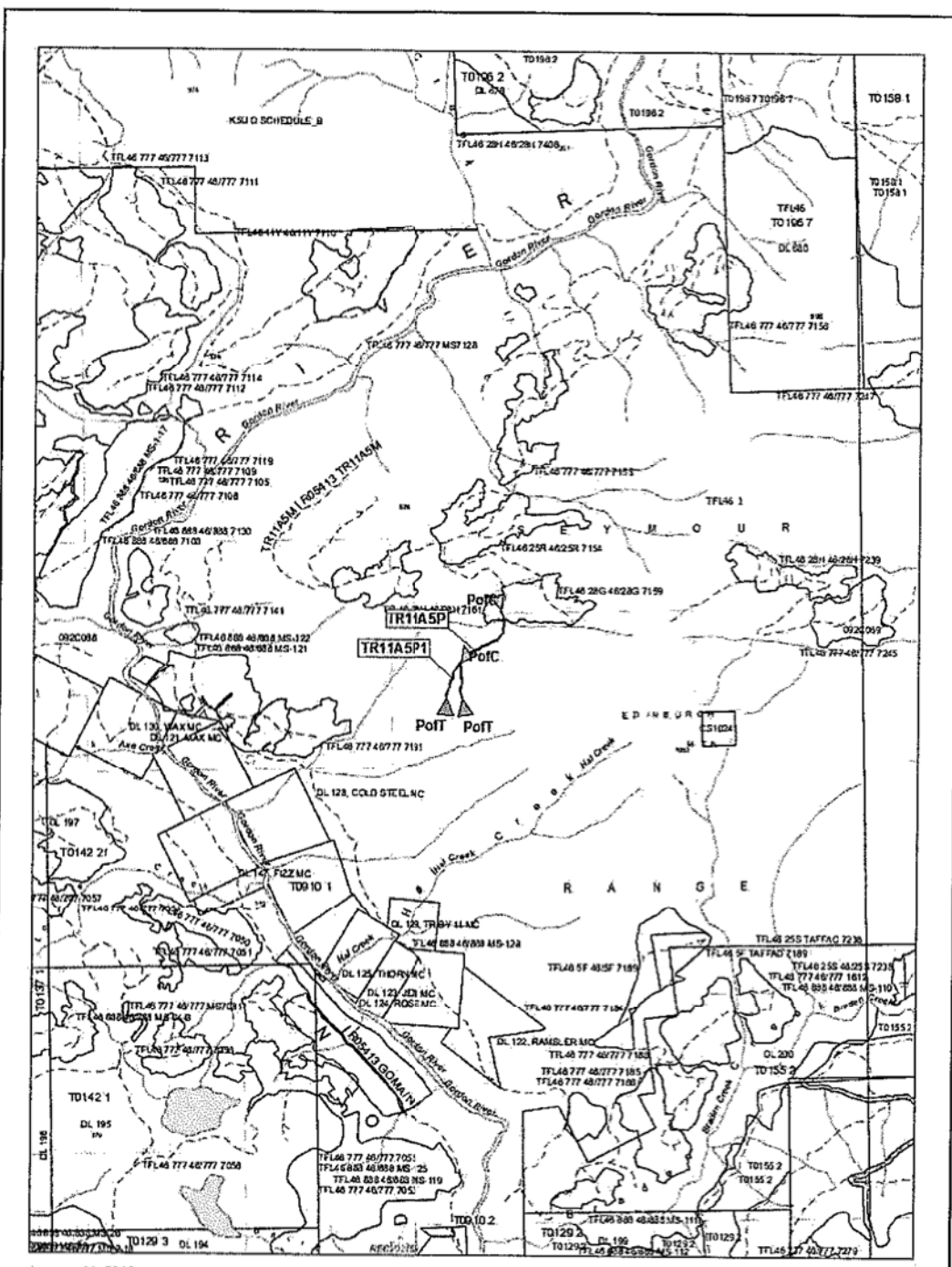

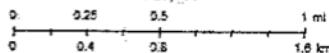

We request an amendment to road permit R05413 to include roads required to develop Cutblock 7163 of TFL 46. The spatial data has been submitted through ESF/FTA as submission # 1825863.

Attached for your review and approval is a 1:5,000 scale map outlining the roads under application. Any associated right of way volume will be stamped to 46/0R1.

In accordance with the Forest Stewardship Plan approved for TFL 46, we have prepared an amendment to the boundary of OGMA #230 which accommodates the location of Branch Road TR11A5P. Given that the boundary of the OGMA has been amended, the road permit area applied for will not overlap the OGMA.

The roads under application are:

- TR11A5P, stations 0+000 to 0+687
- TR11A5P1, stations 0+000 to 0+232
