

Yes the idea was to have some standard responses to some of these, so depending on the traffic government or the BCTA receives, we have some standardized replies. The idea was to collaborate with government so we are on the same page for the replies.

The second piece was to spread the word that trapping season is open, and that back country users should use caution. Maybe this messaging could be combined with something like hunting seasons are open again also. Winter is coming, and back country users should be more prepared for changes in weather and mountainous conditions. Of course also that trapping is happening, use caution. #### Trapping and Pets FAQ

1. My pet is caught in a trap. What do I do? How do I release it?

The steps to remove your pet from a trap depend on the type of trap. Some traps are easily removed by hand while others may require the use of an improvised tool.

Before attempting to remove the trap, seek to calm your pet and protect yourself from being bitten. A pet caught in a trap may be aggressive towards those seeking to release it. Using a muzzle, if available, is recommended.

If you are unable to remove the trap, contact the Conservation Officer Service at 1-877-952-7277.

2. How can I keep my pet safe?

The best way to reduce the chance of pets encountering traps is to keep pets leashed in back country areas. This is especially important if you encounter a trap or signage indicating there are traps nearby.

Some preparation can also be helpful. Review the current "<u>Hunting and Trapping Regulations Synopsis</u>" to learn the trapping season dates in the areas you take your pets. Familiarize yourself with the basic trap types and techniques for releasing captured pets. You may wish to print off this <u>guide</u> and carry it with you while out with your pet.

3. What is the BC Government and the BC trapping community doing to avoid catching pets in traps?

The BC Government regulates trapping. Regulations improving the safety of people and pets include the requirement to set traps 200 meters away from residences and the prohibition of using large body-gripping traps in BC municipalities. Violation of trapping regulations is subject to fines and penalties. To report suspected violations of trapping regulations, contact the BC Conservation Officer Service at 1-877-952-7277.

The BC Trapper's Association has developed training materials specific to urban trapping, where there may be a higher risk of capturing curious unleashed pets. Where feasible, box or cage

traps are mainly used for capturing wildlife in urban/suburban to reduce risk of injury to captured pets.

The BC Government and the BC Trappers Association encourage trappers to post "active trapping" signs during trapping seasons to caution pet owners and other recreational users, and have made free signs available to trappers.

#### 4. Can anyone set traps anywhere?

In most cases, you must have a trapping licence to set traps for wildlife. To be eligible to for a trapping licence, you must be a Canadian citizen or permanent resident and have completed the BC Trapper Education course.

Trappers can only set traps if they have permission to do so from either the trapline holder (on Crown land) or the land owner (on private property). Traplines are defined areas in which an exclusive right to trap is granted.

Traps can be located anywhere within a trapline boundary and are often hidden to avoid vandalism. Trappers are encouraged to avoid setting traps in high traffic areas where the public and their pets are likely to be, including the beginning and end of forest service roads, recreation sites, and popular hiking trails.

#### 5. When does trapping happen?

Generally, trapping occurs within regulated trapping seasons. BC creates trapping seasons based on a variety of criteria including pelt primeness (peak quality), relative vulnerability of age and sex classes to harvesting, abundance and capture technology.

Trapping seasons vary depending on the species targeted and the area of BC. Most trapping seasons run from mid-fall to early spring (~October – April). Some trapping can occur throughout the year. For instance, wildlife threatening livestock on private property may trapped outside of trapping seasons.

## 6. What type of traps are set in this area?

Trappers often set a variety of trap types in each area to target different species. Some traps are designed to restrain wildlife until the trapper arrives, while other traps are designed to kill targeted wildlife quickly.

All traps used in Canada must be certified and meet international standards for humane trapping. You can learn more about the Agreement on International Humane Trapping Standards here: https://fur.ca/fur-trapping/humane-trapping-standards-and-animal-welfare/

#### 7. Isn't trapping a danger to children, or to people in general?

Human injuries from legal trapping are possible, but very rare. While traps are typically not placed in high traffic areas, they are often hidden to avoid vandalism so can be stumbled upon by a passerby and cause injuries to feet or hands. For this reason, it is best to remain on main trails and roads in areas with active trapping.

#### 8. How do I contact a trapper?

Privacy laws restrict the BC Government from releasing contact information for trappers in most circumstances. However, you may make a "Freedom of Information" request for contact information for the person(s) who holds the right to trap in a certain area. #### 9. Why is trapping legal?

Trapping is permitted in all provinces and territories of Canada and in many other countries. Trapping occurs for different reasons, including food, fur trade, pest control, and wildlife management. More specifically, wildlife may be trapped:

- to protect natural habitat, farmland, roads and other property from wildlife damage;
- for disease control (such as rabies or beaver fever);
- · to maintain or improve biodiversity of both animals and plants;
- to protect vulnerable species from over-abundant predators or competing species;
- for public safety;
- to safely remove wildlife in urban and suburban areas;
- · for reintroducing species to their historical territories;
- · for conservation research;
- for environmental and wildlife monitoring;
- for furs and food.

#### 1. How do we get pet out of trap?

## 2. How do I know where these traps are?

- Almost every bit of crown land within the province is part of a registered trapline. Traps can be located anywhere within the trapline boundary and are often hidden to avoid vandalism. Registered trappers are encouraged to avoid high traffic areas where the public is likely to get out and let pets run: start and end of forest service roads, recreation sites, popular hiking trails... It is best practice to keep pets leashed during the active trapping season for their safety.

#### 3. What kind of traps do you have set here?

- Trappers will often have a variety of traps and snares set, each with a targeted species in mind. Some traps are designed for restraining and some traps are for killing. All traps used in Canada must be certified and meet a specified standard for humanness, if there is question that illegal traps are in use please report to the RAPP line. 1-877-952-7277 (RAPP) or #7277 on a mobile phone

#### 5. Isn't trapping a danger to my children?

- While a trap does not pose any immediate danger to your children some traps could cause injury to hands or feet. Traps are often hiden by trappers so they are not vandalized or easily stumbled onto by the unknowing public. It is safest if a trap is found to not touch. Harm to the public caused by traps is an infrequent occurrence and often associated with improper/illegal trapping practices or risky human behaviour. Wildlife trapping is governed by provincial/territorial regulations. Violation of trapping regulations is subject to fines and penalties. Minimum set-back requirements for placement of traps on public lands are included in provincial/territorial regulations. Some public spaces post signage when urban trapping is occurring. Box or cage traps are mainly used for capturing wildlife in urban/suburban areas where there may be a risk of capturing curious unleashed pets. They are effective for capturing certain smaller animals, but can also be less selective than restraining foot hold traps. Use of qualified licensed trappers ensures traps are used safely and in accordance with rules and regulations. If there is a concern a trap is illegally set contact the RAPP line and have the Conservation Officer Service investigate. 1-877-952-7277 (RAPP) or #7277 on a mobile phone

#### 6. How do I get a hold of the trapper?

- Through the freedom of information you can make an application to find out who owns a specific trapline. Link to this process https://www.oipc.bc.ca/

#### 7. How do I stop it?

- If you have any specific concerns about trapping or the trapping industry you can contact Ministry of Forest Lands and Natural Resources Operations & Rural Development. If you determine there is an immediate danger to the public please report your trapping concern to the RAPP line 1-877-952-7277 (RAPP) or #7277 on a mobile phone

#### 8. Are you trapping yet?

- Depending on the species and the nature of the trapping some areas of the province there may be year round trapping. Livestock protection and property protection trapping can occur year round. Trapping for the fur trade only happens when pelts are prime typically running from mid fall till the first part of spring in April. It is encouraged that trappers put up "active trapping" signs during trapping activities and take them down at the end of the trapping season.

I think the Q&A was well done, easy to understand and to the point.

The only thing I would consider adding/mentioning is that when people encounter/observe trapping signs they should actually keep their pets very close on a leash (as indicated)

<u>or in the vehicle</u>. As you may be aware, species such as wolves/coyotes are often travelling logging roads and old grades and these areas (road edges and the intersections of roads)

are often ideal trap setting locations for restraining traps i.e. foot-holds.

Unfortunately, these are often areas where people like to stop and let their pets out of the vehicle for a bathroom break.

I urge our trappers to place signs at the start of the logging road/mainline that they are trapping on and also sign any additional alternate hook-up roads coming the other way (backdoor) as well.

Otherwise looks great to me.

Thank you for your letter dated February 19, 2019, regarding your request for the Province to seek intervenor status in the lawsuit brought against trapper \$.22

I understand that allegation agains s.22 is that he was negligent in placing his traps for a variety of reasons. I also understand that section 28 of the *Wildlife Act* is referenced in support of the claim.

Generally, the Courts have discretion whether to allow a party to intervene in a lawsuit. Typically, the party seeking to intervene must demonstrate a direct interest in the lawsuit or that the lawsuit raises public law issues.

I wish to advise you that the Province will not be applying for leave to intervene.

Please keep us apprised of the status of the litigation and whether the BCTA is granted intervenor status.

Thank you for your email of February 5, 2019, regarding your proposal to enact a trap warning sign system.

I'm sorry to hear that your dog was caught in a trap. That must have been a terrible experience. A staff member tells me that your story on the Defender Radio podcast is powerful and speaks to the challenge of accommodating different outdoor recreation activities in the same areas. Thank you for sharing.

Your proposal is timely. We are considering regulation changes that would require trappers to post warning signs in some circumstances. There are many interests at play and my staff are working hard to unsure that any changes to improve pet safety are workable for all outdoor recreationalists, as well as interested government groups such as the Conservation Officer Service.

My staff are in touch with the Association for the Protection of Furbearing Animals, who created the proposal you put forward, and will seek their input on any regulation changes that move forward.

As you know, no ID tags on traps are required, therefore we have no way of verifying this information nor are we able to trace the trap back to the owner.

Is there anything your department can do to help raise the standards of public safety and animal welfare related to trapping? Can you recommend amendments to the legislation? I am very familiar with the Agreement on International Humane Trapping Standards (AIHTS). Sadly, AIHTS is now over 20 years old and is full of loopholes. Additionally, municipalities are STILL waiting for permission from Doug Donaldson to approve their pending trapping bylaws.

We urgently need:

- ID tags or serial numbers/license numbers on all body-gripping traps
- Mandatory warning signs
- A prohibition on snares (they are excluded under the AIHTS)
- Permission from FLNRO to those pending requests from Surrey, Sechelt, White Rock and Nanaimo (Another recent media clipping here: <a href="https://www.nanaimobulletin.com/news/seven-years-later-nanaimos-animal-trapping-bylaw-still-isnt-approved/">https://www.nanaimobulletin.com/news/seven-years-later-nanaimos-animal-trapping-bylaw-still-isnt-approved/</a>)

While I appreciate COVID is slowing down government systems, these are long-standing issues that are causing unnecessary and <u>preventable</u> pain and suffering to wildlife and non-target animals including pets.

Can you please give me some reassurance that your department is actively working on these issues and provide a timeline for when the public can see changes to the trapping regulations in BC?

Thanks for your email and your interest in helping ensure crown land is available for use by everyone.

You are correct that there is currently no legal requirement for trappers to post signage indicating that there is active trapping activity in an area. Posting warnings signs is suggested within the Hunting and Trapping Regulations Synopsis as a best management practice, as is determining whether lethal traps are necessary when trapping near recreational areas and communities. There are legal requirements for the placement of traps on registered Recreation Sites and Trails (pg 11 of the synopsis) but these restrictions only apply on the relatively few Recreation Sites.

One of the main hurdles with mandating the posting of trapping signs is how relatively intractable the regulation's enforcement would be. Most of the trails in question are not registered or maintained or have any kind of legal standing to indicate that they are publicly used. Without some kind of determination on what is a publicly used trail and what is not, it becomes virtually impossible to determine from a legal perspective which trailheads require signage and which ones do not. We have in the past worked with trappers to encourage posting signs at trailheads they know to be publicly used, and have provided signs to trappers so that they have the means to do so. I will work with the trappers to reinforce the importance of signage, and make sure signs are available as needed in order to help to make sure that all users of Crown land are able to freely use and enjoy our outdoor pursuits. I believe it is everyone's goal to make sure an experience like yours does not happen again.

Regarding trapping on crown land and the requirement, or lack thereof, for trappers to mark their traplines. On Dec. 28, 2019 our dog almost died in a baited #330 Conibear kill trap (see link below for full story). This is the largest standard sized Conibear trap built, it is very powerful and meant to kill instantly or within a few minutes. My concern is that these traps are dangerous and unmarked. In this instance traps are being set in an area used by local residents for outdoor activities (hiking, skiing, getting Christmas trees, etc), sometimes as family outings, and often with dogs. It is a real shame, knowing that these unmarked hazards exist, that we can no longer walk our dogs on crown land without them being leashed the entire time. I believe that this is also a real threat for families with small children, as the wooden box containing this trap could appear as a small fort that other kids have built (something to explore, and kids are often running up ahead of the parents on the trail). This trap was just 20 feet off the trail. Why aren't trappers legally required to mark their traplines? Not every trap would need to be marked, just the trail heads would be fine, to let people know that the danger exists along that particular trail. Are public lands not meant to be enjoyed by all people? It seems that some people, dog owners at least, certainly can't enjoy them, knowing that baited kill traps and snares exist in the woods, unmarked. Around Kimberley that occurs for 5 1/2 months of the year (Oct 15 to March 31). I certainly hope that marking traplines can become a legal requirement, in order to make it safer for the general public while on crown land.
