All. Below FLNR and salmon comments extracted from PJH media avail. Full transcript follows.

Nathan Cullen, Minister Cullen's responsibilities, is to work with Minister Conroy to break up Forests, Lands, and Natural Resource Operations. When we were sworn in in 2017, it was my desire to have a standalone Ministry of Forests, something that the former BC Liberals had rolled in to what is now one of the most unwieldy ministries within government -- Forests, Lands, Natural Resource Operations, and Rural Development.

So Minister Cullen's job is to work with Minister Conroy to disaggregate that, and take component parts, and move them to where they might be better utilized. And when that work is complete, that will become then, I'm hopeful -- again, we will see how the work goes -- a stand-alone Ministry of Forests with Rural Development attached to that, and Lands and Natural Resource Operations as a stand-alone ministry as well, which would be a full ministry with significant human resources and so on.

So I talked at length with my outgoing deputy minister Don Wright, and my incoming deputy Lori Wannamaker -- two career professional public servants -- I expressed my desire to have two ministries where one existed. And they said great ideas, but you don't want us to do that in the next two weeks, do you? And although I did, I took their good advice, and said let's find a way, with a four-year mandate ahead of us, to do this correctly.

The ministry was created by Gordon Campbell just days before he resigned as Premier. If you go back through your files, Les, you'll remember that. And so the ministry was created, and the person who created it left the building. And it has been existing for a decade, or almost a decade, without any amendments or revisions. And I think it's an important part of our economic vitality, certainly forests, but also to have the permitting and other processes separated so that they can have a stand-alone minister.

Another point I want to make is Fin Donnelly is the parliamentary secretary for salmon and aquaculture. Fin's task is to work with Lana Popham, the Minister of Agriculture, Food, and Fisheries, but also to work with Minister Cullen and to work with Minister Heyman to take those component parts that are spread across government -- the provincial government -- and bring them into one place so that we can focus on being equal partners with the federal government when it comes to saving our salmon for this generation and future generations.

It's something I know Fin is very well suited to do. A stand-alone Ministry of Fish did not make a lot of sense. It was tried in the past. The primary responsibility -- or primary jurisdiction -- rests in Ottawa. I wanted to make clear to Ottawa that British Columbians care deeply about salmon. They have cared deeply about the impacts of salmon aquaculture and the jobs that go with it. So to have Fin Donnelly, the parliamentary secretary to address all of those bits and pieces in government is part of what I think a renewed government with a majority mandate should do.

So we're going to be doing some reorganization. We're not tipping over the apple cart. That would be inappropriate. We're doing it in a thoughtful way. Minister Cullen will be part of that Parliamentary Secretary Donnelly will be part of that, and Minister Heyman will be part of that, as we build out what we believe will be a more coherent system for decision making.

Hi Wendy,

Thanks for forwarding the note. We have been communicating with Mr. Washer extensively and I would suggest he is not entirely forthcoming with everyone he is reaching out to at the moment. We recently held a meeting with Vera Vukelich from our policy shop and Mr. Walker so that he could hear it from our Lands branch manager directly what our ministry's policy direction is. This was also an opportunity to demonstrate to Mr. Washer that my staff at the district level were applying fair process and interpretation of our ministry policy. Despite this, Mr. Washer continues to perpetuate the idea that we are treating him unfairly and are unsympathetic during difficult times. In my view, when Mr. Washer is asking for flexibility, he is asking us to allow him to break the law and he is clearly acting in contravention to the terms of his Land Act tenure. Please see attached my last letter to Headline. This file has become unnecessarily time consuming and is unfortunately disproportionately distracting my staff from helping others in need in the adventure tourism sector.

### Some additional thoughts from my staff:

- The Sea to Sky office has been engaging with Doug Washer/Headline directly on compliance issues with his licence of occupation since Summer 2018.
- The compliance issues are the same activities he expressed wanting "relaxed policies" for below.
- Headline was "pivoting" from their authorized activities under the management plan prior to the covid-19
  pandemic. They were doing so without FLNRORD's authorization and we have been working to get them into
  compliance since 2018.
- Doug's comparison of Crown land AT use to the "sidewalk policy" for restaurants is not comparable. Crown land use involves a much larger scope of consultation to ensure protection of environmental and cultural values, and to meet consultation requirements with First Nations and the public. There is high risk in Sea to Sky to allowing changes to Crown land use without adequate review and consultation.
- Doug contacted 4 ministries (FIN, TAC, JEDC, and FLNR) by email in July 2020 with the same request that policies be relaxed and that businesses on Crown land be allowed to modify their operations under expedited review. FLNRORD provided a response to this communication stating it is not possible.
- High recreation use in Sea to Sky necessitates a modified approach to the rest of the Province, as there is greater opportunity for conflict between operators and with the public.
- The noted "incidental use" policy was never intended to be interpreted on the part of the operator. It's intent is as a tool for decision makers to <a href="Months: EHOOSE">CHOOSE</a> to treat some possibly lower-impact activities differently <a href="IF">IF</a> it makes it less work for government. A management plan is the only thing that governs allowable use for

tenured activities. If Headline was relying on the incidental use policy for some of their activities (as they say they were), that was not appropriate or allowable.

I appreciate this is likely much more than you were looking for in terms of a response but I felt it was important to share a broader perspective of the issue.

Hi Jonathan,

Thank you for your reply. I'm doing well thank you for asking and I hope all is well with yourself.

I appreciate your taking this up with the Ministry of Tourism, Arts and Culture. As COVID takes hold in our corridor, I think this issue is becoming even more pressing.

As a point of interest for you, I have reached out and have had several discussions and emails with the local Squamish office. The challenge seems that a relaxing of the policies requires a top down approach as they feel they are obligated to hold to status quo without clear direction from Victoria to make things happen on the ground as it were.

I think the parody is similar to the Hospitality sector whereby side walk usage was allowed for seating of patrons and the process of applications was expedited and prioritized. My understanding is (and I could be wrong) but that approach seemed to be a Top Down approach including the Premier making these announcements early on when COVID hit.

The Ministry of Forests, Lands and Natural Resource Operations has not employed this approach thus far. My request to reach out to other Ministries for support is based on discussions with the District Manager and staff in Squamish and with Vera Vukelich, Manager of Land Policy and Programs. I appreciate there are many factors involved in the decision making process for new applicants and it's a lengthy process however, I feel any new proposals by untenured operators could and should be put on hold. Additionally, I feel that current tenured operators could be provided *temporal* relief to relax *minor* restrictions to existing and *Ancillary* activities.

The hot topic in our industry is to "Pivot" your business model and diversify however, restrictions imposed by MFLNRO prevents this from happening in a timely manner under it's current direction.

If it would help to discuss the matter by phone to provide greater context, i'd be happy to do so.

In any event, I truly appreciate you're taking this matter to heart and doing what you can to shed some light on the issue. Time is certainly of the essence and we do not seem to be getting the kind of response we need from MFLNRO to get our team(s) back to work.

Hello Daniel,

Thank you for fielding questions for the upcoming VCM Webinar.

There seems to be a great deal of support for the hospitality Industry in general and Government seems to be making great efforts to support everyone through this difficult time which I am incredibly thankful for. That said, my business is experiencing unprecedented difficulty and a distinct lack of support from one branch of government is making it exponentially worse. MFLNRO could make a great deal of difference by supporting tenured operators conducting business who operate with a Licence of Occupation (land Tenure).

In the lower mainland in particular, there are policies in place such as the "Incidental Use Policy" which makes up part of the "Adventure Tourism Policy" which could be relaxed, even if just on a temporal basis which is not happening. It seems that restaurants are being allowed to occupy side walks to address COVID impacts for example, yet we are not seeing that similar level of cooperation and support from MFLNRO.

COVID is having a dramatic impact to our business and our inability to pivot, even slightly, and to employ existing policies into our operations to allow us some flexibility which would allow us to hire back staff and contribute to the economy again is simply not happening.

MFLNRO is not allowing us to use policies that exist without prior approvals from Local "District Decision Makers" (DDM's) which can take 2-3 years. Historically, these policies could be used at the discretion of the operator which is now being denied, which is counter intuitive during such difficult times.

### My question is:

What is and / or can be done to get MFLNRO to look at its current, overly restrictive policies and to relax them for a period of time to allow us to get back to work?

### My specific situation is as follows:

We operate Heli Snowmobile / Snowmachine tours on an Ice Cap taking guests to Ice Caves for interpretive tours. This is a logistically complex environment to operate in. Due to a long list of complex reasons, mostly due to weather and snow conditions, it is difficult to access the snowmobiles 100% of the time. (they could be buried upon arrival with guests for example)

For the short term:

- We ask that if the snowmobiles are not accessible, that we be permitted to guide guests to the ice caves without the use of snowmobiles /Snowmachines. (more environmentally friendly)
- We ask that our season be extended through August to Mid October which our Current plan does not permit
  for.
- We ask that as an operator, we be provided the Autonomy to employ the Incidental Use Policy as it was intended and as is allowed in other jurisdictions outside the Sea to Sky corridor, which policy we have relied on in the past but are now being restricted from using.

We believe there are many operators who could benefit tremendously at the moment if some basic policies were relaxed for the short term. We also believe that Current Tenured Operators who are impacted by COVID should be granted Priority by MFLNRO in helping them get back to work ahead of NEW applicants that are not operational.

I appreciate this is a lot of information but I wanted to put some context to the reason for the question.

In short, What discussions are being had with MFLNRO to help operators get back to work? My points above are simply examples that I think they could explore to help us through this Pandemic.

Good morning all. We began briefing the Minister yesterday as you have seen from Andrea's note. I think the briefings went well. I got a good feeling from it, positive and comfortable dialogue with the Minister and the dynamic with the Ministers office team we all know.

### Observations:

- We discussed how the Minister wants her briefings, her style, preferences. I can share that she is likely less on the details than the former Minister. She will benefit from more concise notes, backed up with direct briefings with executive members. That's my initial sense.
- I expressed our intent to CI to her standard and for her to feel free to punt back materials so we can adjust to her needs. So expect some feedback via Andrea.
- Continue to use Tim R to get advice.

### **Building on Success:**

- Eamon was the first ADM after John and I and he set the standard. Very well done. 3 key items, explained at the right level of detail, with the mention of the political relevance, immediate issues she will have to deal with. I would encourage you to talk to Eamon to see how that went.
- The one thing I realized is the briefings will be at risk of all looking like a large set of massive intractable
  issues. I told John we should try to weave in 'good news' items. I know we held you all to 3 but please
  consider how to give the Minister some sense of how we plan to achieve outcomes and that you have a way
  forward on your items.

### Lori Halls and her Assignment:

- I will hold a more detailed call with executive. But for now, I am focusing with Lori on the backstory.

  Orientation on how the Ministry was formed, the drivers, principles and objectives of the formation of the Land Manager model. We are getting back at it for the balance of the day today.
- The goal this week is to ensure that Lori is well positioned to engage with the Minister of State and the discussions are well anchored in an understanding of where we came from, why, and how we function today. I may reach out to any one of you to help with these discussions.
- So far it has gone very well. Lori and I have a long trust relationship so I am able to be direct and she is able to press and test assumptions and my bias.

Hi – I've been thinking more about the delivery of the OG program....and had time because they cancelled the OGSLT meeting. I think the structure that we landed on and submitted to Brian is still a good one. However, it made me consider how this might fit with a larger re-organization. Attached is where I landed.

More leadership is required given the strategic and complex nature of the work that we are being asked to deliver on – which means most of the re-organization needs to happen at RED and above. For many reasons FLNRORD was on the right track with integration and the one-land manager approach but the policy and strategic leadership is the missing piece. Nobody can manage the breadth of operational issues that ADMs, EDs and Directors are being asked to manage and create strategic policy at the same time. Therefore, a model that leaves the worker bees doing there thing but reigns in the scope of leadership roles to allow concentration on the higher level issues might be a good idea.

I know nobody has asked us to solve this but interested in your thoughts on the attached.

## **Executive Update**

Lori Halls

Hello FLNRORD Staff,

With the support of Minister Conroy, and as part of Minister Cullen's mandate deliverables, the Premier has asked that a plan be brought forward to create a new Ministry for Lands and Natural Resource Operations. This new ministry will develop and implement land use policies that support B.C.'s goals for economic activity, environmental sustainability and reconciliation with Indigenous peoples. Creating options for government on what this new organization could look like and how it integrates with other ministries is the focus of the Secretariat's work. This is what I want to update you on today.

Ninety-four percent of British Columbia's land base is Crown land. Land use issues have become more challenging and more complex. There are no easy decisions left to be made. Modernizing land use policies to address our current and future context (climate change, competing interests, changing industries, etc.) is necessary and, in many cases, transformative. We must ensure that efficient and effective organizational structures are in place in order to support an integrated approach across the land base. This will be key to achieving our economic, social and reconciliation goals.

The Ministry of Forests, Lands and Natural Resource Operations was established in 2011; Rural Development became part of the ministry in 2017. FLNRORD was created to better integrate natural resource activities and decisions across the province. FLNRORD's work is inextricably linked to the natural resource sector as a whole, and integration must continue. Given our changing landscape, we've been asked to determine whether the organizational structures built over the past ten years are set up for us to be successful in the future.

Essentially, we are asking the question: Can land use objectives that support economic activity, environmental sustainability, and reconciliation with Indigenous peoples be more effectively achieved through restructuring?

The Lands and Natural Resource Operations Secretariat has been established to undertake this work. Each natural resource sector ministry is contributing resources to this initiative and will have a voice on the Secretariat as the work progresses.

The Secretariat will be thoughtful and inclusive in its approach. Normally, organizational restructuring like this would happen behind closed doors; however, our approach will be much more transparent, and I will be providing you with monthly updates on our progress.

The Secretariat is developing design principles, and we will complete our work in three phases:

- Assessment (Diagnosis)
- Design (Options Development and Direction)
- Implementation

We will undertake the <u>Assessment Phase</u> between February and May 2021. It will involve extensive internal and external engagement in order to understand both the challenges and opportunities within the natural resource sector. Alongside regular engagement with the Deputy Ministers and Assistant Deputy Ministers' Committees on Natural Resource Sector, we are planning to conduct interviews and focus groups with a cross-section of staff from the natural resource sector.

Following the Assessment Phase, the Secretariat will initiate the <u>Design Phase</u>, developing options for government on what a new ministry or organization focused on Lands and Natural Resource Operations could look like. We anticipate seeking direction on any restructuring in Fall 2021. The <u>Implementation Phase</u> would follow direction, which we anticipate for completion in Spring 2022. I will have more to say on all three phases in the coming weeks and months.

As part of the Secretariat team's orientation to the sector, Secretariat staff will be meeting with many FLNRORD staff to better understand the ministry's business and its evolution. These orientation sessions kicked off recently with Rick Manwaring, Associate Deputy Minister, who spent time with the Secretariat team helping them to understand the history of FLNRORD and the sector's approach to integrated land management. While the orientation sessions will focus initially on FLNRORD, we will also be reaching out to the other natural resource sector ministries to better understand how the sector operates as a whole.

Finally, I am pleased to announce that Anna North will be joining the Secretariat Team today as our Project Manager. Anna comes from the Ministry of Agriculture, Food and Fisheries (MAFF). She has been with the BC Public Service at MAFF since February 2015 and had previously worked for the federal government. She has almost 20 years of leadership experience and team management under her belt. Her work experience includes mineral resource management (policy, legislation and operations) both in federal government and with the private sector. Welcome Anna!

Re: Ministry Re-organization

Dear Minister Conroy & Minister of State Cullen;

We understand that your government is planning to change the structure of the Ministry of FLNRO&RD, and that Minister of State Cullen is to

"bring forward a plan to create a new Ministry for Lands and Natural Resource Operations" – a quote from his mandate letter.

The Pemberton Wildlife Association(PWA) has worked closely with the Squamish FLNRO office in recent years to deal with various wildlife and outdoor recreational issues in the Pemberton area. We would like to compliment the District Manager and his staff for their efforts to deal with the concerns we have brought forward. As you are undoubtedly aware, our proximity to the population base of Vancouver,

along with the improvements to Highway 99, have brought a wave of outdoor recreational users to the Sea to Sky corridor. Unfortunately, the Provincial government was totally unprepared for this massive increase in usage and has been in a reactive state ever since.

The current FLNRO structural model was, as we understand it, intended to bring all the pertinent government staff "under one roof" – in an effort to improve the collaboration between what had been separate government departments. While many jobs were lost in the transition, once the new Ministry sorted things out it seemed to work quite well. We are not familiar with other Forest Districts, but here in the Sea to Sky corridor, we believe that the "model" has been working relatively well – thanks to the excellent leadership and staff at the District office.

Some of the recent local FLNRO accomplishments which we are grateful for include:

- the introduction of the Visitor Use Management planning process which is being used to address overcrowding problems in several key areas of the District
- the controls introduced on private helicopter biking charters
- the efforts to more carefully manage Adventure Tourism tenure holders operations
- the implementation of science based, seasonal motorized access controls to promote grizzly bear recovery in the Upper Lillooet River valley
- the implementation of key land use/access recommendations contained within the Sea to Sky Land and Resource Management Plan (2008).

The problems that we have noted with the Ministry were mainly related to a lack of staff.

No matter how the Ministry is re-organized, the Sea to Sky corridor has an urgent need for more staff – particularly Planners, Recreation Officers and Natural Resource Officers.

BC Parks is also woefully understaffed which has led to much concern about the way our Parks are being managed. We realize that BC Parks is in a different Ministry but feel that their staffing issues must also be considered when seeking solutions to the current dilemma.

We need "boots on the ground" to educate and manage the masses of people who are coming our way to enjoy the outdoors.

Guardian programs, perhaps in cooperation with local First Nations, re-storing the Conservation Corps or hiring Recreational Ambassadors may be alternative ways to deal with the lack of staff and compliment the Officers available.

In addition to the field staff, we'd also strongly recommend hiring at least one social media expert to ensure that our visitors are receiving accurate information on their preferred on-line devices.

The development of a recreational synopsis would also be an excellent tool to help educate outdoor recreational users in the Sea to Sky corridor.

The Secretariat is wrapping up its orientation sessions over the next couple of weeks. I want to thank you and your teams for the support you've shown the Secretariat team members. The information provide was very helpful in building the Secretariat's knowledge and understanding of the natural resource sector and provided early insights into the work of the natural resource sector itself. These orientation sessions have helped us to prepare for Phase I - the Assessment Phase. Attached you will find an Overview at a Glance of the Assessment Phase as well as a Timeline for Phases 1 - 3.

Phase 1 – the Assessment Phase will run from February 22 to mid-May. Key activities during this phase include:

Please provide a list of 3-5 excluded leaders in your organization that you would like to participate in these focus groups. Ideally, these people will have significant experience in your ministry and represent a cross section of your business. Similar questions asked in the Executive sessions will be canvassed in the Leadership Focus Group. Please provide the list to Sara Blackstock by February 24 so we can begin scheduling these sessions. The leadership focus group sessions will be two hours long and interview guides will be provided in advance. We are expecting to have completed the Executive Sessions and Leadership Focus Groups by the end of March.

The orientation sessions have already identified several topics that will require a deeper assessment. These topic areas will be further refined based on the Executive Session and Leadership Focus Groups and will inform a series of topic specific Deep Dive Session workshops to be undertaken in April. We expect these workshops to be interagency and may span multiple sessions. We will begin scheduling these workshops in early March.

Note that we are currently setting up an Intranet page for the Secretariat. This page will be a good resource for your staff to get updates on the Secretariat's work and frequently asked questions. Thank you in advance for your ongoing support for this important work, we look forward to hearing from you and your teams through this process.

Good question. A couple thoughts:

- I think we need to own a DRIPA implementation framework/plan/vision for incremental leg/policy changes over next 5 yrs, and how stewardship ( ~ESI/monitoring and assessment, LUP, Cumulative Effects etc), fits with ShDM and leg changes (baseline improvements for rising tide lifts all boats and S.7 consent/joint space). I am just not seeing that coherent plan, maybe folks are thinking about it but all my data points show really scattered thinking with big philosophical mis-alignments between different pockets of our ministry and with MIRR.
- I don't see how MIRR can invent the ShDM space without our input, or without an integrated leg/policy change plan on our end.
- Without us owning this vision we're going to get one offed on agreements by MIRR, with random leg/policy
  development chasing the agreements. I get/support the need for agreements to push the thinking and
  space, but we have to quickly backstop that with a solid vision that bridges these worldview divides.

Thanks James. Good to hear the feedback and especially the Ecosystem Biologist concerns about losing the connections they have made. That has been such a critical element of the integration. I hope we don't lose that in the process. We may need to think about inter-agency collaboration at a whole new scale.

On your first point about the research team, I was thinking about them before my staff call and to be honest I don't have a good answer. My instinct said I guess they would stay with Min of Forests but then thought we have done so much work to broaden the scope it doesn't make sense. Maybe we should move them into the best fit. In other words some stay with MoF and some go with LNRO and maybe some go to MOE, but that breaks up a highly functioning team and doesn't make sense either. My guess is Rick and John will see the researchers as a long tradition in MoF. I'd certainly like to hear your thoughts on what you think would be best. It would also be interesting to know what the researchers want but to do so without creating panic or expectations. That may be hard to do.

Greg I'd also really value your view on this.

Eamon thank you for this note, I've received great feedback from staff on your communications.

Two thoughts I wanted to share:

- 1. Several research staff have voiced concern to me regarding their future state, especially since research wasn't mentioned below. I know there is still so much uncertainty, but just a piece for awareness.
- 2. I had a staff call yesterday with our fish, wildlife and habitat teams to discuss uncertainties, change management, etc. Interesting comments I thought I'd share that came from several ecosystem biologists. As you may recall, 10 years ago there was significant concern with the biologists coming from MOE into Forests and the loss of identity, vision etc. I know this continues to be an issue in some of the regions provincially. One of these very same veteran biologists voiced concern yesterday given all of the relationships, collaborations, and most importantly benefits we currently have ongoing between our biologist, research and forestry business lines and concern regarding losing those and moving back to a silo. You spoke briefly yesterday regarding this, but from my view it was an interesting comment given how strong views were 10 years ago, and how through our hard work on integration those views have completely changed to see the benefits for the FLNRORD model.

Hi all,

Here is a summary from todays All Staff North Area call and the links to new Minister/functions documents I discussed on the call.

#### **COVID** and our Mental Health

- Week 2 of restrictions from the Provincial health officer and likely extended given the daily infection count. O
- North Area Principles "take care of each other first" and "apply flexibility to ensure staff well being".
- Return to office created some tension but also much optimism as low and careful levels of
  interaction started to increase. Return to the office was initiated due to concerns related to
  isolation and the mental well being of staff. Some data on the implications of isolation. The
  results are concerning. The report was prepared by "Corporate Services for the Natural
  Resource Ministries (CSNR) Prepared by People and Workplace Strategies November 2020 "
- This pandemic is having a prolonged and severe impact on the mental health and capacity of Canadians. The level of mental health in October...indicates that the working population is currently as distressed as the most distressed one percent of working Canadians prior to 2020."
- Mental Health and Demographics
- **Gender** for seven consecutive months, respondents who identified as female have had lower mental health scores than those who identified as male (-13.5 to -9.3, respectively). No other gender options were provided.
- Race Black and Arab/Middle Eastern/West Asian have had the lowest mental health scores (-19.5) and Whites have the highest mental health scores at -10.3 of respondents.
- Family Status individuals with at least one child have lower mental health scores than those without children.
- Age mental health scores improve with age, ranging from -22.2 in 20-29-year-olds to -5.1 in 60-69-year-old respondents.

- Location by Province, Newfoundland and Labrador has the highest score (-4.4) and Manitoba has the lowest score (-13.5). British Columbia currently has the fifth lowest mental health score (-11.1).
- • Income lower income have lower mental health scores than those with higher incomes.
- The top concern regarding mental health is related to finances (38%) followed by fear of getting ill with COVID-19 (34%) and fear of a loved one dying from COVID-19 (30%).
- The lowest average mental health score is among those who reported being lonely due to the COVID-19 pandemic.

In terms of finances while there may be less concern amongst public servants, this has a direct effect on many of those in our families or fiends and neighbors. Hopefully the stability of being in the public service provides some assurances.

#### Workplace related outcomes:

• Among those currently employed, 39% report ending the workday feeling mentally and/or physically exhausted. These individuals also have the lowest mental health score.

## The October Report states:

- 77% of respondents reported use of flexible work hours. Of these, 34% stated that flexible work hours improved productivity and their mental health while 6% say that flexible work hours reduce productivity and had lower mental health scores.
- Nearly 80% of respondents feel that their workplace is handling the health and safety risk of the pandemic well. These respondents have a higher mental health score (-8.6) than those who feel their workplace is handling the risks inconsistently or poorly.

#### **Key message:**

These are sobering outcomes. Increases the importance of taking care of one another. Sensitive to our colleagues. Clearly Covid is increasing stress among many of us and I ask all supervisors to continue to exercise flexibility and compassion. Take advantage of the sun when you can. Get outside and get some exercise when you can. We will get through this.

#### **New Minister(s), structure and mandate:**

- New Cabinet was announced on Nov 26<sup>th</sup>. There is always some anxiety when organization structure changes. Change can at first appear stressful but it usually does not have the downsides we imagine. This org change could have many benefits.
- John and Rick sent an email on Friday.
- See links below to Minister mandate letters, assignment of DM's and OICs and Ministry functions. These are also all on the web.
- Premier Horgan's media briefing following his Cabinet announcement. Establish a stand alone Min of Forests and creation of a new Ministry that is responsible for gov's land use policy.
- The basics.
  - New Minister is Minister Katrine Conroy and Minister of State (Nathan Cullen) and parliamentary secretary Rolly Russell.
  - Key announcement of the new Ministry is the role and function Minister of State
    Nathan Cullen to establish a new Ministry of Lands and Natural Resource Operations.
    Also there is the addition of fish to the Ministry of Agriculture.

- A few key considerations:
  - This org change is not about downsizing.
  - Most of our work will not change. If anything it may allows us to be more effective.
  - In change like this there is always an opportunity to make things better
  - This is an exceptional opportunity to influence how that structure looks. We have been given time and some influence on the creation of the new Ministry. That really shows how this gov trusts the public service.

#### What we know:

- So we will have 2 ministries. One that is a stand alone Min of Forests. And a new Ministry of Lands and Natural Resource Operations that will be focussed on land use policies, which sounds like land use planning etc or what I would envision as the strategic elements of resource management. However it also includes an operational component. That may well be the lands and water permitting, and fish and wildlife allocation and habitat protection GIS etc. WE don't know yet. It will take a year to finalize.
- So why is government making this change? I believe there are pressing reasons. For those of you that saw the Premiers media event following the Cabinet announcement you heard Premier Horgan say that FLNRO's size was just unwieldy. He has a very good point. I see this as a great opportunity to deal with some of the long standing challenges we've had. While I have been a strong proponent of the integrated FLNRO model, I've also come to see its limitations. Some of those are personal and some are organizational. FLNRO was too big to get the breadth of organizational direction we required. We saw that in our responses to the WES survey. The vision, mission goals were too broad and did not resonate clearly with all staff. By creating 2 different Ministries with more precise visions that resonate with staff we will be more effective. We will have a ministry of Forests that can focus on transitioning the forestry sector from a high volume forestry to high value forestry. We were also in desperate need for policy direction on a large variety of emerging issues and that direction was hard to get. We have not been agile enough to respond quickly to the emerging challenges we have been faced with ... and this has left staff without clarity of purpose. The Minister had to cover a dizzying array of topics in a day. To be blunt so did the DMs, ADMs and REDs. With the breadth of responsibilities I don't think we were providing the necessary support and guidance. We were too slow. If we did not make this change now I believe we would have missed the opportunity to make substantive progress on some critically pressing issues.
- Having said that; the creation of FLNRO was critical to getting agencies out of their silos
  and integrating our work. All the connections made are incredibly important and we can't
  lose that. We will still need to make those linkages but at least now we will have more
  political and executive focus.
- So work begins next week. Rick is meeting with Lori Halls on Wednesday to begins the work of creating two Ministries. You could not ask for a better person. Rick has an incredible depth of understanding on the work we do and he will always have the people of the organization front and centre. Potentially a corporate agency that does much of its work on behalf of the natural resource ministries. It will take a year. Options sorted by April and approved in the fall. Maybe quicker we will see what Minister Cullen wants. Maybe we can do it faster.
- Ministry of Agriculture, Food and Fisheries. We knew this was a possibility. The addition to ag will be policy focussed.. All fish allocation, habitat management, inventory etc stays with FLNRO. Perhaps into the new Ministry. We think that is wise. Why did they create a fish policy element inside agriculture? They want to put greater emphasis on the file and make a deeper connection with Canada on the policy side particularly as it relates to salmon.

#### Key message:

So the key in all of this truly is to take a deep breadth, remind ourselves of the benefits of this new proposed org structure and think about how it could make things better. I commit to you that as I know things I will pass them quickly on to the REDs etc to ensure you are all staying up to date. There may be occasions when some of you may be asked to help in the design of the new org and I encourage to take advantage of that opportunity if it arises.

Thanks for all the questions and insights you provided on Pigeon Hole. It really helps me understand what matter most to you.

# **Executive Update**

Hello FLNRORD Staff,

With the support of Minister Conroy, and as part of Minister Cullen's mandate deliverables, the Premier has asked that a plan be brought forward to create a new Ministry for Lands and Natural Resource Operations. This new ministry will develop and implement land use policies that support B.C.'s goals for economic activity, environmental sustainability and reconciliation with Indigenous peoples. Creating options for government on what this new organization could look like and how it integrates with other ministries is the focus of the Secretariat's work. This is what I want to update you on today.

Ninety-four percent of British Columbia's land base is Crown land. Land use issues have become more challenging and more complex. There are no easy decisions left to be made. Modernizing land use policies to address our current and future context (climate change, competing interests, changing industries, etc.) is necessary and, in many cases, transformative. We must ensure that efficient and effective organizational structures are in place in order to support an integrated approach across the land base. This will be key to achieving our economic, social and reconciliation goals.

The Ministry of Forests, Lands and Natural Resource Operations was established in 2011; Rural Development became part of the ministry in 2017. FLNRORD was created to better integrate natural resource activities and decisions across the province. FLNRORD's work is inextricably linked to the natural resource sector as a whole, and integration must continue. Given our changing landscape, we've been asked to determine whether the organizational structures built over the past ten years are set up for us to be successful in the future.

Essentially, we are asking the question: Can land use objectives that support economic activity, environmental sustainability, and reconciliation with Indigenous peoples be more effectively achieved through restructuring?

The Lands and Natural Resource Operations Secretariat has been established to undertake this work. Each natural resource sector ministry is contributing resources to this initiative and will have a voice on the Secretariat as the work progresses.

The Secretariat will be thoughtful and inclusive in its approach. Normally, organizational restructuring like this would happen behind closed doors; however, our approach will be much more transparent, and I will be providing you with monthly updates on our progress.

The Secretariat is developing design principles, and we will complete our work in three phases:

- Assessment (Diagnosis)
- Design (Options Development and Direction)
- Implementation

We will undertake the <u>Assessment Phase</u> between February and May 2021. It will involve extensive internal and external engagement in order to understand both the challenges and opportunities within the natural resource sector. Alongside regular engagement with the Deputy Ministers and Assistant Deputy Ministers' Committees on Natural Resource Sector, we are planning to conduct interviews and focus groups with a cross-section of staff from the natural resource sector.

Following the Assessment Phase, the Secretariat will initiate the <u>Design Phase</u>, developing options for government on what a new ministry or organization focused on Lands and Natural Resource Operations could look like. We anticipate seeking direction on any restructuring in Fall 2021. The <u>Implementation Phase</u> would follow direction, which we anticipate for completion in Spring 2022. I will have more to say on all three phases in the coming weeks and months.

As part of the Secretariat team's orientation to the sector, Secretariat staff will be meeting with many FLNRORD staff to better understand the ministry's business and its evolution. These orientation sessions kicked off recently with Rick Manwaring, Associate Deputy Minister, who spent time with the Secretariat team helping them to understand the history of FLNRORD and the sector's approach to integrated land management. While the orientation sessions will focus initially on FLNRORD, we will also be reaching out to the other natural resource sector ministries to better understand how the sector operates as a whole.

Finally, I am pleased to announce that Anna North will be joining the Secretariat Team today as our Project Manager. Anna comes from the Ministry of Agriculture, Food and Fisheries (MAFF). She has been with the BC Public Service at MAFF since February 2015 and had previously worked for the federal government. She has almost 20 years of leadership experience and team management under her belt. Her work experience includes mineral resource management (policy, legislation and operations) both in federal government and with the private sector. Welcome Anna!

#### **Dear Colleagues:**

The Secretariat is wrapping up its orientation sessions over the next couple of weeks. I want to thank you and your teams for the support you've shown the Secretariat team members. The information provide was very helpful in building the Secretariat's knowledge and understanding of the natural resource sector and provided early insights into the work of the natural resource sector itself. These orientation sessions have helped us to prepare for Phase I - the Assessment Phase. Attached you will find an Overview at a Glance of the Assessment Phase as well as a Timeline for Phases 1 - 3.

Phase 1 – the Assessment Phase will run from February 22 to mid-May. Key activities during this phase include:

- 1. one on one executive interviews with Deputy Ministers and Executives (Executive Sessions 1 hour scheduled February 22 – March 5)
- 2. followed by deeper engagement with Leadership Focus Groups (2 hours scheduled March 11 March 30), and finally
- 3. Deep Dive workshops on important themes (depending on the topic there may be 1-3 half-day sessions scheduled April 8 - April 27), as needed.

The Secretariat will be contacting your offices to schedule time for your one on one Executive interviews. We are asking to meet you without other staff present. This will be an hour long session where we will be seeking your perspective on what has been working well within the natural resource sector and where you see opportunities and challenges. While some of these suggestions may have surfaced as part of the orientation sessions, these 1:1 Executive Sessions will ensure all perspectives are heard and have been consistently canvassed across the sector.

Please find a copy of the interview questions that will be asked in the Executive Session. We ask that you come prepared to speak to each. The comments and feedback will not be attributed to individual participants.

We also would like your advice on who should be participating in the Leadership Focus Groups. Please provide a list of 3-5 excluded leaders in your organization that you would like to participate in these focus groups. Ideally, these people will have significant experience in your ministry and represent a cross section of your business. Similar questions asked in the Executive sessions will be canvassed in the Leadership Focus Group. Please provide the list to Sara Blackstock by February 24 so we can begin scheduling these sessions. The leadership focus group sessions will be two hours long and interview guides will be provided in advance. We are expecting to have completed the Executive Sessions and Leadership Focus Groups by the end of March.

The orientation sessions have already identified several topics that will require a deeper assessment. These topic areas will be further refined based on the Executive Session and Leadership Focus Groups and will inform a series of topic specific Deep Dive Session workshops to be undertaken in April. We expect these workshops to be interagency and may span multiple sessions. We will begin scheduling these workshops in early March.

Note that we are currently setting up an Intranet page for the Secretariat. This page will be a good resource for your staff to get updates on the Secretariat's work and frequently asked questions. Thank you in advance for your ongoing support for this important work, we look forward to hearing from you and your teams through this process.

Following several weeks of orientation sessions, the Lands and Natural Resource Operations Secretariat (the Secretariat) has initiated Phase I – the Assessment Phase. Attached you will find an Overview at a Glance of the Assessment Phase.

The Assessment Phase will run to mid-May. Key activities during this phase include:

# Meeting with Regional Chief Terry Teegee

Regional Chief Terry Teegee (Takla Lake First Nation) was first elected as BC Assembly of First Nations (BCAFN) Regional Chief in 2017 and was re-elected for a second three-year term in November 2020. Regional Chief carries the responsibilities of the hereditary name of Maxweeum Tsimghee. He is a graduate of the University of Northern British Columbia with a Bachelor of Science degree in Forestry and has a diploma in Forestry Technology from the College of New Caledonia.

Regional Chief Teegee has served in elected positions including Tribal Chief of the Carrier Sekani Tribal Council (2012 to 2018), and the BC Representative for the National Aboriginal Forestry Association (2008 to 2014). He was appointed to the Fraser Basin Council Board, an advocacy group that promotes sustainability in the Fraser River Basin, from 2009 to 2018. Regional Chief Teegee was one of 250 participants selected from across the country to participate in the 2017 Canadian Governor General's Leadership Conference.

#### **Background:**

- The BCAFN is the regional entity of the pan-Canadian Assembly of First Nations and advocates for treaty and non-treaty First Nation interests but does not represent Metis or Innuit issues.
- They are typically explicit in articulating that they do not have the authority to speak for the Rights and Title holders, and only advocate on their behalf.
- The BCAFN is one of the three organizations that makes up the First Nations Leadership Council (FNLC), alongside the Union of BC Indian Chiefs (UBCIC) and the First Nations Summit. The organizations exist independently from one another but often co-ordinate under the umbrella of the FNLC.
- The BCAFN articulates their mandate as the following:
  - o Advance the rights and interests of First Nations people in British Columbia;
  - Restore and enhance the relationship among First Nations in British Columbia, the Crown and people of Canada;
  - Develop and promote policies and resources for the benefit of First Nations in British Columbia including but not limited to governance, lands and resources, economic, social, education, health and cultural matters;
  - Work in coalition with other organizations that advance the rights and interests of First Nations peoples; and
  - Take direction from the Chiefs-in-Assembly according to the resolutions passed at Assemblies.
- The Ministry primarily works with the BCAFN through the FNLC including two working groups:
  - Joint Core Working Group (JCWG).
  - Forestry Sub-Committee of the Joint Core Working Group.
- The Province also works with the BC Assembly of First Nations through various arrangements with First Nation Organizations that have been established under the direction of the FNLC this includes but is not limited to;
  - First Nations Energy and Mining Council
  - First Nations Forestry Council
  - o First Nations Fisheries Council

- The Forestry Subcommittee is a legislative and policy review table focussed on the alignment of the Declaration Act to priority forestry legislative, policy and practice barriers that are systemic obstacles to reconciliation.

#### 3. Wildlife

#### **Hunting Regulations:**

- The Minister responsible for the Wildlife Act has the authority to make hunting regulations to
  ensure the conservation of wildlife and wildlife habitat, safe and sustainable use of wildlife
  populations after Indigenous and treaty rights are accounted for, and to maintain/enhance
  recreational opportunities (e.g., season dates and bag limits, motor vehicle
  prohibitions/restrictions, trapping, etc.).
- Regulations are updated on a two-year cycle to ensure issues and opportunities are addressed in a timely manner. The current suite of hunting regulations is in effect until June 30, 2022.
- Hunting regulations are informed through consultation and engagement with First Nations, as well as hunting/trapping stakeholders, and engagement with the general public.

#### Species at Risk:

- For the majority of species and ecosystems at risk, BC works with Indigenous peoples at a regional level regional biologists build relationships and work with communities within local areas. This leads to variations in collaborative approaches across the province.
- Several 'priority' species are managed by the Species at Risk and Recovery (SARR) branch including:
  - Whitebark and Limber pine includes a working group with indigenous representation from McLeod Lake Indian Band, Ktunaxa, Lower Similkameen Indian Band, and Lillooet Indian Band.
  - 2. Northern Goshawk and Marbled Murrelet consultation with south coast communities and the initial stages of discussion with Haida regarding self or co-management.
  - 3. Interior Fisher –the province will be reaching out to Nations shortly, whose territories overlap Fisher habitat to identify where there is interest in discussion and collaboration on Fisher recovery.
  - 4. Caribou Section 11 agreement various different models for engagement/collaboration (further info below)
- Priority Places is a project funded by federal and provincial governments in low valley/ grassland areas of the south coast and southern interior. Projects in the Fraser valley and Okanagan have been working collaboratively with Indigenous peoples toward knowledge sharing and conservation actions for shared priority species in and around traditional territories.

#### Caribou:

- Canada and BC are each a party to a Section 11 agreement for the recovery of Southern
  Mountain Caribou (SMC). Section 11 refers to a section of the federal Species at Risk Act, which
  enables the federal Minister of Environment to enter into an agreement with a party for the
  purpose of collaborating on the recovery of a listed species at risk. The Section 11 agreement
  contains provisions on how the parties will allocate resources, share data, collaborate in
  resolving issues, and engage with Indigenous Nations, among other things.

#### **Indigenous Forest Bioeconomy Program:**

- The Indigenous Forest Bioeconomy program provides another platform for Indigenous opportunities in the natural resource sector by responding to a community's interests and needs through collaboration and partnerships.
- Through this program FLNRORD collaboratively identifies and pursues forest bioeconomy
  projects with Indigenous partners across B.C. Projects range from non-timber forest products
  such as the extraction of essential oils from conifer needles, to advanced biomaterials such as
  non-woven medical textiles produced from cedar, to biochemicals such as tannins extracted
  from bark.
- Projects have numerous environmental, economic, social and cultural benefits. By utilizing
  forest biomass and residuals from conventional harvesting for novel high-value applications,
  the program supports forest sector transformation with full participation of Indigenous
  peoples.

#### 2. Old Growth:

- In July 2019, government appointed panel members Garry Merkel and Al Gorley to lead an old-growth strategic review. They gathered input and examined old-growth management from a variety of perspectives. On April 30, 2020, they submitted 14 recommendations to the Province in their report.

# Lori Halls Deputy Minister Lands and Natural Resource Operations Secretariat



#### Hello FLNRORD Staff,

With the support of Minister Conroy, and as part of Minister Cullen's mandate deliverables, the Premier has asked that a plan be brought forward to create a new Ministry for Lands and Natural Resource Operations. This new ministry will develop and implement land use policies that support B.C.'s goals for economic activity, environmental sustainability and reconciliation with Indigenous peoples. Creating options for government on what this new organization could look like and how it integrates with other ministries is the focus of the Secretariat's work. This is what I want to update you on today.

Ninety-four percent of British Columbia's land base is Crown land. Land use issues have become more challenging and more complex. There are no easy decisions left to be made. Modernizing land use policies to address our current and future context (climate change, competing interests, changing industries, etc.) is necessary and, in many cases, transformative. We must ensure that efficient and effective organizational structures are in place in order to support an integrated approach across the land base. This will be key to achieving our economic, social and reconciliation goals.

The Ministry of Forests, Lands and Natural Resource Operations was established in 2011; Rural Development became part of the ministry in 2017. FLNRORD was created to better integrate natural resource activities and decisions across the province. FLNRORD's work is inextricably linked to the natural resource sector as a whole, and integration must continue. Given our changing landscape, we've been asked to determine whether the organizational structures built over the past ten years are set up for us to be successful in the future.

Essentially, we are asking the question: Can land use objectives that support economic activity, environmental sustainability, and reconciliation with Indigenous peoples be more effectively achieved through restructuring?

The Lands and Natural Resource Operations Secretariat has been established to undertake this work. Each natural resource sector ministry is contributing resources to this initiative and will have a voice on the Secretariat as the work progresses.

The Secretariat will be thoughtful and inclusive in its approach. Normally, organizational restructuring like this would happen behind closed doors; however, our approach will be much more transparent, and I will be providing you with monthly updates on our progress.

The Secretariat is developing design principles, and we will complete our work in three phases:

- Assessment (Diagnosis)
- Design (Options Development and Direction)
- Implementation

We will undertake the <u>Assessment Phase</u> between February and May 2021. It will involve extensive internal and external engagement in order to understand both the challenges and opportunities within the natural resource sector. Alongside regular engagement with the Deputy Ministers and Assistant Deputy Ministers' Committees on Natural Resource Sector, we are planning to conduct interviews and focus groups with a cross-section of staff from the natural resource sector.

Following the Assessment Phase, the Secretariat will initiate the <u>Design Phase</u>, developing options for government on what a new ministry or organization focused on Lands and Natural Resource Operations could look like. We anticipate seeking direction on any restructuring in Fall 2021. The <u>Implementation Phase</u> would follow direction, which we anticipate for completion in Spring 2022. I will have more to say on all three phases in the coming weeks and months.

As part of the Secretariat team's orientation to the sector, Secretariat staff will be meeting with many FLNRORD staff to better understand the ministry's business and its evolution. These orientation sessions kicked off recently with Rick Manwaring, Associate Deputy Minister, who spent time with the Secretariat team helping them to understand the history of FLNRORD and the sector's approach to integrated land management. While the orientation sessions will focus initially on FLNRORD, we will also be reaching out to the other natural resource sector ministries to better understand how the sector operates as a whole.

Finally, I am pleased to announce that Anna North will be joining the Secretariat Team today as our Project Manager. Anna comes from the Ministry of Agriculture, Food and Fisheries (MAFF). She has been with the BC Public Service at MAFF since February 2015 and had previously worked for the federal government. She has almost 20 years of leadership experience and team management under her belt. Her work experience includes mineral resource management (policy, legislation and operations) both in federal government and with the private sector. Welcome Anna!

## **Executive Update**





#### Hello FLNRORD Staff,

With the support of Minister Conroy, and as part of Minister Cullen's mandate deliverables, the Premier has asked that a plan be brought forward to create a new Ministry for Lands and Natural Resource Operations. This new ministry will develop and implement land use policies that support B.C.'s goals for economic activity, environmental sustainability and reconciliation with Indigenous peoples. Creating options for government on what this new organization could look like and how it integrates with other ministries is the focus of the Secretariat's work. This is what I want to update you on today.

Ninety-four percent of British Columbia's land base is Crown land. Land use issues have become more challenging and more complex. There are no easy decisions left to be made. Modernizing land use policies to address our current and future context (climate change, competing interests, changing industries, etc.) is necessary and, in many cases, transformative. We must ensure that efficient and effective organizational structures are in place in order to support an integrated approach across the land base. This will be key to achieving our economic, social and reconciliation goals.

The Ministry of Forests, Lands and Natural Resource Operations was established in 2011; Rural Development became part of the ministry in 2017. FLNRORD was created to better integrate natural resource activities and decisions across the province. FLNRORD's work is inextricably linked to the natural resource sector as a whole, and integration must continue. Given our changing landscape, we've been asked to determine whether the organizational structures built over the past ten years are set up for us to be successful in the future.

Essentially, we are asking the question: Can land use objectives that support economic activity,

environmental sustainability, and reconciliation with Indigenous peoples be more effectively achieved through restructuring?

The Lands and Natural Resource Operations Secretariat has been established to undertake this work. Each natural resource sector ministry is contributing resources to this initiative and will have a voice on the Secretariat as the work progresses.

The Secretariat will be thoughtful and inclusive in its approach. Normally, organizational restructuring like this would happen behind closed doors; however, our approach will be much more transparent, and I will be providing you with monthly updates on our progress.

The Secretariat is developing design principles, and we will complete our work in three phases:

- Assessment (Diagnosis)
- Design (Options Development and Direction)
- Implementation

We will undertake the <u>Assessment Phase</u> between February and May 2021. It will involve extensive internal and external engagement in order to understand both the challenges and opportunities within the natural resource sector. Alongside regular engagement with the Deputy Ministers and Assistant Deputy Ministers' Committees on Natural Resource Sector, we are planning to conduct interviews and focus groups with a cross-section of staff from the natural resource sector.

Following the Assessment Phase, the Secretariat will initiate the <u>Design Phase</u>, developing options for government on what a new ministry or organization focused on Lands and Natural Resource Operations could look like. We anticipate seeking direction on any restructuring in Fall 2021. The <u>Implementation Phase</u> would follow direction, which we anticipate for completion in Spring 2022. I will have more to say on all three phases in the coming weeks and months.

As part of the Secretariat team's orientation to the sector, Secretariat staff will be meeting with many FLNRORD staff to better understand the ministry's business and its evolution. These orientation sessions kicked off recently with Rick Manwaring, Associate Deputy Minister, who spent time with the Secretariat team helping them to understand the history of FLNRORD and the sector's approach to integrated land management. While the orientation sessions will focus initially on FLNRORD, we will also be reaching out to the other natural resource sector ministries to better understand how the sector operates as a whole.

Finally, I am pleased to announce that Anna North will be joining the Secretariat Team today as our Project Manager. Anna comes from the Ministry of Agriculture, Food and Fisheries (MAFF). She has been with the BC Public Service at MAFF since February 2015 and had previously worked for the federal government. She has almost 20 years of leadership experience and team management under her belt. Her work experience includes mineral resource management (policy, legislation and operations) both in federal government and with the private sector. Welcome Anna!
