Trish may find the high-level summary below useful. I am also attaching a Key-Messages document that Meggin's team has prepared if Trish would like more details.

- 2-Billion Trees Federal Program Overview:
- December 2019: The federal throne speech signalled the Government of Canada's intention to plant 2 billion trees to "clean the air and make our communities greener".
- September 23, 2020: Speech from the throne re-iterated this commitment.
- November 30, 2020: At the Federal Fiscal Update, Canada proposed to provide up to \$3.16 billion, over ten years, starting in 2021-22, to Natural Resources Canada to partner with provinces, territories, non-governmental organizations, Indigenous communities, municipalities, and others to plant 2 billion trees.
- Canada's objective is to increase the level of tree planting across Canada; therefore, program focus is expected to be on incremental planting above a baseline.
- o Canada's intentions for the 2 billion tree program are understood to be broader than reforestation on provincial crown land, and to include private lands, urban areas and Indigenous communities.
- o Tree planting funded through long-standing provincial programs may be eligible where it exceeds levels that would be expected in the absence of federal funding. These levels would be determined during program negotiations. o Reforestation by industry following harvest, will not be eligible.
- This initiative aligns with BC Government's commitment to plant more trees and make significant investments in forest health, wildfire protection and silviculture.

- The Office of the Chief Forester is the lead for BC.

BC's Capacity to Support 2-Billion Trees Program:

- FLNR is working with key partners to scope out B.C.'s capacity to support this Federal program:
- o With local governments, through the Union of BC Municipalities, to expand tree planting opportunities to urban forests.
- o With Ministry of Agriculture, to identify tree planting opportunities on farmlands, to develop opportunities for other tree-based natural solutions in agriculture.
- o With industry to ensure capacity in nurseries, seed supply, and planting contractors is available to meet the demands of any new program.
- o With Ministry of Environment and Climate Change Strategy to ensure reforestation is recognized both a key climate change mitigation and adaptation tool in British Columbia.
- FLNR is also Considering how the province can support Indigenous engagement in this program, through reviewing our recent work with Indigenous nations.
- Through federal support from the Low Carbon Economy Leadership Fund (LCELF), the province has scaled up its Crown land reforestation programs.
- The expertise, capacity and partnerships that have been developed can bridge to the new federal commitment, ensuring that industry, communities, and other key partners are not impacted by a gap in planting demand while the 2-Billion Trees program get established.

#### **Estimated Costs:**

- The program will likely include a federal recovery component but recovery percentage to be confirmed (LCELF is at 50% recovery).
- B.C. is planting trees on crown lands at a cost of \$1.20 per tree (excluding program overhead and based on current market conditions).

- If a higher planting level would be needed, the annual planting cost would increase proportionally and additional costs for infrastructure improvements to tree seedling nurseries and tree seed orchards would be required to meet the increased demand.
