Attached are three reports that touch on issues Stand.earth is bringing to the attention of the Canadian federal government, primarily the Ministry of Transport. We would welcome the opportunity to discuss these matters and policy solutions with you.

The attached report released in February of 2020, authored by the International Council on Clean Transportation (ICCT) provides groundbreaking new analysis on the use of Liquefied Natural Gas (LNG) as a marine fuel. LNG is primarily methane, a greenhouse gas that traps 86 times more heat in the atmosphere than the same amount of CO₂ over a 20-year timeframe. This report examines a previously poorly understood source of fugitive methane emissions from ship engines. It found that the most popular LNG ship engine leads to 70% - 82% more lifecycle greenhouse gas (GHG) emissions compared to the cleanest fuel currently available, marine gas oil (MGO).

Global shipping is already responsible for 3% of global carbon emissions. If it were a country, it would be the world's sixth largest GHG emitter. A 2015 European Union study, done before the new understanding of fugitive methane emissions from ship engines, showed that under a business-as-usual pathway, shipping would be responsible for a staggering 17% of global GHG emissions by 2050.

The ICCT report was submitted to the United Nations International Maritime Organization (IMO), which then used this new methodology in its analysis for the final report of the Fourth IMO Greenhouse Gas Study. The UN body found that methane emissions from the shipping sector increased by 150% between 2012 and 2018.

The Intergovernmental Panel on Climate Change has stated that methane emissions must be reduced by 35% *or more* from 2010 levels by 2050 if a 1.5 °C target is to be met. Investments to support the use of LNG as a marine fuel, including increased fracking and building LNG bunkering infrastructure, makes neither economic nor scientific sense. The use of LNG must be phased out to meet our climate commitments, not expanded.

The second attached report examines the enormous volumes of water pollution from the multiple cruise ship waste streams that are dumped along the BC coasts, directly into the critical habitat of Southern Resident Killer Whales. These waste streams include sewage, greywater, and the contaminated washwater from Exhaust Gas Cleaning Systems, also known as scrubbers.

This analysis found that had cruise ships been permitted to travel the normal seasonal routes up the BC coast this summer, the ships would have dumped a staggering 31 billion litres of scrubber washwater, 1.8 billion litres of greywater, and 220 million litres of sewage. This enormous volume of untreated and poorly treated water pollution would have been permissible under the current, weak Canadian regulations, whereas Puget Sound and Alaskan waters are protected under no discharge zones and strict regulations and monitoring schemes.

Sewage and greywater are waste streams that are laden with excess nutrients, soap, oil and grease, and prescription drugs. These can promote algal blooms and oxygen-depleted marine deadzones that suffocate fish. Prescription drug and personal care products can have longer term impacts on fish fertility and health.

Scrubbers enable cruise operators to comply with more stringent sulphur pollution regulations while continuing to burn the cheapest and dirtiest fossil marine fuel available, heavy fuel oil. These systems are only permitted due to a loophole in the regulations. Scrubber washwater is laden with heavy metals and polycyclic aromatic hydrocarbons (PAHs) that can persist in the environment, bioaccumulate up the food web, and accumulate in sediment. PAHs are carcinogenic compounds that have also been demonstrated to affect red blood cells, the immune system, and can produce reproductive, neurologic, and developmental effects. Human exposures to these toxins can occur as contaminants are introduced into our seafood, such as salmon, herring, and filter feeders like clams, mussels, or scallops.

If and when cruise ships are permitted to return to Canada's waters, these vessels must not be allowed to continue dumping and exploiting the scrubber loophole. We must put the protection of public health and the health of the marine environment, including threatened and endangered species, before the cruise industry interests and profits.

The third analysis attached was authored by the ICCT and commissions by Environment and Climate Change Canada in November of 2020, and looks more in depth at scrubber usage and the regulations that apply. According to the report, scrubbers lower sulfur dioxide emissions but other emissions were increased, specifically those of carbon dioxide, particulate matter, nitrogen oxides, and black carbon when using cheap fuel with a scrubber compared with ships that switched fuels. This illustrates the potential impacts of scrubbers on air quality in port and coastal communities.

The study also finds that the ocean pollution generated by these systems, i.e. washwater, bleed-off, and sludge, was often in compliance with the weak regulations that exist, which are not science-based standards, all the while containing unsafe levels of heavy metals and other toxins. Heavy metals and many PAHs do not biodegrade and instead collect in the food web. This makes these pollutants serious problems for the health of endangered mammals such as Southern Resident Killer Whales, coastal communities that depend on the ocean as a source of protein and food, and aquaculture operations that depend on clean waters to grow in.


