Paul/Bill,

BCWS will require safe access for our crews, which includes Dave and his crew. Danger tree falling will be required along the FSR. We plan on sending out a Faller Coordinator to work with Dave and his fallers today. Our Operations Section Chief talked to Dave last night and is meeting with him on site today.

As you are aware, damaged infrastructure such as bridges can be addressed in the Rehabilitation Plans that you will complete for the fires in your District.

Resources have been stretched to the limit across Canada and the western USA. We are now getting additional support from other Provinces in Canada. We anticipate sending crews out to support Dave soon. The 2<sup>nd</sup> IMT did not show up until Monday so I am not clear as to Dave's reference about the "new" IMT. The first IMT had been here for around a week and a half by Saturday.

Hi Paul,

I hope you are well. I have a question regarding the FSRs and fires that have destroyed our licence up the Gorge. Once we are allowed back up on the Gorge, who is responsible for sanitizing the FSR after the fire went through. We had started doing this work on the Gorge and have it cleaned up from 22-26km but BCWS has instructed us to cease operations. The fire has burned to at least 33km as of today but the Hunakwa fire burned from 38-42 and there is a good chance the 4 Mile fire will still burn from 33 to 38km. This means there could be another 16km to sanitize and it all has to be done with hand fallers and equipment. If BCWS does not let us continue with this important work and they eventually leave or walk away, who pays for this work? Who also pays to repair the bridges if there is fire damage? Does it get charged to BCWS? I should add that there are no BCWS personnel on the Gorge side fire, we proceeded with works approved by the Vernon Fire Center and we were making good progress in key areas until the new IMT shut us down Saturday.
