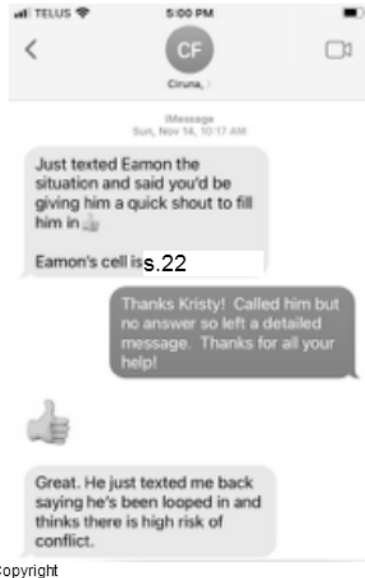
It is my understanding there is currently a blockade at 39 km on the Morice River Road. Please continue to avoid this area for the time being.
