Hi Adam,

Some species at risk and conservation document background and the answers to your three questions, below:

Oldgrowth specklebelly (*Pseudocyphellaria rainierensis*) lichen is listed as Special Concern in the federal *Species at Risk Act* (SARA) and is not listed in any provincial legislation. As such, there is no federal or provincial legal tool or ministerial authority available to protect this species. Under the federal SARA there are legal tools to conserve and recover species listed as Threated or Endangered. Provincial legal tools for species at risk are limited to species listed in the *Forest and Range Practices Act* (FRPA) and the *Wildlife Act*. Presently lichen is not legally considered wildlife in any provincial legislation and as such no legal tools are available to protect individuals of this species nor its habitat. This species may occur in wildlife habitat areas in and around TFL46 and would therefore be protected under umbrella species such as northern goshawk, marbled murrelet and coastal tailed frog.

The provincial/federal management plan for Oldgrowth Specklebelly lichen (2017) is a jointly developed document containing recommended conservation actions intended to prevent this species from becoming threatened or endangered across the species range in BC. Conservation and recovery documents such as management plans and recovery plans are developed and published as *science advice* and are not legal conservation action commitments.

### In answer to your specific questions:

- 1. Were comprehensive biodiversity surveys done prior to allowing road construction and logging in TFL 46 and are comprehensive species surveys ever carried out prior to clearcutting, road-building and other forestry operations? Comprehensive biodiversity and species surveys are not required prior to clearcutting, road-building and other forestry operations. Licensees cannot be issued permits for forestry operations until a Forest Stewardship Plan is approved by a district manager. The Forest Stewardship Plan includes biodiversity values that must be met, at a landscape level, by the licensee. As you know, the Province operates under a Professional Reliance model and as such, it is the responsibility of the licensee to ensure that a professional (Registered Professional forester in this case) is involved and has the expertise to ensure harvest operations meet the objectives and stipulations of the Forest Stewardship Plan.
- 2. Given the published commitment to protect the species and its habitat, will you immediately protect these rare lichens and host trees? As described above, a Management Plan is not published commitments by government to protect a species or it's habitat, but is published *science advice* on the steps necessary to prevent the species from becoming threatened or endangered. This lichen is not listed in federal nor provincial legislation and as such cannot be specifically managed.
- 3. How do the proposed amendments to FRPA ensure that endangered species are identified and protect prior to logging or road construction and, if at-risk species or ecosystems are found during these surveys, will logging or road-building be halted in the relevant areas? The proposed FRPA amendments do not speak directly to endangered

species. There are no legal tools that prevent harvesting in areas where species at risk occur on crown land, outside of Identified Wildlife Management areas, parks and ecological areas.

I am writing today with respect to a species of concern and logging activity. I am not sure if this situation has been brought to your attention previously, however I have been contacted by a number of individuals with respect to Old Growth Specklebelly Lichen, a species of Special Concern according to COSEWIC.

As I understand it, British Columbia is home to the only remaining occurrences of this rare species in Canada. Volunteer citizen scientists and biologists recently identified what may be Canada's largest stand of host trees, located near Fairy Creek on Vancouver Island. The stand had been damaged by logging road construction, and a number of host trees were lost.

Those citizens followed due process, and submitted a formal complaint to the Forest Practices Board in July, 2021. They then received (August 5th) a written correspondence from Teal Cedar who stated "The information you provided to the FPB, including locations of the sightings has been forward to us and we would like to thank you for providing this important information". In a follow-up correspondence, the citizens then asked Teal Cedar what plans they had to protect the remaining host trees and remediate the damage from road construction but received no response. Incredibly, cutting has in fact resumed, and at least 19 more host trees have been lost as of November 2nd.

BC and Canada have published a plan in 2017 to conserve and recover this species, and it includes a commitment to "secure long-term protection for the known populations and habitats of oldgrowth specklebelly".

I have three questions that I hope will allow be to better understand the situation and your authority to protect this species.

- 1. Were comprehensive biodiversity surveys done prior to allowing road construction and logging in TFL 46 and are comprehensive species surveys ever carried out prior to clearcutting, road-building and other forestry operations?
- 2. Given the published commitment to protect the species and its habitat, will you immediately protect these rare lichens and host trees?
- 3. How do the proposed amendments to FRPA ensure that endangered species are identified and protect prior to logging or road construction and, if at-risk species or ecosystems are found during these surveys, will logging or road-building be halted in the relevant areas?

Oldgrowth Specklebelly Lichen is listed as special concern in the federal *Species at Risk Act* (SARA) and is not listed in any provincial legislation. Under the federal SARA, there are legal tools to conserve and recover species listed as threatened or endangered. In addition, provincial legal tools for species at risk are limited to species listed in the *Forest and Range Practices Act* (FRPA) and the *Wildlife Act*. As such, there is no federal or provincial legal tool or ministerial authority available to specifically protect this species.

However, Oldgrowth Specklebelly Lichen may occur in wildlife habitat areas in and around Tree Farm Licence 46 and would therefore be indirectly protected under umbrella species such as northern goshawk, marbled murrelet, and coastal tailed frog.

The provincial/federal management plan for Oldgrowth Specklebelly Lichen (2017) is a jointly developed document containing recommended conservation actions intended to prevent this species from becoming threatened or endangered across the species range in BC. Conservation and recovery documents such as management plans and recovery plans are developed and published as advice; they are not commitments made by the Province.

With regards to comprehensive biodiversity and species surveys, they are not required prior to clearcutting, road-building and other forestry operations. However, licensees cannot be issued permits for forestry operations until a Forest Stewardship Plan is approved by a district manager. The Forest Stewardship Plan includes biodiversity values that must be met, at a landscape level, by the licensee. Licensees are responsible for ensuring a Registered Professional Forester is involved and has the expertise to ensure harvest operations meet the objectives and stipulations of the Forest Stewardship Plan.

Regarding your final question, the recently adopted FRPA amendments do not speak directly to endangered species. The Province manages species at risk by designating Identified Wildlife Management areas, parks and ecological areas in order to conserve species and support biodiversity.
