Yes, WLAP could be exposed to liability. You could be seen as vouching for the hunters' good quality in some respect and if the landowner relied on that and harm resulted from their not having that quality, they could credibly claim it was your fault. But risk of liability should not cause us to stay in bed all day for fear of doing something wrong, so I suggest the better approach is to weigh pros and cons and to minimize liability if you choose to act.

If you choose to send the letter, re-craft it to both distance yourself from vouching and also think about disclaiming responsibility - although the latter strategy may affect the landowner's receptiveness. You might also wish to be careful about the sentiments of the recipient - one person's nuisance is another's cute Bambi.

Specific suggestions

"You can help" - How about "If you wish to support us in this regard, you can help"

"These individuals operate under" - this implies how they in fact behave. How about "The permits given to these individuals include"

Add near end? Although the government issues permits to the individuals described, we make no representations to you about them and take no responsibility for their activities.

P.S. A friendly reminder to make sure the permit makes all required exemptions. e.g. hunt out of season will not be sufficient if there's a law against shooting - you'll need to cover that too.

Dick:

On August 3, Bob and I met with CRD Southern Gulf Islands rep. Rich Tamboline, Sth. Island COs Dunst and Horncastle, and 2 Mayne Island residents about ongoing escaped fallow deer issues on Mayne Island. They estimate that around 50-60 fallow deer range over most parts of the island (I'm guessing there are significantly more than this number) causing significant local problems and the potential for another Sidney Island overpopulation fiasco.

For the last 6 to 8 years, in a combined plan with sth. island COs, we have permitted up to 4 island residents to harvest fallow deer by permit (Mayne Island is a no shooting and no hunting area, so no real options at this point to control the population through regular hunting seasons). This permit program has been moderately effective and at the Aug. 3 meeting it was decided that up to 2 more locals might be permitted and that we would contact FN folks to see if they might increase harvest efforts on the reservation on the northeast part of the island (I have made initial steps on this initiative).

Another thing that came out of the meeting was the notion that there were several key properties that permitted hunters had not yet accessed because they did not know the landowners personally. They were concerned that access might be denied - we offered to provide a letter of introduction that the permittees might provide landowners as a way of identifying them as legitimate permit holders. Bob and I thought such a letter might best come from you rather than one of us - the attached draft letter is the result.

Thanks for getting back to me.

At a recent meeting with Mayne Island residents and a Gulf Islands Capital Regional District representative, we discussed the proliferation of fallow deer on Mayne Island that has occurred as a result of escapes of animals over the past decade from an on-island deer farm. There are currently an estimated 50-60 free-ranging fallow deer on the island, and apparently at least some of these animals have taken up residence on the reserve on the peninsula on the eastern portion of the island. We are very keen on reducing as much as possible the numbers of these non-native deer, as their dramatic negative effects on native vegetation has been well-documented on other islands (such as Sidney Island). Several local residents have been permitted to remove deer from private lands on the island, but there still appears to be a general increase in both range and numbers of these animals.

At the meeting, we discussed contacting First Nations to see if they would be interested in hunting fallow deer on reserve lands on Mayne Island. In addition, as a result of ongoing control efforts, occasionally there are whole carcasses of fallow deer that have been made available to families in need. We would like to determine if there is an interest by appropriate band members in receiving any of these carcasses for sustenance and/or ceremonial purposes, and if so, I would appreciate it if you could provide a contact name for distribution of animals.

As a follow-up tp your letter of June 16th. one of the permit holders - Steve MacDonald - made some contact with the Victoria Office of Fish and Wildlife and they generously came up with a set of business cards for each of the permit holders on Mayne Island. It is an official looking card with the permitee's name and indicates the permit was authorized by Al Martin Director. This type of card has been very well received by the volunteers and it certainly satisfies one of the concerns which they had expressed. Somehow Steve also managed to obtain three caps with BC Fish and Wildlife crests. They have been distributed to the three hunters who have been most active.

We have been keeping a fairly low profile over the summer because of the large number of visitors on the island. I'm hoping the group will be able to have another meeting in September and we can make some firmer plans for the fall/winter control programme. Further examination of the "trap idea" has indicated that the use of this method would require more people than we currently have available. Concerns extend to the proper handling and disposal of the carcasses which may be accumulated as well as the potential negative response in the community. We will continue to examine the possibility but it looks less promising than it did initially.

Perhaps we can work out the logistics of meeting again with your staff as part of our continuing plans.

Due to the efforts of a small number of volunteers the number of wild fallow deer on Mayne Island has remained stable. Because of the amount of densely populated areas these deer inhabit, they can not be extirpated, but their numbers can be controlled by hunting the remaining areas. There appears to be no other feasible method of removing them. The main obstacle to this method is gaining access to the few areas that are safe to hunt, as these areas are all privately owned. Each owner has his or her own personality and dealing with them is a science all it's own. Some will only allow certain individuals access, some request that you phone in advance and others will allow access but refuse to sign anything granting that access. If this access is lost, then so is all hope of ever controlling these deer. The only way to handle the situation is a "leave no tracks" policy. Never be seen with a firearm (if possible), keep out of sight as much as possible when hunting, do not drive on the property if it can be avoided, do not shoot unless you are assured a kill (keep the number of shots to a minimum) and never confront a person if they challenge you. I feel the department should take great care in granting too many permits as there is such a small amount of area available and the owners would be upset if too many people accessed their lands. As we are not an organized group, it is conceivable that all hunters could access a property in a single day. We cannot afford to lose the cooperation of even one of these land owners. To somewhat alleviate this, I would suggest that Richard Brown be appointed co-ordinator (if he would agree) to keep conflicts of this type to a minimum. Regards;

THE REALITY OF CONTROLLING FALLOW DEER ON MAYNE ISLAND.

Due to the efforts of a small number of volunteers the number of wild fallow deer on Mayne Island has remained stable. Because of the amount of densely populated areas these deer inhabit, they can not be extirpated, but their numbers can be controlled by hunting the remaining areas. There appears to be no other feasible method of removing them. The main obstacle to this method is gaining access to the few areas that are safe to hunt, as these areas are all privately owned. Each owner has his or her own personality and dealing with them is a science all it's own. Some will only allow certain individuals access, some request that you phone in advance and others will allow access but refuse to sign anything granting that access. If this access is lost, then so is all hope of ever controlling these deer. The only way to handle the situation is a "leave no tracks" policy. Never be seen with a firearm (if possible), keep out of sight as much as possible when hunting, do not drive on the property if it can be avoided, do not shoot unless you are assured a kill (keep the number of shots to a minimum) and never confront a person if they challenge you. I feel the department should take great care in granting too many permits as there is such a small amount of area available and the owners would be upset if too many people accessed their lands. As we are not an organized group, it is conceivable that all hunters could access a property in a single day. We cannot afford to lose the cooperation of even one of these land owners. To somewhat alleviate this, I would suggest that Richard Brown be appointed co-ordinator (if he would agree) to keep conflicts of this type to a minimum. Regards;

APPENDIX 1

Right to Appeal (notice required by Ministry policy)

You may appeal this decision to the Environmental Appeal Board under section 101.1 of the *Wildlife Act.* To do this, you must give written notice of appeal to the Environmental Appeal Board not later than (a) 30 days from the date you actually receive this notice, or (b) 44 days from the date, this decision is deposited in Canada Post, registered mail, whichever is earlier.

A notice of appeal must comply with the Environmental Appeal Board procedure regulation (BC Reg. 1/82) under the *Environmental Management Act.* It may be provided by mailing it by registered mail to the chair of the <u>Environmental Appeal Board at PO Box 9425 Stn. Prov. Govt., Victoria, B.C., V8W 9V1</u>, or by leaving it for the chair during business hours at the 4th floor, 747 Fort Street, Victoria, B.C.

You, your counsel, or a representative must sign the notice of appeal and contain:

- your name and mailing address,
- the name of your counsel or representative, if any,
- the reasons for the appeal,
- particulars relative to the appeal, and
- a statement of the nature of the order requested.

Your notice of appeal must be accompanied by a fee of \$25.00, payable to the Minister of Finance and Corporate Relations.

We have been advised of the following; you have fallow deer at large, deer that aren't tagged, your fallow deer come in contact with wildlife and you have fawns on your farm. As a Game Farm licence holder, you are responsible for tagging, ensuring your game farm animals do not escape from the approved facilities, and preventing game farm animals from coming into contact with wildlife. Failure to abide by those conditions could result in licence suspension or cancellation.

All of the free-ranging fallow deer on Mayne Island (and they are quite numerous and very widespread at this point) originated from Paula's farm, and they have been treated as property of the Crown for many years now. There are a number of permitted hunters that taken several dozen deer from the island each year for distribution (primarily) to FNs and families in need. They are permitted by us as an attempt to try and limit the increase in numbers and distribution of fallow deer on the island.

This latest review of Paula's situation came about from a question raised by the local RCMP officer (who is also one of the permitted fallow deer controllers) who regularly noticed up to 20 animals going in and out of Paula's property which has open gates as well as breaks in the fence along the back side. In my opinion, her current permit for 7 deer being kept in captivity does not reflect reality, and is being kept active on the speculation that her farm may at some point in the future become operational once again.

On June 8, 1999, Senior Conservation Officer Jamie Stephen, Wildlife Biologist Kim Brunt and I visited your fallow deer farm on Mayne Island. I am writing this letter to clarify our position. We realize you are licenced by the Ministry of Agriculture and Food to operate a fallow deer farm on Mayne Island. We are also aware that this licence carries with it certain responsibilities. You have advised us that fallow deer have escaped from the perimeter fence of your deer farm on three separate occasions due to blow-down during windstorms. Due to our experience with attempting to live-trap wildlife, we realize that it is not an easy task to recapture all your fallow deer escapees. In spite of your efforts, we continue to receive complaints from residents of Mayne Island about your escaped fallow deer.

While we are aware that there is a growing blacktailed deer population on Mayne Island due to the Island's no shooting or hunting closure, it is your escaped fallow deer that are the focus of the public complaints we receive.

As you are no doubt aware, Ministry of Environment Lands and Parks (MOELP) is having to spend considerable time and effort to address a growing fallow deer population on Sidney Island. In spite of heavy hunting pressure, Sidney Island's fallow deer population continues to grow. MOELP Wildlife Biologists simply do not want a repeat of the Sidney Island situation on Mayne Island. They do not want any fallow deer on Mayne Island unless they are inside the confines of your deer farm's perimeter fence.

So, in spite of complaints from Mayne Islanders about your escaped fallow deer, we are trying to push aside those complaints and deal with the issue. Our Ministry simply insists that you continue to work toward reducing the number of non-captive fallow deer on Mayne Island to zero. It is your responsibility.

You should be aware that I have contacted Dr. Mervyn Wetzstein of Ministry of Agriculture and Food in the Abbotsford office to obtain a copy of your Game Farm Licence, as well as the manual which outlines your responsibilities as a licencee.

You should also be aware of sections 76 and 77 of the Wildlife Act, copies of which are enclosed for your perusal. The definition of "domestic animal" used in both sections is defined by Section 12 of B.C. Reg.

168/90 and includes horse, cattle and sheep. Therefore, fallow deer are not considered domestic animals. The offence sections are 77(2) which states "release or abandon other than domestic animal" and 77(3) which states "fail to recover escaped non-domestic animal", and can both be dealt with by way of \$115 tickets. In more serious cases, charges under these sections can be dealt through the Courts where, upon conviction, penalties can range up to \$5000 and/or six months imprisonment.

As discussed by telephone, this matter is under investigation, with the possibility of charges.

As you can see from Section 76, your escaped fallow deer are really the property of the Crown. In our recent telephone discussion, you indicated that the fallow deer rut starts near the end of September and runs until mid December, You have indicated you are most successful in baiting the fallow deer during the rut. Bearing in mind that we can shoot your escaped fallow deer at any time (see Section 79) since they are now the property of the Crown, we will tentatively give you until the end of October 1999, to try and recapture your escaped fallow deer.





Re: Recapture of storm related escapees of fallow deer from my pastures

I have received your letter dated September 23, 1999 as ordinary mail in my mailbox on September 28, 1999, addressed to a Mr. Buchholz. As I informed you in detail since the very first time you contacted me, I am constantly on the alert to recapture my escaped deer back into my fenced pens. I have been quite successful so far. In addition to the numbers I have reported to you before in September with a total of 12, I have caught a big rutting buck last week. My efforts continue on a daily basis in this regard.

I was glad to hear from you that the Ministry's biologists are also not happy with the results on Sidney Island. However, to take this dissatisfaction out on me, a deer farmer punished already with the storms and escapes of my property, the deer, is just not right. As you are aware, the complaints from Mayne Island were instigated by public articles written with false facts in our local newspaper by one person who made it her goal to pursue fallow deer, after she had seen the devastation created by Sidney Island fallow deer under your management. But you cannot compare apples with oranges.

It is unacceptable when you personally interpret the law and threaten me, a law abiding citizen, with jail for six months or a fine of \$5,000.00 if I fail to recover the escaped deer. The law reads differently: ..." the person commits an offense if he or she fails to make every reasonable effort to recover the animal". This is a big difference, Mr. Broadland.

It is unexplained, why you highlighted in the attached section of the Wildlife Act, which you named "pertinent", under 77 (2) "If a person releases or abandons an animal, other than a domestic animal, the person commits an offense". Why did you highlight that? Are you insinuating a release or abandon by me? I find this part of your letter also very offending and unacceptable.

However, reading further under section 79, I raise the question, how can you justifiably say that my escaped fallow deer at large are likely to harm persons, property, wildlife or wildlife habitat - so far having been caught eating flowers - and are therefore to be killed by you, when you are undoubtedly aware that the grossly overpopulated black tail deer are definitely constantly causing all of these damages, including several car accidents on the island and nothing is being done about that proven harm to persons and property? I have provided you with my response article which included constructive suggestions how to properly manage our black tail population.

As you wrote: "this matter is under investigation, with the possibility of charges", I would like to know what exactly you are investigating and what charges are being contemplated? I think, it is only fair to answer my question in this regard at your earliest convenience.

As I did before, I can assure you that I have the utmost interest of capturing my escaped deer, thus getting my property back behind my fences. Accordingly, my efforts are not only reasonable but I extend every possible effort to recapture them. I look forward to get answers to my questions from you.

Last fall I sent you a copy of my September 23, 1999 letter to Ms. Paula Buchholz at Arbutus Bay Deer Farms. Ms. Buchholz pleaded that we allow her to recapture the escaped Fallow deer, rather than us attending to shoot the deer. We agreed and have waited patiently while she recaptured over 35 Fallow deer.

While this is admirable, it has to come to our attention during the course of the investigation that some of the perimeter fencing on the deer farm may be too large a mesh size, thus allowing some of the smaller deer to push their way through the perimeter fence. When asked about this situation, Ms. Buchholz did not deny that some of the deer were able to push through some areas of the perimeter fence, rather she simply stated that some Ministry of Environment (MOE) staff had apparently approved the perimeter fencing at the time when MOE staff were responsible for such approval.

Could we please discuss this issue. We are interested in hearing what the approved mesh size is for perimeter fencing on Fallow deer farms. There is a need for a field inspection to identify what proportion of the perimeter fence meets standards. It seems pointless to allow Ms. Buchholz to play "the recapture game" if some Fallow deer are free to leave whenever they decide to leave. We understand there are still about 10 escaped Fallow deer near the deer farm.

Although I've concluded this file, the issue of the escaped fallow deer on Mayne Island doesn't go away. As a result of Jamie's June 20 note to me I called Merv Wetzstein (MAF) yesterday. I read out the points raised in Jamie's note to me. With respect to Merv instructing Paula Buchholz that upgraded fencing and removal of danger trees will be a condition of her licence in the future, Merv did not agree and viewed it as a threat that we would be prepared to contact somebody higher up in MAF. Merv went on to say that Paula has reduced her herd size down to 22 fallow deer, they are all ear tagged and she has agreed to confine them in the approved fence area. I had a twenty minute conversation with Merv. Bottomline, he believes Paula has made a significant effort to reduce her herd size and things are under much better control on the farm. Merv suggested he would probably de-licence the lower, unapproved fencing area from future licences. Merv was not concerned about access to the barn area (which is contained within the unapproved fenced area), so long as the wing fences leading to the barn area were brought up to standard.

Shortly after that conversation, Paula's neighbour Sally Sexsmith called me. She agrees Paula has worked very hard to eliminate 95 fallow deer. She says Paula is anxious for plans for one-way gates that she could install in the lower, unapproved fenced area. Sally went on to say that she thinks she saw 3 fallow deer in the lower fenced area, but when she called Paula she wouldn't believe her. When we discussed phase two (getting names of Mayne Islanders that would be prepared to shoot fallow deer), Sally suggested John Dodds, Richard Brown and Punch Robson. More on that at a later date.

My final conversation on the issue was with Paula Buchholz. She's not very happy and became very upset with me on several occasions during our conversation. She says she has 22 fallow deer left on the farm, 20 yearling does, 2 bucks. All are ear tagged. She has agreed to only use the areas with approved fencing, but is not happy because the best pasture was in the older, unapproved fencing area. She is having to provide more grain, albeit for fewer animals. To slaughter the 95 deer she had to capture them and take them five at a time to chemainus. She had to pay \$75/deer for slaughtering and meat cutting (\$7125 my calculation), plus on-going freezer costs. She lost it when I brought up the topic of logging the danger trees. She is also very upset that she is not allowed to use her best pasture, because of " a mistake by our Ministry" (approving the old fencing that is now substandard). Paula got really stressed when I wanted to give her fair warning that phase two would probably happen this Fall (Islanders to be given permits to shoot Fallow deer on their property). The conversation was suddenly over.

I believe things are working out. We've taken too long to get to phase two, but I believe phase one was a success because we're down to 22 ear tagged fallow deer being raised in an area of approved fencing. Tell me if you think I should still write to Merv. Personally I believe the emphasis should now switch to phase two, before it's too late.

I spoke just now to our Crown Counsel, John Blackman.He seemed to grasp the situation quite quickly. He recommends consultation rather than confrontation. John suggests we explain to Ms. Paula Buchholz our concern that every reasonable effort be made to reduce the number of non-captive fallow deer on Mayne Island to zero and that since some of the buck fallow deer have no intention of ever returning home (some bucks have been loose for several years), maybe it should be her responsibility to arrange for another way to eliminate them. John thinks we should encourage her to apply for a permit from the Regional Manager and figure out a way for local hunters to be delegated as her agents. Makes sense to me. Thoughts? Should I write the letter to Ms. Buchholz?

Hi Doug - Thanks for the update from MAF; while I am encouraged that MAF will communicate new responsibilities to Ms. Bucholtz, unless those stipulations are incorporated as pre-requisite conditions for licence renewal, they may not achieve the desired result. Please would you notify me as soon as you learn the outcome of MAF's visit. Notwithstanding (a) Dan Irelands feeling that C.O.s should address the issue of the escapees, and (b) Paula Bucholtz's past re-capture efforts, the responsibility may still reside with the farmer (s. 77(3); Ken Broadland will consult with Crown Counsel over the interpretation of 'every reasonable effort'. Mike, If Crown Counsel agrees that Ms. Bucholtz has statuatory responsibility to 'recover' the still at large animals, would you be prepared to issue a permit to an approved (by us) designated hunter employed by her to hunt in a closed area? Moreover, would wildlife staff be prepared to accompany one or two of us to (a) meet with a quorum of those Islanders who signed the Sexsmith petition, with a view to identifying potential collaborators (hunters) who may assist upon their own land; and (b) under acceptable circumstances, shoot any Fallow deer escapees which we encounter. Doug, please advise me of your position asap. I'm sure you would agree that further delays may exaccerbate the problem Thanks.

As you are aware, Paula Bucholz operates a Fallow deer farm on Mayne Island, from which, since a Game Farm permit was originally issued (by Barry Saunders in 1988), an unknown number of Fallow deer have escaped. Last year, Kim Brunt and Ken Broadland and I visited Paula, inspected her farm, and found a number of Fallow deer escapees browsing close to the farm and another group further north on the Island. As a result of that visit and another site inspection by Ken and Dr. Mervvyn Wetzstein (Min. of Agriculture) about 6 weeks ago, we believe the following improvements must be made to prevent the future escape of captive deer:

(1) Fencing must be upgraded to current standards as expressed by policy of the Ministry of Agriculture (in 1988, standards were less stringent than today);

- (2) Standing trees upon the Bucholz property, within a tree length of the existing perimiter fence, must be removed so as to eliminate windthrow fence damage, which is believed to have provided escape opportunities in the past;
- (3) All captive deer must be permanently marked for ease of distinguishing any new escapes from escapees from previous times (N.B. that it is an existing condition of Paula's permit that all deer have to be permanently marked, but it appears that this requirement has not been met).

In recent weeks, our office has received further reports from Mayne Islanders that Fallow deer continue to roam freely about their property. Although it is difficult to attach confidence to estimates from various individuals, one property owner recently reported a small herd of '10 to 11' at one location. Paula Bucholz does seem to have re-captured a number of escapees at the farm site since our intitial visit last year, but those deer which have migrated to remote locations from the farm will not likely be recaptured.

In order to minimize the potential for increasing numbers of Fallow deer on Mayne Is., I propose the following:

- (a) Wildlife section request the Ministry of Agriculture insist on escape control measures as outlined above, and in the event the control measures are not implemented, that the Ministry of Agriculture cancel Paula Bucholz's permit (N.B. Dr. Mervyn Wetzstein is familiar with the site and circumstances, and can be reached at 604-556-3013 or by facsimile at 604-556-3015);
- (b) Ministry staff (Conservation Officers and Wildlife section staff) undertake a schedule of planned hunts to attempt to reduce the numbers of free ranging Fallow deer on the Island. In order to assess the feasibility of hunting Fallow deer escapees on Mayne Is., I have requested Conservation Officers Ken Broadland and Gary Horncastle to attempt to shoot - as authorized by section 79.(1) of the Wildlife Act - as many escaped Fallow deer as practical, where safety considerations and consent from private property owners has been satisfactorily addressed.

Just a quick summary of our visit to Paula Buchholz Fallow deer farm on Mayne Island. Paula has about 130 deer and plans to immediately start reducing herd size to 20 deer, including about 17 fawns. Wants to accomplish this before the bucks get in velvet (they're already starting). On fence issue-not using the old Fish and wildlife approved fenced area. More feasible considering her herd size to be reduced to 20 deer, but still needs to use part of it because that's where the barn is and that's where they are fed and processed. Regarding the issue of falling all trees within a one tree length of the perimeter fence...Paula says it's not needed and an over- reaction, but she agrees there are still some trees that could be affected by prevailing south-easterlies and the trees are on her land and she would have them logged if the Government would pay logging costs. On the issue of ear tags, fawns of the year are not required to be ear tagged until December, so if she reduces herd size to 20 deer, only about 3 deer will initially need to be ear tagged.

I gave her a letter saying she had to arrange for agents to hunt or trap the remaining loose fallow deer on Mayne Island. Although initially reluctant, she eventually agreed that they needed to be dealt with, probably by shooting, but thought that we were probably in a better position to organize qualified hunters to do the shooting. Paula thought we'd have trouble finding anybody to do the hunting, I told her there had been several volunteers. Paula has 160 acres, 24 in the fenced fallow deer enclosure. I asked if hunters could hunt on her property. At first she said no, then later agreed they could so long as she had some say as to who hunted on her property.

Paula is having trouble with a former tradesperson who was helping build her new house. On monday, May 22, Paula called to say someone opened a gate and cut part of a fence and 50 fallow deer escaped. RCMP are investigating. Paula has since recaptured 9 fallow deer. More as it continues.

REGARDING THE SERIOUS PROBLEM OF ESCAPED FALLOW DEER ON MAYNE ISLAND.

Dear Mr. Sundquist

We, the undersigned farmers on Mayne Island, have been concerned for several years with the presence of escaped Fallow Deer on our Island. As is well known, these animals are extremely destructive to pasture and trees; grazing the former down to the roots and girding the latter of bark, causing the death of the tree. These incidents put these animals (which are now the "property of the government" in direct competition with the interests of farmers and fruit tree growers on Mayne.

Both the Ministry of Agriculture and the Ministry of the Environment have clear responsibilities to help us with this growing problem.

An Abridged Quotation of *The Ministry of Agriculture's* Game Farm Regulations reads:

Control of Game

- 4 A licensee must
 - (a) confine to the farm the game for which the game farm license is held.....

Notification of escape

(various stringent requirements involving accurate reporting of the escape within hours to 7 days)

Notification of recapture

(notification of recapture within 7 days)

Game at large

7 (1) A licensee must recapture game that escapes from the licensee's farm within 30 days of the escape of the game to avoid application of section 76 of the Wildlife Act to that game. (see section 76, to follow)

(continued)

Ministry of the Environment, Lands and Parks' Wildlife Act, section 76 reads:

Section 76 On the escape from captivity or the release or abandonment of an animal that is not a domestic animal, the government acquires the ownership of that animal.

We request that the <u>Ministry of the Environment</u> and the <u>Ministry of Agriculture</u> confer together and do their jobs as outlined in the regulations which govern their activities or issue specific hunting permits to farm owners to eliminate these escaped animals. Fallow deer directly compete with our farming efforts on Mayne. Further, we remind you of the shocking devastation caused by Fallow Deer on Sidney Island.



Thank you for your letter of April 26, 2005, regarding fallow deer management on Mayne Island.

We applaud your efforts to maintain access to the few areas where hunting is permitted by having Richard Brown coordinate the permitted individuals to avoid conflicts. Your suggestion of pursuing some form of identification for the permitted hunters also appears to have merit for facilitating access to private lands. However, we do not have any type of Ministry identification that could be provided beyond the letter of introduction we provided to permitees in September 2004, or the permit itself.

You mention in your letter that you would be following up on looking into a small trap that might be used to trap deer. While trapping is not authorized under the current permits for fallow deer control on the island, we are very interested in hearing from you any ideas on trapping activities that might be used. Perhaps we could set up a conference call prior to this fall's hunting activities where we could discuss this further.

Thank you for your efforts to date, and we look forward to working further with you on this issue.

Mayne Island Fallow Deer permits

Hello Rich:

The Mayne Island fallow deer kill permits expired on December 31/04. All permitting is now down out of Victoria, coordinated by the Permit Authorization Service Bureau (PASB). I called them to see about renewing these permits, (as well as adding Mr. Holmes as an additional permittee) and they said that shouldn't be a problem.

I spoke to Nancy Smith who was temporarily filling in for Kelly Smith who usually handles these types of permits (called Wildlife Act Sundry permits). She couldn't confirm that there would be no charge for these permits until she had spoken to Kelly. I did let her know that these individuals are basically doing a service for the Ministry, and I understand that a waiving of any applicable fees in these circumstances typically occurs.

The process for obtaining these permits is to have each of the potential permitees (Richard Brown, Robert Anderson, John Dodds, Steve MacDonald and Michael Holmes) contact the PASB office via their toll free number to initiate the permitting process. The number they should call is:

1-866-433-7272 ext. 2, then 3

PASB staff will be able to confirm whether a waiving of fees is applicable when they are contacted by the permitees. The permit then comes to our regional office for approval. Could you please pass this information along to each of these gentlemen??

As you are probably aware, free-ranging fallow deer currently occur on most parts of Mayne Island. This is the result of several escapes of deer from a local fallow deer farm.

Fallow deer are not native to British Columbia. They are, however, very successful at colonizing new territory at the expense of habitat for native species of wildlife. Also, fallow deer often cause extensive damage to agricultural crops and gardens. For these reasons, the Ministry of Water, Land and Air Protection is seeking the support of local land owners. If you wish to support us in this regard, you can help by providing access to your property for hunters who have been permitted by the Ministry to harvest fallow deer. With your co-operation we believe it is possible to control the situation before irreversible damage to native wildlife and their habitats occurs.

Thank you for the opportunity to meet on August 3, 2004, and discuss emerging fallow deer issues on Mayne Island. We sincerely appreciate the effort you have made to convene those who have the knowledge and experience to develop management options. In terms of the action points Ministry staff took from the meeting, I would like to confirm the following:

- 1) Ministry staff will prepare a letter outlining the fallow deer problem and steps the Ministry authorizes and supports to control population growth. We understand the current free ranging population to be in the order of 50-60 animals. There is little likelihood of reducing this number substantially. Our primary objective is to prevent this number from increasing. Our letter will serve as a backgrounder and introduction to land owners where permitted hunters may desire access for population control purposes.
- 2) The Ministry is prepared to issue permits to up to three more individuals who are considered by existing permittees and our staff to be qualified and capable of contributing to population control efforts. We await your further recommendations in this regard.
- The Ministry will review the language of the existing permits with the objective of providing greater clarity around the conditions attached thereto (especially disposal of carcasses).
- 4) The Ministry will approach First Nations representatives to encourage their participation in harvest on reserve and to investigate opportunities for delivering fallow deer carcasses to them.

5) The Ministry will review available information and options for use of attractants to concentrate fallow deer in areas where harvest may occur readily.

One final point relates to hunting opportunity. Whereas the Ministry generally supports maintenance of such opportunities, we accept the safety and public perception issues around reinstatement of a restricted hunting season on Mayne Island are not likely to be resolved. For that reason we will not pursue a fallow deer hunting opportunity at this time.

Thank you again for your efforts in dealing with the fallow deer problem. We look forward to your continuing support.

Further to this issue, I wish to update you as to the fallow deer remaining at large from the above premises.

Some animals have been recaptured during the past few months. As of March 21, 1996, there remains one or two mature does at large. Our office has received reports that offspring have been sited with the mature animals but an exact count is not known.

The licensee has been requested to conduct an accurate herd inventory to determine the exact number of animals still at large. Ms. Paula Buchholz has agreed and will forward a detailed report by April 30, 1996.

However, since the 30-day "grace" period extended for game at large under the <u>Game Farm Act</u> has expired some time ago, the remaining animals fall under the jurisdiction of your ministry. Ms. Buchholz has been advised that any costs incurred by government personnel for recapture or disposal may be charged to her should your ministry decide to take action under Section 79 of the <u>Wildlife Act</u>.

Greg:

We share a concern about fallow deer on Mayne Island. Shortly before receiving your email, the Duncan COs and I planned a trip to the island on June 3rd to assess the situation. If the estimate of 100 or more is correct, we have probably already missed a our best opportunity to control this population. Late in 1994, I first heard of an escape of fallow deer that occurred in May, 1994, where at least 3 of the deer were not recovered. There have been several escapes since (apparently about 20/year) "most" of which have been recovered. I have been making noise about "nipping this thing in the bud" for quite some time. However, other than providing permits to the animal control contractor and a local employee of BC Hydro (or is it BC Tel?) to kill deer, we have not had much success controlling the deer numbers.

The local fallow deer farmer, Paula Bucholz is the source of the escapees. Duncan CO Ken Broadland called her to let her know we would be out for a look and likely soon "gunning" for her escapees and she was quite concerned at losing some of "her" animals, but has been given fair warning to round them up now, or risk losing them permanently. I have a letter from Min. of Ag&Fish from Mar./96 stating that escapees became the property of the Crown after 30 days. We'll assess the likelihood of success of an archery hunt and update you on our planned course of action after our June 3rd trip.

If we decide on MoE control program, maybe you should come along Greg..... it looks like this might be a rare opportunity to actually be successful on a deer hunt in Region 1!!

Re: Fallow deer on Mayne Island

It has recently come to our attention that at least three fallow deer have been free-ranging on Mayne Island since May 1994. BC Environment is very concerned about the potential effects of this introduced species on native wildlife and habitats. The most significant of these concerns relate to disease transmission and habitat degradation.

Although the health of captive fallow deer can be monitored closely, free-ranging animals may become resevoirs and/or vectors for diseases which may be devastating to native wildlife. addition, fallow deer in the Gulf Islands have the potential to develop extremely high population levels which have been shown to severely alter native ecosystems. Sidney Island is a prime example of the level of habitat degradation that can occur if fallow deer are allowed to proliferate. It appears that the group of three fallow deer includes both males and females, so the opportunity for population expansion is obvious.

We strongly endorse any efforts by the Animal Control Officer on Mayne Island to remove these deer by safe, humane means. This should be done as soon as possible to reduce the chance of the addition of more animals through spring births. Please request that the officer record any ear tag information (if present), and the sex/age of any animals removed.
