

We require that 30-day review period to be completed before moving forward with operations. Fiscal year end should not factor into the GCPE delays, and infract the Chinook business area had similar delays with a recent ad – sent it in early February and it took 5 weeks before it made its way to the papers.

As to the reporters questions generally, I would go with what we have in our info note:

 The effects of glyphosate on human health has been extensively reviewed by international regulatory agencies, including the Pest Management Regulatory Authority (PMRA) for Health Canada, with the conclusion generally being that exposure to glyphosate does not pose a carcinogenic or genotoxic risk to humans.

You can add that Roundup (glyphosate) is readily available for purchase at Canadian Tire and garden centers in BC and Canada for use by the general public because of that fact.

It is used because it has been found over decades of use to be the most effective at controlling vegetation while continuing to get approval for use by PMRA. As we have said many times, herbicides are a small part of the toolbox used in an Integrated Pest Management approach in BC to manage vegetation.

When is the government expected to approve the plan? Were there any issues raised during the public consultation? Have First Nations been consulted?

There has also been an outcry from many organizations and people against this plan, mainly because glyphosate is not believed to be safe for people and biodiversity. Does the ministry have any comment on that matter? Why use this particular herbicide?

If I could have a statement from the ministry and some background info regarding that pest management plan before tomorrow, that would be ideal.

From Gagandeep: Several local residents have been calling and emailing us about the pest management plan and plans to spray herbicide in the area.

## RESPONSE:

Provided Background

- Any proposed use of herbicides in the reforestation process must be identified and approved by the Ministry of Environment and Climate Change Strategy.
- BC Timber Sales makes a concerted effort to avoid using herbicides, and have only utilized them in situations where other options have not been or may not be completely successful.
- The use of herbicides in B.C.'s forest sector has declined significantly in recent years as foresters use a variety of approaches to manage competing vegetation, including manual, mechanical, burning, biological and herbicides.
- This permit does not mean that application of herbicide will take place. It would simply allow for the planning around the use of the herbicide to begin at that time, with care taken around the protection of multiple resource values as outlined in the permit.

- If after monitoring growth performance it is felt that herbicides may be needed, a notice to apply would have to be consulted and published prior to the application of any herbicides.
- Notification must be consistent with the pest management permit, and could include requirements like posted notices (signs posted in advance of, or immediately following, specified pesticide applications), newspaper and/or radio broadcast notices, and direct notification of individuals, especially those who had been offered notification during the consultation process.
- The permit also outlines all the measures that BCTS will take to avoid and minimize the need to use herbicides. Herbicides are only sparingly used when all attempts to avoid the use of herbicides has not been successful
- The effects of glyphosate on human health has been extensively reviewed by international regulatory agencies, including Health Canada, with the conclusion generally being that exposure to glyphosate does not pose a carcinogenic or genotoxic risk to humans.
- Glyphosate remains an important tool for establishing conifer or conifer—deciduous mixed stands and ensuring future timber supply.

  - BC Timber Sales Chinook has not yet sent the Pest Management Plan (PMP) package to the Ministry of Environment and Climate Change Strategy for consideration and approval.
  - The Pest Management Plan is still in the proposal phase.
- What opportunities were First Nations and the public given to provide input?
  - Area First Nations were consulted during the drafting of this PMP; in 2021 for those Nations who chose to
    engage (16 Nations), there were meetings, field visits and further notification strategies developed for the
    Notice of Intent to Treat (NIT) stage. Public opportunity to provide input is ongoing.
  - It is also important to note that the BCTS PMP will not result in any herbicides being sprayed in the outlined area in 2022 by BCTS.

  - A PMP does not outline specific treatment areas. Specific areas are identified in the NIT, which
    has not and may not occur. A PMP includes a map of the geographic area covered by the PMP.
  - BCTS has committed to an NIT consultation process of 90 days.
  - No application by BCTS will occur without further consultations with First Nations as outlined in the PMP, and no spraying at all will occur in this area by BCTS in 2022.

## Request

From Reporter: I'm working on a story for The Narwhal following up on the concerns that have been raised about BC Timber Sales pest management plan and in particular the use of glyphosate.

I wonder if you can provide a response to the following questions by Tuesday at noon?

- Has the proposed Integrated Pest Management Plan 2022-2027 for the Chinook Business area been approved? BCTS Chinook has not yet sent the PMP package to MOECCS for consideration.
- What opportunities were First Nations and the public given to provide input? First Nations were engaged in late 2021. For those Nations who chose to engage (16) there were meetings, field visits and further notification strategies developed for the Notice of Intent to Treat (NIT) stage.
- The PMP doesn't identify specific locations where glyphosate may be used. What opportunities will First Nations and Indigenous Peoples have to comment on plans to spray specific areas that may affect their access to traditional foods? Where will those opportunities for comment be posted?

A PMP does not outline specific treatment areas. Specific areas are identified in the NIT.

A PMP includes a map of the geographic area covered by the PMP. Future treatment areas, specific cut blocks or portions of cut blocks, are identified in the NIT process.

BCTS has committed to an NIT consultation process of 90 days.

BCTS Chinook is not spraying in 2022.

- In the legislature MLA Adam Olsen raised concerns that there had been inadequate consultation and reiterated calls for the consultation to be extended. His comments followed the release of the government's Declaration on the Rights on Indigenous Peoples action plan. Does Minister Conroy believe the consultation fulfilled the obligations of the declaration? Why is Minister Conroy unwilling to extend the consultation?

The Minister of Environment and Climate Change Strategy has jurisdiction over PMPs, not the Ministry of
Forests.
- Given the numerous concerns about Glyphosate, is the province considering a ban on the product? If not, why
not?
