Mark,

Please find attached towing surveys for the "*Miller Freeman*" and "*Surveyor*" that are necessary for the transit of your vessels to Vancouver Island.

It is my understanding that you had initially planned to take these vessels to Campbell River as a temporary measure until you were ready to haul them from the water.

Considering the fact that these vessels have been subject to extensive theft, it is my strong recommendation that these vessels be taken directly to your facility in Union Bay and hauled out of the water as they now pose a risk to both public safety and the environment.

The issue is that we are unaware as to what extent the vessels have been compromised due to the theft. There is evidence of extensive theft in the engine rooms of both vessels, and I noted that many non-ferrous items were missing. If these systems continue to be tampered with, there is a high risk that the vessels may be subject to flooding, mainly if we are to experience freezing conditions in the coming months that could cause any number of pipes to freeze and ultimately fail.

The tow surveys have been very specific with regard to towing conditions, in particular to weather, for the same reasons outlined above.
