# Background

The following analysis is based on data received from the Conservation Officer Service (COS) detailling incidents of pets caught in traps that were reported to the COS. The data ranges from 2015 until September 2021.

There were a total of 74 instances of pets getting caught in traps, with an annual average of 10.6. The vast majority of incidents involved dogs (89%) and the rest involved cats (11%).

77% (57) of incidents occurred between November and April. The highest number of incidents occurred in February (14) and November (12).

## Regions

The highest number of incidents occurred in the following regions: Cariboo (13), followed by the Omineca Zone (12), the Lower Mainland (12) and Kootenay (10).

## **Fatalities**

Out of all incidents, around 15% (11) resulted in death, 72% (53) in injury and in around 13% (10) of instances, the condition of the dog was unknown. On average, 1.6 incidents resulted in death and 7.6 incidents resulted in injury per year.

### **Traps**

32% (24) of incidents involved snare traps which accounted for 27% (3) of fatalities. 26% (19) of incidents involved leghold traps which accounted for 9% (1) of fatalities. In 42% (31) of cases, the type of trap was unknown. 64% (7) of fatalities involved an unknown trap type.

# Crown vs. Private Land

57% (42) of incidents occurred on Crown land, 26% (19) on private land and the exact location is unknown in 17% (13) of instances.

#### Notes

- **1.** The table in the "Incidents" sheet was adapted from data provided by the COS. Certain columns from the original tables were omitted because they either contained personal information or information that was not relevant for the analysis.
- **2.** The database from which the data was extracted required a manual search of incidents related to pets in traps. As a result, the completeness of the data can not be guaranteed.
- **3.** The information in the categories "Trap Type", "Condition", "Land", Animal" and "Incident" was not provided by the COS but derived from the incident descriptions. This might result in (minor) inaccuracies.
- 4. Instances in which more than one animal was involved are counted as one incident. If the incident resulted in at least one fatality, it is counted as such.
