The culvert design as it currently stands would require a Change Approval. If they want to complete the work as Notification, a recommendation to change the design to a single opening box culvert should be provided to the applicant. Additionally, they should provide confirmation by way of a markup to the engineering drawings that the depth of fill is under 2 meters.
