



Jason Caswell is the acting District Manager for that period.

As we briefly discussed at the last G2G meeting Jason will be providing to you on my behalf a description and map of the Raush Valley area. This is the area that the Simpcw First Nation has expressed interested in talking about protection options under the umbrella of old growth valleys that are largely untouched. At this time we will be seeking some broad indication if Lheidli T'enneh has any questions, concerns about the concept at this very early point of the discussions. We don't wish to step out of line in regards to relationships and First nation territory discussions, we just wish to be transparent to all parties. From my personal perspective the valley is largely intact from forestry operations, foresters that I respect have indicated to me that the valley has marginal timber opportunities due the challenging terrain (steep and rocky), challenging access options, a large percentage of the land base is currently encumbered in protected areas and other no harvest designations, etc. For reference the Raush Valley is part of Carrier Lumber Ltd.'s operating area in the Robson Valley TSA, as of this time Carrier Lumber has no active plans for operations in the valley.

Tammy Baerg will be contacting you regarding the status of Lheidli T'enneh thoughts on the candidate areas for the spatialization of the biodiversity areas. I understand that you have met a number of times regarding the proposed areas and you understand that these areas would be temporary in nature and allow future landscape level planning to determine if they should stay, go, be revised, etc. I understand you were going to gather some broad thoughts on the suitability of the proposal from chief and council.
