According to the information I reviewed, Scott Duncan does not have the qualifications to volunteer to check the hours of credentials for any of these organizations. There is no Scott Duncan that I could find on the current list of existing members to EGBC. Scott Duncan only recently wrote the well drillers exam at the April 15 BC Ground Water Association convention. He provided a copy of the ITA well pump installer certification but was not registered as a well pump installer at the time of the joint well site inspection on Dallas Drive July 2022. Scott Duncan did finally register as a well pump installer later in 2022.

Engineers and Geoscientist BC (https://www.egbc.ca/) is the governing body that holds the registry and regulates engineers and geoscientists in BC. The volunteers that check the credentials of the applying engineers and geoscientists must members in good-standing.

Well Drillers and Pump Installers Certification is received from Industrial Trade Authority (ITA), recently changed to SkilledTradesBC (https://skilledtradesbc.ca/) working very closely with the BC Ground Water Association to host the exams and check the hours required to receive the certification. The volunteers checking the hours must be certified and registered well driller or well pump installer in good standing.

Once the well driller or well pump installer receives certification, the person must register with the Province to comply with the Water Sustainability Act.

## RE: Advisory on Restricted Well Activities and Qualifications in the Province of British Columbia

In their administration of the Water Sustainability Act (WSA or the "the Act"), Ministry staff members respond to complaints and undertake periodic reviews of the compliance of well drillers with the standards for construction, decommissioning, deactivation and disinfection of wells under the WSA, as well as under the Groundwater Protection Regulation (GWPR), including requirements for professionals (as defined under WSA) and registered well drillers only to carry out certain well related activities, if so qualified, as required by the provisions of WSA (Part 3, Division 3) and the GWPR. It has come to our attention that you may have been involved in the construction of wells without proper authority under the Act.

July 28, 2022, Natural Resource Officers Jordan Pertus and Ryley Griffin, and Groundwater Protection Officer Laurie Lyons attended the 428 Dallas Drive drill site to follow-up on a complaint of a well being drilled by J.R. Drilling Central Limited Partnership without a registered well driller or professional onsite. During the 428 Dallas Drive onsite well inspection the owner of J.R. Drilling Central Limited Partnership stated that he was acting as the Qualified Professional (QP) overseeing the well drilling operation and that you are apprenticing to become a well driller.

Section 48-50 of WSA outline the following requirements (with emphasis added):

## **Definitions**

48 (1) For the purposes of this Division:

"person responsible", with respect to constructing a well, installing a well pump, conducting a flow test or decommissioning a well, means,



(a)if the activity is supervised by a professional, that professional,

(b) if paragraph (a) does not apply and the activity is supervised or performed by a well driller or well pump installer who is qualified to supervise or perform that activity, that well driller or well pump installer,

(c) if neither paragraph (a) nor (b) applies, a person who performs the activity in the ordinary course of that person's business, and

(d)if none of paragraphs (a), (b) or (c) applies, the person on whose behalf the activity is performed;

"professional" means a registrant as defined in section 5 of Schedule 1 to the *Professional Governance Act*;

"qualified", in respect of an activity in relation to a well or well pump,

(a) for a well driller, means a well driller who has the qualifications prescribed as required to perform or supervise the activity in relation to the well or well pump, and

(b) for a well pump installer, means a well pump installer who has the qualifications prescribed as required to perform or supervise the activity in relation to the well or well pump;

"well" includes any casing, screen, drive shoe, packer, riser pipe, cap, valve, grout, liner and seal relating to a well;

"well driller" means a person who has the prescribed qualifications;

"well pump installer" means a person who has the prescribed qualifications.

(2) For the purposes of this Division, a person's actions are directly supervised by another person if that other person is responsible for the control and conduct of the person's actions.

## Restrictions on constructing or decommissioning wells and related activities

- 49 (1) Subject to section 50, this section applies to a person who
  - (a) constructs a well,
  - (b) decommissions a well,
  - (c) deactivates a well, or
  - (d) disinfects a well.
  - (2) A person referred to in subsection (1) must
    - (a) comply with the applicable regulations,
    - (b) in the case of an activity referred to in subsection (1) (a), (b) or (c), either
      - (i) be a well driller who is qualified in respect of the activity in relation to the well, or
      - (ii) act under the direct supervision of
        - (A) a person described in subparagraph (i), or
        - (B) a professional who has competency in the field of hydrogeology or geotechnical engineering, and



- (c) in the case of an activity referred to in subsection (1) (d), be a person described in paragraph (b) or a well pump installer described in section 50 (2) (b) (i), or act under the direct supervision of a person described in section 50 (2) (b) (ii).
- (3) Unless provided otherwise by a regulation under section 83 [plan regulations restrictions on groundwater activities] or 137 [minister's regulations restricting groundwater activities], subsection (2) (b) or (c) of this section does not apply in respect of the following:
  - (a) a person
    - (i) excavating a well to a depth of not more than 15 m, or
    - (ii) performing an activity referred to in subsection (1) with respect to an excavated well that has a depth of not more than 15 m;
  - (b) a person deactivating or disinfecting a well owned by the person;
  - (c) a person constructing or decommissioning a geotechnical well, if the activity of constructing or decommissioning the well is not likely to penetrate an aquifer;
  - (d) a person installing, replacing or repairing, on a well owned by the person,
    - (i) a flow meter, or
    - (ii) a well cap, well cover, valve or vent that is part of the wellhead and accessible at the surface of the ground;
  - (e) a prescribed
    - (i) person,
    - (ii) well,
    - (iii) activity in relation to a prescribed work, or
    - (iv) activity.
- (4) A person who, in performing an activity referred to in subsection (3) (c) or prescribed under subsection (3) (e), penetrates an aquifer must stop performing that activity until the person has complied with subsection (2) (b) and must take the steps recommended by the person described in that subsection.

As described above, the construction, decommissioning and related activities associated with water wells in British Columbia must be performed by or under direct supervision of a well driller registered in the province of British Columbia, or a professional with competency in the field of hydrogeology or geotechnical engineering. If the work is undertaken independently, without direct supervision of a well driller or professional who has the qualifications to perform or supervise the prescribed activity, then the person conducting the work is in contravention of the WSA. In that regard, section 106(4)(0) of WSA states that a person commits an offence who "...performs an activity in relation to a well, well pump or wellhead for which qualifications are required under this Act without holding the required qualifications...".

A person is considered to be acting under the direct supervision of a registered well driller or professional if the supervising person:

 Possesses the qualifications with respect to the activity and authority to supervise;



- 2) Confirms in advance to the person being supervised that he or she considers the other person to be "under the direct supervision" of the supervising person for the purposes of section 49 of the *Water Sustainability Act*, and specifies which actions or activities the direct supervision relates to (including any limitations);
- 3) Has the ability to, and does, provide directions at appropriate stages throughout the activity to satisfy himself or herself that the work meets the requirements of the WSA and GWPR;
- 4) Confirms that the supervised person is completing the activity as directed by the supervising person; and
- 5) Takes full responsibility for the activity and the outcomes of work.

You are no doubt aware of the registration requirements under WSA for well drillers and well pump installers. Be advised that a review of the Province's register of qualified well drillers does not identify any person certified or registered as a well driller in the Province of B.C. associated with J.R. Drilling Central Limited Partnership and as such, you may not be working under direct supervision of a registered well driller or professional.

A person who fails to provide proof of qualification as required under section 51(1) of the *Act* commits an offence. A person who performs an activity in relation to a well, well pump or wellhead for which qualifications are required under this *Act* without holding the required qualifications commits an offence. A person who commits an offence is liable on conviction to a fine or imprisonment or both.

<u>Please provide on or before May 10, 2023</u>, the full name, designation, and registration number of:

- (a) The well driller registered with the Province of British Columbia and/or,
- (b) The professional with experience in hydrogeology and registered with the Engineers and Geoscientists of British Columbia (EGBC),

responsible for direct supervision of your work as a well drilling apprentice.

Also mentioned on the call was that someone from the Ministry stopped and asked a driller (in the Kootenays) to see his certification/registration while he was onsite drilling. They were quite surprised that we were checking on them. No other details were provided so I don't know who the parties involved are.
