ISSUE: Houston Sawmill Closure

### **BACKGROUND:**

 On January 25<sup>th</sup> 2023, Canfor announced that they would be temporarily closing their sawmill in Houston, BC for approximately 2 years for restructuring. This announcement included the permanent closure of Canfor's Chetwynd facility.

- Previously, on January 12 Canfor announced it was permanently closing its pulp and paper mill in Prince George.
- The decision to restructure has not been formally approved by Canfor's board of directors.
   That decision is expected by June 2023.
- Houston has a population of approximately 3000. Houston Canfor is one of the main employers in Houston. It is anticipated that the upgraded facility will require fewer employees (estimated at 300).
- Between Canfor's licenses, they have an allowable annual cut (AAC) of approximately 1,045,00 m3 in the Morice Timber Supply Area (TSA).

- Member of Legislative Assembly John Rustad sent a letter to the Honourable David Eby and Honourable Bruce Ralston on January 26 requesting a meeting to discuss the support BC can provide to the district of Houston and Canfor.
- The Associate Deputy Minister of Forests met with Canfor executive on February 22.
  - Canfor stated they want to keep their license active and their local contractors and woodland staff working during the shutdown (estimated at an additional 300 employees). They are in discussion with other major licensees and with BC Timber Sales (BCTS) for the purchase of existing developed volume. Some of the Morice Canfor volume could help support the West Fraser sawmill in Fraser Laker for the next 2 years.
  - Canfor are also looking for assurances around future timber supply in the Morice TSA in advance of their investment decision in June. While there is a potential for modest downward pressure it is one of the more robust and stable timber supply areas in the province. First Nations in this TSA are supportive of the forest industry.
  - Another meeting is scheduled for the end of March prior to Minister Ralston's meeting with Canfor.



- Canfor is working with the United Steelworkers to provide support for transitioning employees.
   They have been in communication with the Ministry of Labour regarding the Bridging to
   Retirement Program and transitioning impacted workers to other job opportunities in the area.
- In coordination with the District of Houston, Staff from the Ministry of Jobs, Economic Development and Innovation (JEDI) facilitated an initial community transition meeting on Tuesday February 28, 2023. In attendance were representatives from Ministry of Social Development and Poverty Reduction (SDPR), Ministry of Labour, Ministry of Post-Secondary Education and Future Skills (PSFS), Service Canada, WorkBC, United Steelworkers, Canfor, and the District of Houston.

#### DISCUSSION:

MLA Rustad has specifically asked the government to provide program support to impacted workers until the rebuild is complete. The JEDI Community Transition Team leads coordinating overall transition supports as well as worker transition and community service supports. The Regional Economic Development Manager provides economic development support to the community.

The Community Transition Team works with a variety of stakeholders including provincial ministries, the federal government, and non-government organizations as well as the private sector. Partnerships are essential to a successful community transition response.

MLA Rustad has also requested that government ensures a forestry environment that supports the rebuild of the Canfor Houston sawmill. Ministry of Forests staff, including BCTS, are working with Canfor to identify needs and support them through this transition. Staff continue to process priority permits and other authorizations requested by Canfor.

Canfor Houston has been working collaboratively with local First Nations, government and other major forest licensees towards furthering stewardship initiatives and opportunities. They have upcoming meetings scheduled with several Nations in the area to discuss areas of concern related to the temporary closure.

#### MINISTRY RESPONSE:

The Ministries of Forests and JEDI are committed to working with both Canfor and the District of Houston to support them through the short-term closure of the Houston sawmill. Canfor wants to minimize the impact to the community by keeping their license active and their local contractors and woodland staff working during the shutdown.

With support from the Ministry of Forests, the Ministries of Labour, JEDI, and PSFS have a suite of supports for workers, communities and First Nations to offset economic and community impacts resulting from downturns in the forest sector. This includes skills training, short-term employment opportunities, employment assistance, and retirement transition support for workers who are 55 years old or older (Attachment 1).s.13; s.17

s.13; s.17 Government has also established a Forestry Worker Support and Community Resiliency Council (FWSCRC) chaired by Parliamentary Secretary Routley, to provide further advice on community and worker support.

Worker transition supports will continue as long as the need is identified by the local government and key stakeholders. Economic development supports will continue beyond the transition response as part of a comprehensive strategy towards long term community sustainability.

# **Executive Summary:**

Western is an integrated Canadian forest products company with approximately 2,000 employees, managing forests and manufacturing wood products and is the largest operation on the Coast with approximately 38% of the timber harvest rights, 6 sawmills, 2 value added facilities (Attachment 1) with a total of 1 billion board feet production capacity. s.13; s.16



**ISSUE:** New Mandate Letter for Forest Enhancement Society of BC

RECOMMENDATION: Approve that there are no new priorities for the Forest Enhancement

Society of BC

#### **BACKGROUND:**

 New Mandate Letters will be required for all Crown Agencies that previously received them from government, as required by the Premier's Office.

- The Crown Agencies and Board Resourcing Office (CABRO) is introducing a streamlined process to update Mandate Letters for Crown Agencies.
- Cabinet Submission will be required <u>only</u> for those Crown Agencies that have new proposed priorities for the next 18 months.
- For Crown Agencies with no new priorities, CABRO will coordinate their Mandate Letters to either DMCSI or DMCE. ADM committee review will not be required.
- This streamlined approach will free up resources at Cabinet.
- Minister of Forests is responsible for the Crown Agency Forest Enhancement Society of BC (FESBC).
- Ministry of Forests must submit a deputy minister approved declaration on whether there are any new proposed priorities for FESBC, by March 30, 2023.

#### DISCUSSION:

FESBC is a service delivery Crown Agency that was formed in 2016. FESBC contributes to the achievement of Government's strategic priorities through the delivery of its constitutional purposes:

- Prevent and mitigate the impact of wildfire,
- Improve damaged or low-value forests,
- Improve habitat for wildlife,
- Support the use of fibre from damaged and low-value forests, and
- Treat forests to improve the management of greenhouse gas (GHG) emissions.

On January 19, 2023, Premier Eby announced \$50 million of new funding to FESBC and specified that the new funding would be used to improve fibre utilization. The new funding is provided as part of Budget 2023.

As this specific focus is within the purpose of FESBC, no new priorities are identified.

Premier's direction for the new funding can be captured in the refreshed Mandate Letter for FESBC.
