BUSINESS EXPENSE APPROVAL FORM INSTRUCTIONS

BUSINESS MEETING AND PROTOCOL EVENT EXPENSE POLICY HIGHLIGHTS

Refer to CPPM 18.3.4 for a complete list of government policies.

- BC Government facilities should be used for business meetings/protocol events when available in accordance with CPPM 18.3.4
- Meal expenses are not appropriate when a meeting can reasonably be adjourned over the meal period.
- A BEA form is not required for claims that are \$30 or less.

GENERAL INFORMATION

A Business Expense Approval (BEA) form is required to obtain pre-approval and support claims for all costs associated with business meetings/protocol events, excluding travel costs for BC government employees and meeting registration fees. A BEA form is also required for the purchase of protocol related gifts (e.g. when required for foreign dignitaries). One BEA Form is usually completed for each event. "Blanket" BEA forms may be used to cover costs of regularly scheduled meetings over a fiscal year – in these cases attach a photocopy of the BEA form to support receipts.

FORM COMPLETION

SECTION 1 - ORIGINATOR INFORMATION

This section should be completed by the originator of the business meeting/protocol event expense.

SECTION 2 - NAME/NATURE OF EVENT

Describe the nature of the expense. In general terms, name the event, the number of people and the affiliation of those attending. For example: Annual Regional Meeting – 20 BC Government employees, 2 service contractors.

SECTION 3 - INDIVIDUALS INCLUDED IN MEAL CLAIMS

Complete this section **only** if a meal is included in the claim. For all individuals who had their meal provided, identify their name and either the Ministry or company they are affiliated with. If necessary, attach a separate list. This information is required in order to cross reference to travel vouchers and service contract invoices to ensure duplicate meal claims are not made.

SECTION 4 - BUSINESS EXPENSES REQUESTED

Identify an estimated amount in the appropriate categories. Identify an "Estimated Total" for the claim. The estimated total should not be exceeded.

Subsequent approval for business meeting/protocol event expenses is not required when the actual cost exceeds the maximum estimated total cost, if **all** the following conditions are met:

- a) the nature of the business meeting/protocol event has not changed;
- b) the overage of costs is minimal (reasonable); and
- c) the actual amount remains within the approval level of the delegated ministry official who pre-approved the business meeting/protocol event expense.

If **ALL** conditions are not met, subsequent approval by the appropriate expense authority is required.

Enter the appropriate STOB if it is not identified (categories 6, 7 and 8).

SECTION 4 (cont'd)

Category 1: Identify the cost of the meeting room.

Category 2: Identify costs associated with renting equipment/furniture (e.g. overhead projectors, coffee machines, etc).

Category 3: Identify office services charged by the facility (e.g. photocopying, faxing, telephone charges).

Category 4: For business meetings/protocol events held in a government or commercial facility, identify the type of food and/or beverages provided.

Category 5: For business meetings/protocol events involving meals in restaurants, identify the type of meal.

Category 6: Identify costs associated with payments to event planners, speakers, performers, etc.

Category 7: Identify costs associated with paying travel expenses for non-BC Government participants.

Category 8: Identify any "other" business expenses not identified in Categories 1 through 7. "Other" would include protocol gifts for foreign dignitaries.

SECTION 5 - EXPENSE AUTHORITY PRE-APPROVAL

This section is to be completed and approved by the appropriate expense authority official prior to the event. Note that pre-approval may be obtained via e-mail instead of completing Section 5, as long as the e-mail request identifies the nature of the business expense and the estimated total. In these cases, attach the approved e-mail to the BEA form when submitting claims for processing.

SECTION 6 - EMPLOYEE REIMBURSEMENT INFORMATION

Complete this section **only** if reimbursing an employee for expenses they have paid personally. Enter the payee name, cheque mailing address, and reimbursement total. The employee signs as Qualified Receiver certifying for goods/ services received. For other payees, the payee information will be reflected on their attached invoice.

GMTRP Early Works

April 4, 2017

Key Messages:

- We've taken another important step in the project to replace the George Massey Tunnel – now identified as one of the worst traffic bottlenecks in the entire country.
- Two contracts for preliminary construction work on the George Massey Tunnel Replacement Project have been awarded.
- The contracts are for site preparation in order to improve ground conditions for future lane widening and work will begin in the next few weeks.
- The new bridge and associated highway improvements, including dedicated transit lanes, will cut some commute times in half and also improve travel-time reliability for the 10,000 transit passengers and more than 80,000 vehicles that use the tunnel each day.
- Safety benefits of the project include a design that meets modern seismic standards, additional lanes that make merging safer for all vehicles while reducing collisions by an estimated 35%, and wider lanes and shoulders that will improve safety and emergency response times.

2. Why are there two contracts for the same work?

- This is considerable work, which needs to be done in a timely manner.
- Because of the difficulties moving construction equipment through the congested tunnel, it was deemed more efficient to tender one contract for work north of the tunnel and one contract for work south of the tunnel.

3. Is there any additional permitting required to proceed with site preparation?

- We required permitting from the Ministry of Forests, Lands and Natural Resource Operations for ditch work north of the tunnel.
- As well, we'll need Environmental Assessment Office approval on the environmental management plan for the site preparation work.
- Those applications have been submitted and approvals received.

4. Mayor Brodie has been a critic of the project. Does the City of Richmond need to approve any of this site preparation work?

- No. All work is happening on ministry right-of-way.
- The Project team has had more than 125 meetings with City of Richmond staff which has provided input into the project over the last 3 years.

5. Will many trees along Highway 99 need to be removed?

- Invasive plants, brush and small trees will be removed within Ministry right of way in Richmond and Delta
- In Richmond, the majority of work will be adjacent to Highway 99 between Westminster Highway and Blundell Road.
- In Delta, the work is adjacent to Highway 99 between Highway 17 and 104th Street.

6. Will sound walls or new plantings replace those trees that will been removed?

- When construction has been completed, the areas will be restored and improved with new plantings.
- Restoration will include revegetation of cleared areas with native species appropriate for the site conditions.
- This is expected to yield ecological benefits relative to existing conditions.

7. What is the ministry doing on the property next to Westminster Highway at No. 5 Road?

- The property bordered by Highway 99, Westminster Highway and No. 5 Road is ministry right-of-way.
- Surplus soil from the ditch work is being stored by the contractor on this property with the ultimate goal of creating an environmental enhancement area on the site after the project is complete.
- Throughout the project, we expect this site will be used for storage of materials and equipment.
- However, the ministry intends to keep this site as natural as possible and incorporate many of the larger trees in the environmental enhancement area.

8. Will there be any traffic delays as a result of this work?

- Traffic will be maintained throughout construction.
- It will be a requirement for the contractor to maintain current traffic service, particularly during rush hour and daytime periods.
- We do anticipate considerable work at night.

9. Have you started to secure the land you'll need?

 Yes. We have been in discussion with all affected land owners and anticipate all property acquisitions to be completed over the coming months.

Tolling:

14. With some bridges tolled and others not, isn't it time to review the Province's policy on tolling?

- Construction on this project is anticipated to begin this year followed by a five-year construction period.
- Everyone is aware of the vibrant debate about Metro Vancouver's transportation future, including suggestions from the public that all bridges in the region should be tolled.
- This and other ideas are certainly things all governments are listening to.

15. Are you considering mobility pricing on the Lower Mainland?

- The Mayors' Council has expressed interest in mobility pricing as a possible funding mechanism for transit investments.
- But mobility pricing is a complex topic.
- When we hear from representatives of local governments or different stakeholders, there is no clear agreement on what mobility pricing is.
- Definitions and ideas range from tolls, congestion pricing, time of day, distance-based and how mobility pricing is applied around the world varies from city to city.
- I look forward to hearing more information about the work TransLink is undertaking on this topic.

16. How will the project be paid for?

The Province intends to fund the project through user tolls.

 The Province is also seeking a contribution from the federal government.

17. What will the toll be on opening day?

- With five years before completion, we have some time to ensure the toll will be as affordable as possible for motorists.
- At this point, we expect the toll on opening will be comparable to the toll rates on the Port Mann Bridge.
- Long repayment periods give flexibility for toll rates to be set at a level that attracts traffic, but still allow the bridge to pay for itself well within the useful life of the asset, without using general tax revenues.
- As with the Port Mann Bridge, motorists using the new bridge will see real-time savings.

18. How long will the toll remain?

- It depends on the final cost, availability of federal funding or other sources, prevailing interest rates, the toll rate and actual traffic volumes.
- The lower the toll rate and the higher the cost, the longer it takes to repay.
- Once capital costs are finalized and all funding sources are secured for the new bridge, we expect to be able to achieve a similar timeframe as the Port Mann Bridge for repayment of this project.
- Long repayment periods give flexibility for toll rates to be set at a level that attracts traffic, but still allow the bridge to pay for itself well within the useful life of the asset, without using general tax revenues.

19. Will tolling for the new bridge be consistent with TReO?

 Yes. TI Corp, with its TReO tolling system, has proven experience in efficient toll operation and administration, as well as a strong record of customer service.

20. Will Port Mann toll revenue go to fund GMTRP debt, or vice versa?

 Both projects are self-sustaining and TI Corp has ensured that the ability exists to repay both assets and meet all financial obligations within the required timeframes.

21. The North Shore bridges aren't tolled, and yet the replacements for the tunnel and the Pattullo Bridge will be. How is this fair for those living south of the Fraser River?

- Those living south of the Fraser River are benefitting from new infrastructure that's providing significant travel time savings – about an hour a day on the Port Mann, and an estimated 30 minutes a day on the tunnel replacement.
- As well, government has announced improvements to the Alex Fraser Bridge that will save time for commuters using that crossing.

22. Your tolling policy requires you to engage in public consultation before introducing a new toll. When will that happen?

 This happened during the last consultation, when we encouraged the public to provide feedback about the decision to toll, as well as on the rest of the Project Definition Report (PDR).

23. There are doubts that tolls on the Port Mann will retire its debt in time. How will you pay off another \$3.5 billion project through tolls alone?

- Port Mann is on track to retire its debt on schedule. Its financial outlook continues to improve, with traffic up four per cent from last year.
- Long-term interest rates are at historical lows, much lower than when the Port Mann Bridge was financed.
- Based on the analysis to support the business case, we are confident the project costs can be fully recovered with tolls, even

with lower traffic volumes.

 We've considered the experience with the new Port Mann Bridge and have factored that in to our traffic forecasts and the project business case, which confirms that costs for the project can be fully recovered with user tolls.



Introduction:

- Good morning. Thank you all for coming, as we gather on the traditional territories of the Coast Salish.
- After four years of extensive consultation, hundreds of meetings with regional governments and First Nations, and a tremendous amount of technical work, construction is underway on the George Massey Tunnel Replacement Project!
- The site preparation work here, and on the north side of the tunnel in Richmond, represents the first construction work on Massey replacement.
- This project will end up generating about 9,000 good-paying, highly-skilled jobs over the life of the project.

About GMT Replacement:

- The George Massey Tunnel Replacement Project includes construction of a new 10-lane bridge to replace the aging tunnel.
- It will have eight travel lanes, plus two dedicated transit/HOV lanes.
- It will also include improvements to Highway 99 between Bridgeport Road in Richmond and Highway 91 in Delta, and three new highway interchanges.
- Key benefits of the project will be:
 - o A continued commitment to world-class transit.
 - o Environmental enhancement and restoration.
 - o Improved safety and seismic resilience.
 - o Improved traffic movement.
 - And most importantly to our provincial economy, a more efficient movement of goods and services along the Highway 99 corridor.
- Procurement is underway for the major construction contract.
- We expect to have that in place this summer, with major construction beginning later this year.
- And in 2022 a new 10-lane bridge will be serving motorists, cyclists and pedestrians on this important corridor.
- The total project cost is estimated at \$3.5 billion.

Transit:

- Over the past four years, I've heard the argument that the money would be better spent on improvements to transit.
- I think infrastructure improvements and transit improvements go hand-in-hand.
- As the population of the region continues to grow, it's important to invest in each and that's exactly what we're doing.
- Last Friday, you heard TransLink announce the biggest bus service hour increase in a single service change since 2010 65-thousand more bus service hours to 26 routes beginning later this April.
- This is the result of the collective efforts of all three levels of government.
- Also on Friday, you heard Minister Fassbender with our government's commitment of \$2.2 billion in matching funds for new transit projects in Metro Vancouver.
- This means \$4.4 billion in senior government funding is now committed for the Lower Mainland's transit priorities.
- This includes rapid transit in Surrey and along the Broadway corridor in Vancouver.
- Our Port Mann/Highway 1 project has also supported transit improvements.

- It allowed transit service to cross the Port Mann for the first time in 25 years and now over 50,000 people a month take Express Bus service over the bridge.
- The George Massey Tunnel Replacement Project will see over \$500 million in transit improvements.
- Along with travel time reliability, we'll be able to building on the than 10,000 transit riders that already use this corridor daily.

Environmental Enhancement:

- Throughout our project development, we've gone to great lengths to ensure the George Massey Tunnel Replacement Project benefits the environment, and enhances liveability in the Lower Mainland.
- Following an extremely thorough environmental review, we've received our Environmental Assessment Certificate for the project.
- The project team will ensure full compliance to the key conditions set out in this approval.
- I want to thank those who took the time to participate in the environmental assessment process.
- We've also received our approval from the Agricultural Land Commission.
- When the project is complete, we will return surplus lands to agriculture, and may even see a net gain in that regard.

- I thank the Delta Farmers' Institute and Richmond Farmers' Institute for their input these last four years.
- These have been important meetings, given the significance of agriculture to the Richmond and Delta economies.
- Among the benefits this project will have for farmers in the region will be improved drainage for fields, and better access for getting produce to market.

Improved Safety:

- Delta's Fire and Emergency Services Chief Dan Copeland is here. So is Delta Police Chief Neil Dubord.
- I want to thank you and your personnel for the work you do. I know it's extremely difficult.
- And that work is even more challenging in the confined space of the Massey Tunnel.
- When there's a crash in the tunnel, or a car fire like what happened on March 9th, you're the ones who rush to the rescue sometimes carrying your gear with you when you can't get a vehicle close enough.
- This project will see Highway 99 upgraded to modern engineering standards to increase safety for drivers.
- Motorists will have longer merge lanes, wider travel lanes, improved sight lines and increased vertical clearances at overpasses.

- We estimate that collisions will be reduced by more than 35%.
- And when our first responders do have to attend a call, easier access means a more timely response – and in safer working conditions.
- It has also been a challenge to bring the existing tunnel up to modern seismic standards. Some seismic work has been done, but we're at risk of damaging the tunnel by doing further seismic upgrades.
- In the event of a major earthquake, it's extremely important that Highway 99 be a lifeline crossing.
- The new bridge will be built to modern seismic standards, designed to withstand a 1-in-2,475-year seismic event.
- I've heard critics suggest that it can't be done.
- Let me say this: thousands of hours of professional geotechnical and bridge structural engineering have been dedicated to ensuring that the new George Massey replacement bridge and its supports are appropriately designed for the conditions at the crossing site, and for a major seismic event.
- The bridge will be the same height above the water as the Alex Fraser Bridge.
- Due to its location, with flat land on each side and the need to cross a shipping channel, it will be about 3 kilometers long that's 65% longer than the Port Mann, and 32% longer than the Alex Fraser.

Improved Traffic and Goods Movement:

- But the project is more than a new bridge.
- It also includes improvements that will enhance traffic flow and safety, taking into consideration current and forecast future demand for travel, based on local and regional population and employment growth plans.
- As well, careful planning will ensure that Highway 99 will continue to serve existing traffic volumes and patterns during construction, including maintaining the counter flow during rush hour.
- This is important, because Highway 99 is a major corridor for commuters as well as goods and services, with connections to the Canada-U.S. border, YVR, Roberts Bank, Boundary Bay Airport, port facilities on both sides of the Fraser River, and commercial hubs in Delta, Richmond, Surrey and Vancouver.
- Truck traffic at the George Massey Tunnel is forecast to more than double in the next 30 years.
- This bridge will remove the bottleneck, which will eliminate over one million hours of vehicle idling each year.
- 200 lane-kilometres of improved and rehabilitated highway will relieve congestion.
- Construction of 14 new overpass and ramp structures will improve the efficiency of Highway 99 and its feeder roads.
- And for the first time ever at this location, walking and cycling will be viable transportation options, as the new

bridge will include a multi-use pathway with connections to Steveston Highway and to River Road.

Conclusion

- This project is a massive undertaking with benefits that will be felt across the entire region.
- And it all starts with site preparation, which is getting underway in both Richmond and Delta.
- So let's get busy! Let's get work underway, so we can eliminate the worst traffic bottleneck in the province, and get traffic moving again through Delta and Richmond on Highway 99.
- It's a privilege to represent hard working women and men of Kamloops South Thompson in British Columbia's Legislature.

George Massey Tunnel replacement construction officially underway

DELTA – Transportation and Infrastructure Minister Todd Stone, Delta Mayor Lois E. Jackson and other dignitaries were on hand today to officially kick off construction on the George Massey Tunnel Replacement Project.

"After four years of consultation with First Nations, municipal and regional governments, and a tremendous amount of technical work, construction is underway on the George Massey Tunnel Replacement Project, which includes replacing the seismically vulnerable tunnel with a safe, modern bridge," said Stone. "These site preparation contracts represent the first work on the Massey replacement, which will generate approximately 9,000 direct jobs over the life of the project."

"This project will address the needs of our residents, the agricultural community, local business, commerce, and industry, by aiding in the movement of people and goods throughout the Lower Mainland, while also improving the safety and quality of life of our citizens," said Jackson. "This project is a testament to what can be accomplished when multiple levels of government work together for the benefit of all. May I personally congratulate and thank Premier Christy Clark for her foresight and vision, as we look forward to continuing to work with the Province on the completion of such a vital piece of infrastructure that will benefit the Lower Mainland now, and for many years to come."

Two contracts have been awarded for site preparation work to improve drainage and ground conditions in advance of major project construction. Hall Constructors of Surrey has been awarded an \$11.5-million contract for site preparation work south of the tunnel.

"We're excited to be a small part of history as our crew begins the work on the George Massey Tunnel Replacement Project," said Chad Tenney, vice president of Hall Constructors. "The good jobs created by this project will benefit our employees and their families, and the many others who will work on the project over the next five years."

A contract valued at \$5.8 million has been awarded to B&B Heavy Civil Construction of Surrey for site preparation along Highway 99 between Bridgeport Road and Steveston Highway. The total cost of the George Massey Tunnel Improvement Project is estimated at \$3.5 billion.

This site preparation work includes ditch improvements and the placement of pre-load material on soft soils immediately adjacent to the existing highway. Pre-load work is standard practice on most major highway construction projects. Soil is piled to compress the existing ground in advance of the main work, which will minimize settlement following construction.

The process to award the major construction works contract is still underway, and the Province expects to have its preferred proponent chosen by summer 2017. All major approvals are in

place for the project to proceed, including the project's Environmental Assessment Certificate, awarded on Feb. 9, and approval from the Agricultural Land Commission received on Feb. 24.

"We appreciate the ministry's responsiveness to input and concerns around agricultural issues relating to the project," said Richmond Farmers' Institute president Todd May. "The inclusion of the Richmond Farmers' Institute during the consultation process has further solidified the relationship between government and farming families in enhancing agricultural viability now and into the future."

The new bridge and associated highway improvements, including dedicated transit lanes, will cut some commute times in half and also improve travel-time reliability for the 10,000 transit passengers and more than 80,000 vehicles that use the tunnel each day. The project includes over \$500 million in transit infrastructure.

The new bridge will include a multi-use pathway with connections to Steveston Highway and to River Road, making walking and cycling viable transportation options at this location for the first time ever.

The existing 60-year-old tunnel does not meet current seismic standards, nor can it be brought up to current standards without risk of damage, which could render the crossing unusable. The new bridge will be built to modern seismic standards, providing a lifeline crossing over the Fraser River in the event of a major earthquake.

Other safety benefits of the project include additional lanes that make merging safer for all vehicles while reducing collisions by an estimated 35%, and wider lanes and shoulders that will improve safety and emergency response times.

After site preparation, major construction will begin later this year with the new bridge opening in 2022. Tunnel decommissioning will follow.
