#### **Setting the stage for a referendum on proportional representation - October 5, 2017**

Today in the Legislature the BC Government introduced **Bill 6: Electoral Reform Referendum 2018 Act**. This Bill provides the legal framework for Elections BC to conduct a referendum before November 30 2018 on proportional representation.

We are absolutely thrilled with the introduction of this Bill. It fulfills a major promise of the Confidence and Supply Agreement that we signed with the BC NDP. In their summer throne speech, the BC Liberals also supported a referendum on proportional representation. As such, I hope that they will also support this bill to ensure that it is adopted unanimously.

In response to the **government’s announcement**, my colleagues in the BC Green Caucus (Adam Olsen and Sonia Furstenau) and I sent a **letter to the Premier** supporting the fact that the Attorney General will be acting as an independent official and that his office will be responsible for drafting the referendum process and question. In the letter we note that to further ensure that the Attorney General’s office can operate with independence, we will not seek to consult with his office when it comes to evaluating submissions that are made to the ministry during the public engagement phase, or on the subsequent decisions regarding the development of a referendum process and referendum question.

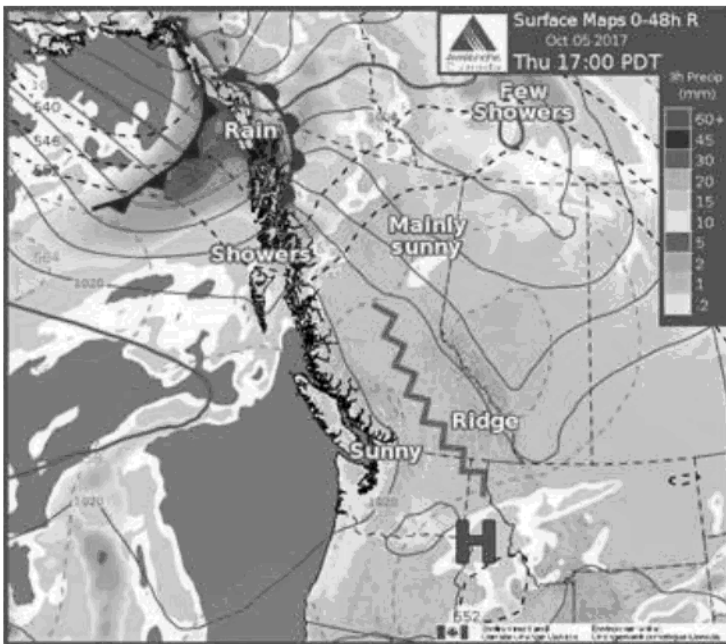

### **EMBC UPDATE – October 02, 2017 AS OF 0700 HRS – ASSESSMENT**

There have been no significant new incidents in the province in the last 24 hours.

#### **PROVINCIAL WEATHER**

This morning a winter storm will be affecting southern Alberta as a modified Arctic air mass drops south across the area behind an intense low in southern Saskatchewan. The western edge of the storm will brush the South Rockies, the Lizard Range, the Purcells and eastern sections of the Kootenay ranges today. Near the Alberta border freezing levels will be at or near valley bottom with precipitation falling strictly as snow. Accumulations of 5 to 10 cm of snow can be expected over the Elk Valley region with amounts of 20 cm possible near the BC/Alberta border. Over the Purcells and East Kootenays freezing levels should be in the 1000 to 1500m range meaning valley bottoms will experience rain while the alpine sees snow. Snowfall amounts will quickly drop off the further west one goes with only about 2 to 5cm expected for Kimberly and the Kootenay Pass areas. The remainder of the province will enjoy sunny mild weather as a ridge of high pressure builds across the central interior. The high pressure will induce moderate outflow winds through the valleys and fiords of the central and south Coast Ranges.

Skies will clear across the southeast corner of the province on Tuesday morning. The rest of the province will awake to clear cool weather. The next Pacific storm will head northeastward towards the southwestern Yukon.

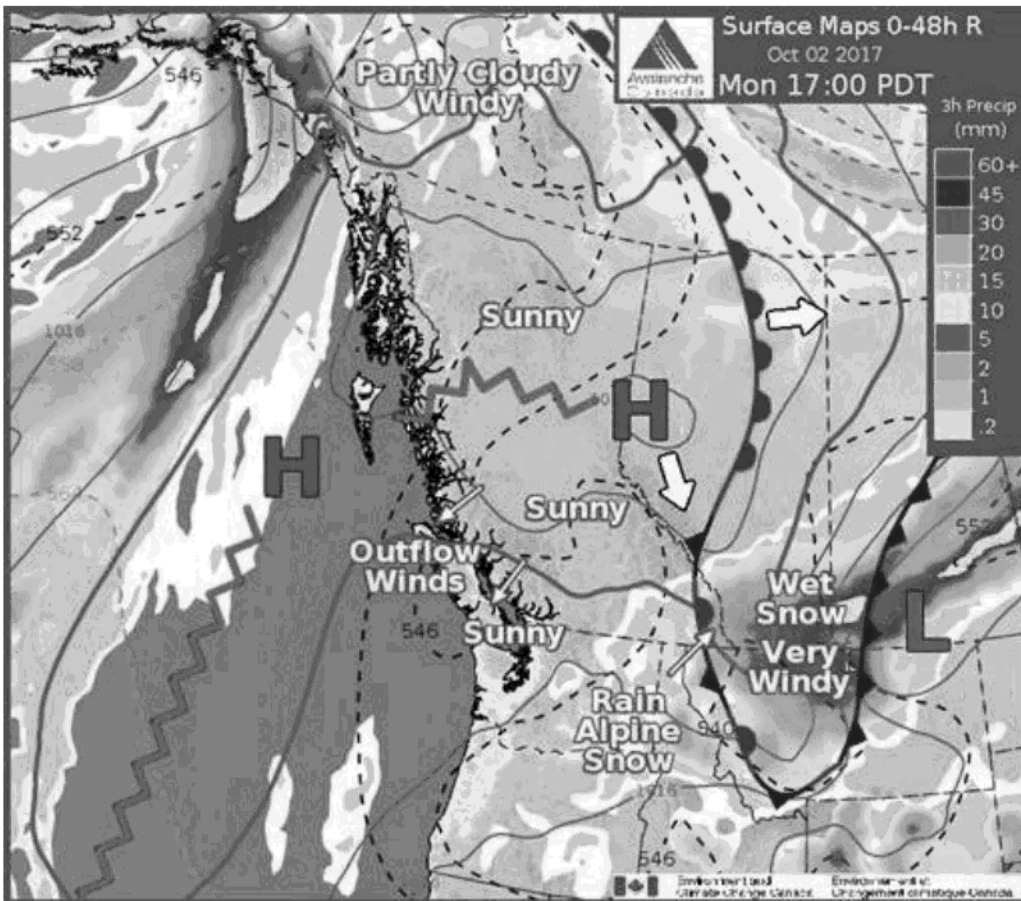

### **EMBC UPDATE – October 01, 2017 AS OF 0700 HRS – ASSESSMENT**

There have been no significant new incidents in the province in the last 24 hours.

#### **PROVINCIAL WEATHER**

A cool upper trough lies over the province today. This unstable air mass will continue to produce scattered afternoon and evening showers across most of southern and central BC. Alpine flurries are expected although no significant accumulations are forecast.

The other weather feature of note is a low-pressure system developing over the southern Prairies. This low will draw a modified arctic air mass southward across the Fort Nelson and BC Peace regions today. As the low in the southern Prairies intensifies tonight, strong northerly winds will develop over Alberta funneling the colder air mass rapidly southward along the east slopes of the Rockies reaching all the way down to the Alberta/Montana border by Monday morning. The colder air interacting with the moisture wrapping around the low will result in rain changing to snow over the eastern slopes of the southern Rockies. Accumulations will likely be significant in some areas.

Beginning on Monday, all other mountain ranges across the province will be influenced by an upper ridge over the eastern Pacific. The ridge will slowly drift across the province through the week providing a few days of fine fall weather.

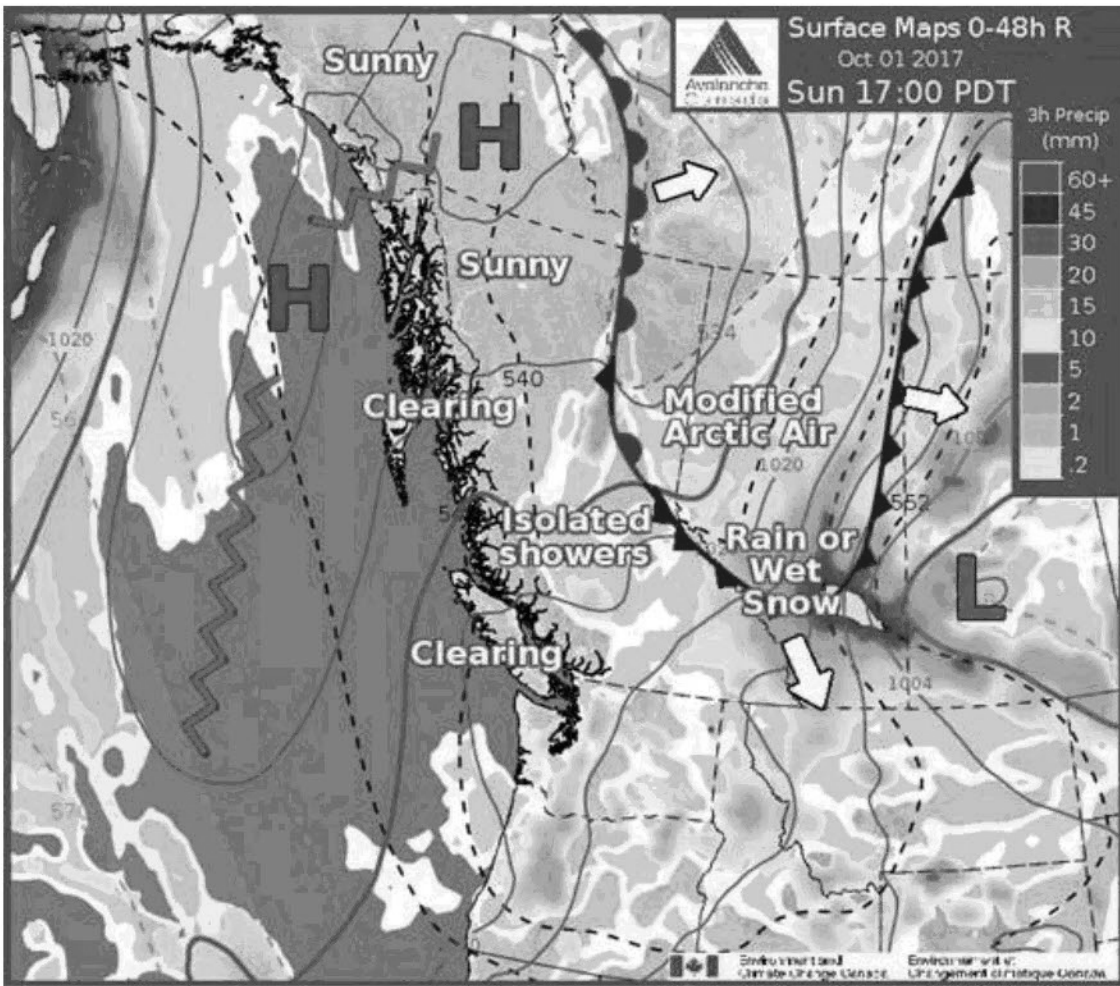

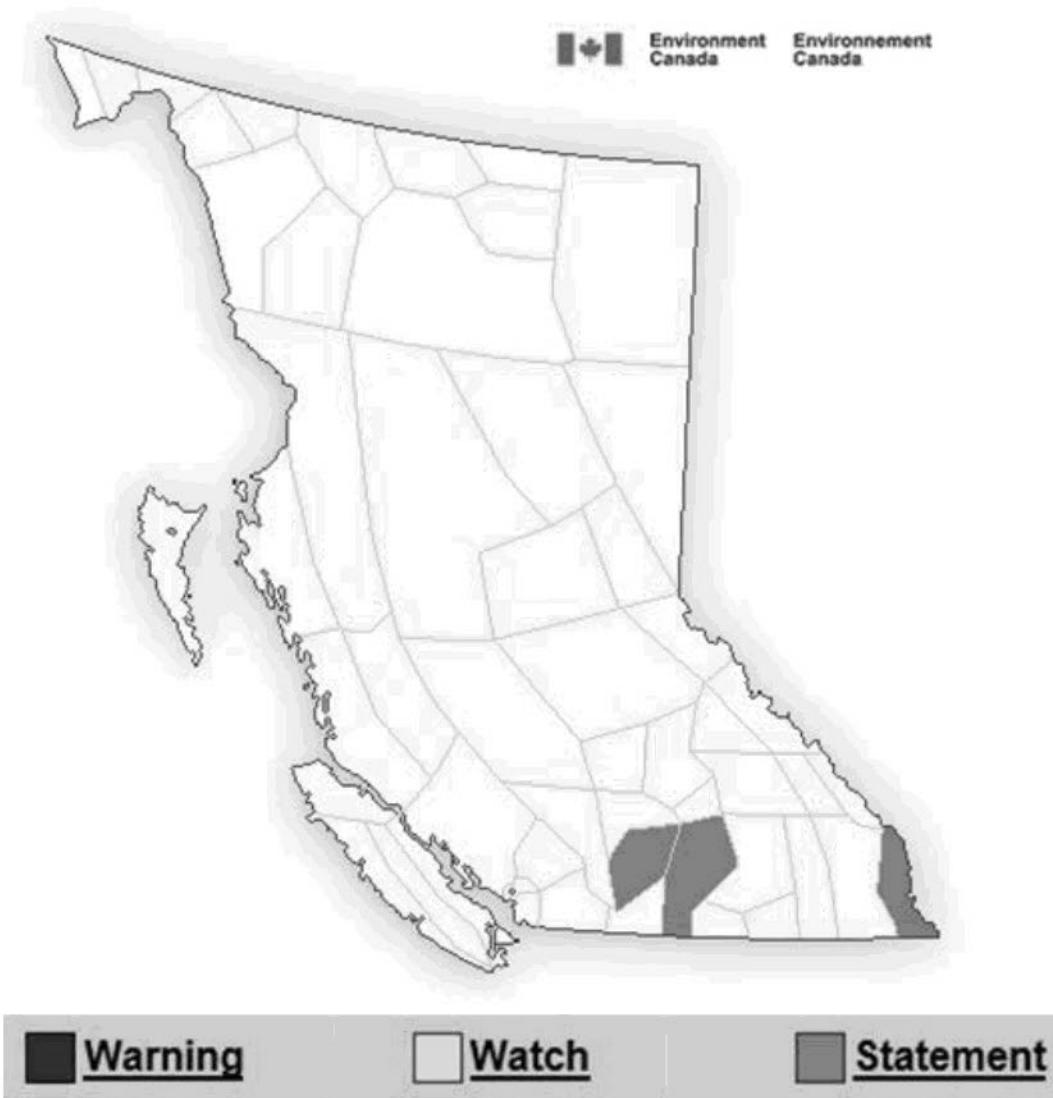
