ISSUE SUMMARY

The Environmental Assessment Office (EAO) has released its Site C inspection record on BC Hydro's cultural and heritage resources management in the Cache Creek/Bear Flat area for the Highway 29 realignment.

The report concludes that the updated, refined design of the Cache Creek bridge, if built, would not be compliant with the Site C project's Environmental Assessment Certificate (EAC). Construction activities for the bridge have not yet started.

The review also identified areas that the project's Heritage Resources Management Plan and Cultural Resources Mitigation Plan can be improved. BC hydro is updating these plans in response.

No orders were issued from the inspection.

BACKGROUND

- In April 2017, Nun wa dee Stewardship Society which represents West Moberly First Nations and Prophet River First Nation – filed a complaint with the EAO regarding the Highway 29 realignment at Cache Creek/Bear Flat.
- Their main concern is with BC Hydro's Highway 29 realignment at Cache Creek, due to its proximity to a sweat lodge and potential First Nation burial site.
- BC Hydro has been working with other First Nation groups in the area to mitigate the impacts of the realignment; however, the mitigations proposed do not satisfy the concerns of West Moberly First Nations and Prophet River First Nation.
- As part of the EAO's review of the complaint, it identified that the current bridge design is
 different than the bridge design filed in the Site C Project Description (changed from a combined
 bridge and causeway to a longer bridge), which is attached to the project's EAC.
- The EAO has noted in the inspection report, that if BC Hydro were to proceed with construction
 of the bridge as currently planned, an amendment to the project's EAC will be required.
- BC Hydro is taking into account the EAO's findings and looking at further options.

KEY MESSAGES

Highway 29 work

BC Hydro describes its work to realign six segments of Highway 29, the "arterial highway that connects Hudson's Hope to Fort St. John, running along the north side of the Peace River"₈₂, to avoid flooding by the Site C reservoir. This work was scheduled to commence in summer 2017, in anticipation of the river diversion in fall 2019, but in June 2017 BC Hydro was requested to "delay the start of this work to allow further discussions with local property owners and consultation with Aboriginal Groups". This postponement would have risked delaying the river diversion.

However, the Ministry of Transportation and Infrastructure, under whose jurisdiction the road lies, has since advised that they are "willing to discuss the implementation of mitigation measures that would manage the risk of flooding while allowing River Diversion to continue"83. BC

Hydro states that this development will allow the river diversion to

proceed despite the postponement of highway work.

Deloitte does not comment on the highway 29 work in its description of project risks 84.

Hi Katherine: Further to our phone conversation just now, here is the updated language provided for us this morning by MoTI related to the highway 29 realignment. This is from the QA we prepared to support today's announcement on the BCUC review of Site C.

How will the BCUC review impact BC Hydro's plans to remove property owners from their homes and procure contracts for the Highway 29 Bear Flats to Cache Creek re-alignment?

- BC Hydro has been in contact with property owners to advise that no action will be taken to remove them from their homes prior to the conclusion of this review.
- Highway 29 Bear Flats to Cache Creek contracts will be deferred pending the results of the BCUC review.
- The Ministry is working with BC Hydro to find ways to mitigate the potential for the highway closures should the schedule be delayed and is confident that there are available mitigation options. One example is the option to build a temporary detour bridge and road alignment adjacent to the Cache Creek Bridge. This temporary detour bridge and alignment will not affect the timeline of the project if the BCUC review shows it should proceed.

Thanks Les. Further to the background section on the highway 29 re-alignment we wanted to add bullets related to the diversion of highway 29. Look ok:

If asked – about Highway 29 re-alignment:

- The delay in the project and the budget increase is not related to the suspension of work on Highway 29.
- Work to re-align Highway 29 was suspended in June to allow impacted property owners to stay on their land pending a government decision on the future of the project and to allow BC Hydro to consult further with First Nations on the proposed route for the re-alignment.
- Back in June there was an assumption that work on the highway had to start this past summer in order to be complete ahead of river diversion in September 2019.
- However, as described in the BCUC's preliminary report, since that time, the Ministry
 of Transportation has proposed mitigation measures that would have allowed the
 river diversion to proceed in fall 2019 despite the postponement of highway work.
- It's also worth noting that Deloitte did not comment on the highway 29 work in its description of project risks

Response:

Last week, the Environmental Assessment Office provided feedback that the refined design of the Cache Creek Bridge, which is required for the Highway 29 realignment, would not be compliant with the Site C Environmental Assessment Certificate, if built as currently planned.

The initial bridge design, which was filed in the Site C project description, was for a short bridge with causeway. Last year, we refined the design to address geotechnical issues in the area and to mitigate impacts to a potential burial site, which resulted in a longer bridge design. The reason it would be non-compliant is because current bridge design is different than what we filed in the project description. The remainder of the Highway 29 realignment at Cache Creek remains compliant with the project description.

As you are aware, work related to the Highway 29 realignment is on hold (and construction activities for the bridge haven't started) while the project is reviewed by the BCUC. We are currently looking at alternate options to address this issue.

The EAO also identified some opportunities for us to improve cultural and heritage resources management. We've already made changes to our plans to provide greater clarity on effectively managing cultural and heritage resources.

- The Bear Flats to Cache Creek section is the first of six sections of Highway 29 that need to be relocated to accommodate the proposed Site C reservoir.
- The Bear Flats to Cache Creek was scheduled to be tendered in two contracts, the road construction and bridge construction.
- The road contract tender is being cancelled today; the bridge contract has not been tendered yet.
- Approximately 8.5km of road will be reconstructed in this project and the bridge design is 455m long.

What are the risks of deferring the road tender package?

- Should the highway relocation proceed following the BCUC review, the road and bridge relocation completion dates may be delayed into another construction season.
- In this event, there is a small chance that a short section of existing highway, including the Cache Creek Bridge, will be impacted by a combination of flooding caused by the dam construction and spring freshet in the coming years.

- The Ministry is working with BC Hydro to find ways to mitigate the potential for the highway closures and is confident that there are solid mitigation options.
- One example is the option to build a temporary detour bridge and road alignment adjacent to the Cache Creek Bridge.
- This temporary detour bridge and alignment will not affect the timeline of the project if the BCUC review shows it should proceed.
- Again I'm confident that the ministry and BC Hydro will be able to put together strategies to mitigate any impacts to the timeline.

How much is this going to cost?

· We do not have a firm estimate at this time.

When are the remaining sections of Highway 29 scheduled to be released?

- Pending the results of the BCUC review, the remaining sections are all scheduled to be tendered over the next few years.
- The project team is working towards having all the impacted sections of highway moved prior to the full inundation of the reservoir in 2023.

By sending the Site C project to BCUC for review, what are the implications of this delay on the project's timeline?

- The ministry has done a thorough technical review on the implications of deferring the Highway 29 realignment, which includes building a temporary detour bridge and alignment while a long term realignment is finished.
- This temporary detour bridge and alignment will not affect the timeline of the project if the BCUC review shows it should proceed, and I'm confident that the ministry and BC Hydro will be able to put together strategies to mitigate any impacts to the timeline.

What about reports that suggest the project would lose \$600M if this realignment did not take place?

- This is a question you'll have to ask BC Hydro.
- Again, provided the BCUC review concludes that the Site C project should continue, the ministry is confident that the work will be done in accordance with the original timeline.
