Hi Karl- we'd like to request a photographer to accompany Minister Bains to an event on Nov 25 (Saturday) to the West Coast Domestic Workers' Association about temporary foreign workers. Our Minister will be speaking about a mandate letter priority, that is government's plans to create a Temporary Foreign Worker registry and other ways government will protect and support temporary foreign workers.

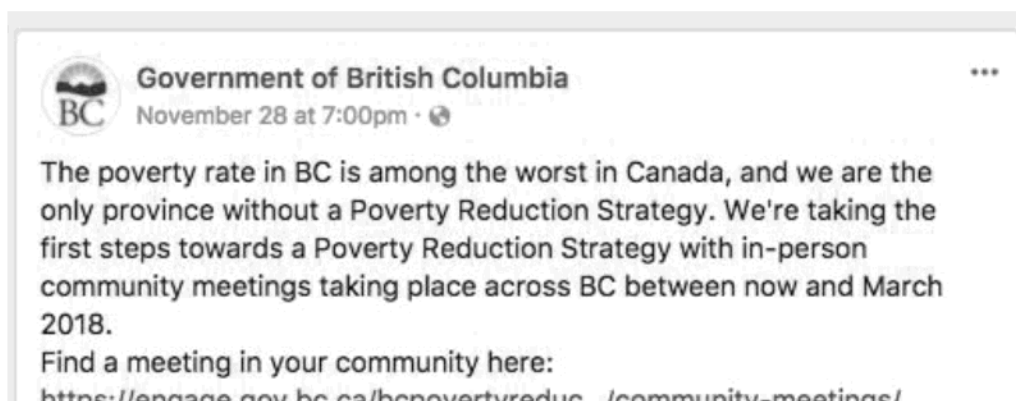
