

ADVICE TO MINISTER

CONFIDENTIAL ISSUES NOTE

FIFA 2026 Bid

Ministry of Tourism, Arts and Culture

Date: March 13, 2018

Minister Responsible: Hon. Lisa Beare

RECOMMENDED RESPONSE:

- The United Bid Committee (Canada/USA/Mexico Soccer Federations) is bidding for the opportunity to host the 2026 FIFA Men's World Cup in Canada, the US and Mexico.
- On Jan. 30, 2018, Vancouver City Council approved a motion to move forward to the second stage of the bid process that will be submitted to FIFA in March, 2018.
- If United Bid is successful the 2026 World Cup would consist of 80 matches (60 in the US, 10 in Mexico and 10 in Canada).
- · Vancouver was shortlisted for the games hosted in Canada.
- Three other -cities Edmonton, Montreal and Toronto were also shortlisted.
- The Province of British Columbia submitted its information to FIFA on March 8, 2018, unsigned.
- That submission included a letter outlining issues of concern regarding costs. Government offered to negotiate terms with FIFA to improve financial obligations, in order to address these concerns.
- · That submission was rejected.
- FIFA will make a decision in June.
- · Sporting events are an important part of BC's event tourism.
- BC has successfully executed major international sport events, including the Women's Soccer championships and the 2010 Olympics.
- The Province carefully assesses all sport events for value to taxpayers.

ADVICE TO MINISTER

If asked about the City of Vancouver's approval of the 2026 FIFA World Cupbid...

- Vancouver City Council's approval moves them forward as a potential host city in the United Bid submission for the 2026 FIFA World Cup.
- The City of Vancouver has an exceptional record in hosting major events, including the FIFA Women's World Cup Canada 2015.
- We look forward to receiving a comprehensive business case from the City of Vancouver to see what the request for provincial funding and commitments will be.
- The Province cannot commit to the potential costs associated with the FIFA requirements for an event of this magnitude without a detailed business plan and budget from the City.

ADVICE TO MINISTER

BACKGROUND

January 30, 2018, Vancouver City Council unanimously supported the motion to move forward as a potential host in the United Bid, which features a coordinated bid submission for the 2026 FIFA World Cup by cities from Canada, the USA and Mexico.

The United Bid timeline is considered an "expedited process" meaning that timelines are very tight and give very little time for due diligence on behalf of the federal and provincial governments. The "expedited process" was initiated at the request of the United Bid proponent (i.e. Soccer Canada.)

Key dates in the expedited process include:

- March 16, 2018 United Bid Committee to submit bid to host FIFA;
- June 13, 2018 FIFA to announce host of the 2026 World Cup, or defer the announcement and enter into a full bid process (not an expedited process.);
- June 30, 2020 FIFA recommends 12-16 Host Cities for the successful bid; and
- 2021 Confirmation of Official Host Cities by FIFA.

Ministry staff and PAVCO are working with Soccer Canada, FIFA and the City of Vancouver to identify projected event costs, but support from the federal government and funding for the tournament have not been confirmed.

On September 1, 2017, Minister Lisa Beare provided Mayor Robertson with a conditional letter indicating support-in principle at that stage of the World Cup bid process. The letter stipulated that the province would require the City of Vancouver to prepare and submit a comprehensive business plan that includes details on the operational, financial and other obligations and risks associated with hosting the 2026 World Cup. To date, no business plan or detailed budget has been provided.

Event Background

The National Soccer Federations of Canada, Mexico and the United States have formed a United Bid Committee (UBC) to bring the 2026 FIFA Men's World Cup to North America. The regional approach was adopted to accommodate the recent expansion of the tournament which now includes 48 teams (previously 32) and an 80 match schedule. It is anticipated that Canada will host 10 matches in two major centres (assume one of MTL/TOR and one of VAN/EDM) with the majority of competitions staged and costs incurred in the USA. Morocco is the only other country bidding on the 2026 event so the chances for success of a CAN/MEX/USA bid are good.

The formal bid deadline to be submitted to FIFA is March 16, 2018 with a final decision on acceptance of the United Bid Committee's proposal expected at the FIFA Congress in June. The final selection of host cities and stadia will take place in 2020-2021.

The three nations have hosted 13 FIFA World Cups combined (men, women and youth), which is more than any other trio of geographically-connected nations. Canada hosted the FIFA Women's World Cup Canada 2015, which attracted over 1.35 million spectators and more than 20 million Canadian television viewers.

STATEMENT

Minister of Tourism, Arts and Culture's statement on 2026 FIFA World Cup bid

VICTORIA - Lisa Beare, Minister of Tourism, Arts and Culture, has made the following statement about Vancouver potentially hosting the FIFA World Cup in 2026:

"The prospect of hosting the FIFA World Cup is exciting for soccer fans, and has the potential to bring significant economic and cultural benefits to British Columbia. For the past several weeks, our government has been working diligently with the United Bid Committee -- consisting of Canada, the United States and Mexico - to bring the 2026 cup to Vancouver, as one of the committee's Canadian host cities.

"While we support the prospect of hosting the World Cup, we cannot agree to terms that would put British Columbians at risk of shouldering potentially huge and unpredictable costs.

"Throughout this process, we have been in regular contact with the bid committee and other levels of government to support this bid, while protecting taxpayers. Through these conversations and our submissions to the bid committee, we have made numerous attempts to clarify the risks and obligations faced by British Columbians.

"So far, the bid committee has rejected our requests to clarify how much British Columbians could be expected to contribute. And they have declined to negotiate with the province regarding the concerns we raised.

"Should the bid committee reconsider, our door remains open to bringing some of the 2026 World Cup games to Vancouver."

- They indicate that FIFA may unilaterally change the terms of the agreement without consultation or agreement from the host jurisdiction.

These conditions were not met, despite the City of Vancouver and the BC Pavilion Corporation's best efforts to obtain the required information.

This situation contrasts sharply with that which pertained for the 2015 Women's World Cup. In that case, the Province knew precisely what its financial exposure was and what it would get in return for its investment.

- Government's total financial investment for the 2015 Women's World Cup was capped at \$2 million.
- For that \$2 million, Vancouver hosted 9 matches including preliminary rounds, quarter finals and the final game.

We do not have the same understanding of the number of games, costs, obligations and risks associated with FIFA 2026.

This is particularly concerning for cost items such as security.

As an example, security costs for the 2010 Olympic and Paralympic Games were more than five times the original estimate of \$175 million. Total security costs were \$900 million. Without a bona fide business plan and security threat assessment the federal government's support is approved in principle and its financial contribution is capped. This creates additional elements of uncertainty for provinces and host cities.

We do not have the same understanding of the number of games, costs, obligations and risks associated with FIFA 2026.

This is particularly concerning for cost items such as security.

As an example, security costs for the 2010 Olympic and Paralympic Games were more than five times the original estimate of \$175 million. Total security costs were \$900 million. Without a bona fide business plan and security threat assessment the federal government's support is approved in principle and its financial contribution is capped. This creates additional elements of uncertainty for provinces and host cities.

I am still working on getting the go-ahead to release the letter of application. I will get back to you re: this.

Q & A: FIFA Bid

1. What are the concerns you had with the FIFA bid?

- The predominant concern is the unknown financial risk to the province.

- In addition we are concerned with the binding nature of the guarantees:

2. Did you identify the province's concerns to the FIFA bid committee?

Yes, the Province submitted a letter identifying a number of cost-related concerns and offered
to negotiate these concerns with the sporting agency (United Bid Committee), however, this
request was declined.

3. When was the deadline from Canada Soccer and the United Bid Committee to the province and city of Vancouver to be included as a Canadian Candidate Host City?

 The deadline for the City of Vancouver to be included as a Canadian Candidate Host City in the United 2026 Bid Book was 11:30 am EST / 8:30 am PST, WEDNESDAY, MARCH 14, 2018.

4. Is the City of Vancouver included as a Canadian Candidate Host City in the United Bid?

 The province and city of Vancouver were informed this morning at 9:26 am that we have not been included as part of the United Bid.

5. When will the United Bid committee announce the Canadian Cities?

 Our understanding is that the United Bid Committee will announce the host cities that will be included in the bid submission on Thursday, March 15, 2018.

6. When is the final bid package due to FIFA?

 Our understanding is that technically the deadline for the United Bid Committee to have documents submitted in Switzerland is Friday March 16th at 5pm Zurich time (9am PST) Government needs to make financial decisions based on good information to protect the taxpayers of British Columbia and we did not have the information necessary to sign a stadium agreement.

8. The federal government says the FIFA championship would be good for Canada's economy. Why don't you agree?

- The Government of Canada is entitled to its assessment and opinion of hosting events such as the World Cup.
- The Province remains an enthusiastic supporter of hosting major events. We were proud to support the recent Women's World Cup recently.
- Unfortunately, the terms proposed by FIFA left British Columbian taxpayers at an unacceptedly high risk for uncontrolled costs.
- To date, there has not been any legitimate economic analysis provided to the Province by the proponents.
- Hosting international events does contribute to the local economy. But it also does have a cost.
 We have to balance this with the needs of all British Columbians and the current priorities of our government.
- The Province will continue to enthusiastically welcome hosting international events which are of benefit to British Columbians.

9. Opposition members and others say that the Men's Cup would bring \$50M in value to Vancouver and the province. Why weren't you interested in realizing that economic benefit?

- That is impossible to verify. To date, there has not been any legitimate economic analysis
 provided to the Province.
- If costs, risks and revenues are unknown, then calculations of the economic value of the event to the Vancouver and provincial economies cannot be accurately estimated.

10. Has the province withdrawn support to back the City of Vancouver's bid

- To be very clear, the Province of British Columbia has been supportive of the 2026 Bid.
- In September 2017, the Province of British Columbia provided a letter of support with three conditions.
 - Receipt of a bona fide business plan including details on the operational, financial and other obligations and risks of hosting the 2026 World Cup.

- Canada taking a lead role in addressing necessary security and public safety.
- That the taxpayers of British Columbia would not have to bear any liability for event overruns or financial guarantees.
- These conditions were not met despite the City of Vancouver and the BC Pavilion Corporation's best efforts to obtain the required information.

11. Canada and all the other provinces are proceeding with bids. Why is BC the only province stating concerns?

- BC Place is owned by the province and not the municipality which means that the province has been approached early in the negotiations. In other jurisdictions, cities may be able to enter into stadium use agreements without provincial involvement.
- We are continuing to work with the City of Vancouver and the United Bid Committee to establish terms that fulfill FIFA requirements and addresses our concerns.
- We obviously can't speak for other jurisdictions. It is our understanding that other provincial
 jurisdictions share a number of BC's concerns regarding lack of information required to agree to
 the FIFA terms.

12. The 2015 Women's World Cup was a success and had a significant economic return to the City and the Province. Why say no to the Men's World Cup which has even greater global interest?

- For the 2015 Women's World Cup, the Province knew precisely what its financial exposure was and what it would get in return for its investment.
 - Government's total financial investment for the 2015 Women's World Cup was capped at \$2 million.
 - For that \$2 million, Vancouver hosted 9 matches including preliminary rounds, quarter finals and the final game.
- We do not have the same understanding of the number of games, costs, obligations and risks associated with FIFA 2026.
- This is particularly concerning for cost items such as security.
- As an example, security costs for the 2010 Olympic and Paralympic Games were more than five times the original estimate of \$175 million. Total security costs were \$900 million. Without a bona fide business plan and security threat assessment the federal government's support is approved in principle and its financial contribution is capped. This creates additional elements of uncertainty for provinces and host cities.
