Sale of Retirement Concepts

BACKGROUND REGARDING THE ISSUE:

- On February 23, 2018, Reuters reported that the Chinese government seized control on Anbang Insurance Group Co Ltd, and said its chairman had been prosecuted.
- In a statement, the China Insurance Regulatory Commission (CIRC) said Anbang had violated laws and regulations which "may seriously endanger the solvency of the company."
- Anbang will be taken over for the period of at least one year and will be managed by a group of officials from the CIRC.
- An announcement says the group will seek to undertake an equity restructuring of the company. The CIRC also said that Anbang's debt's and obligations will not be impacted by the takeover.
- On June 13, 2017, a Globe and Mail a reporter contacted the Ministry of Health to inform the ministry that Chinese media were reporting Anbang's chairman Wu Xiaohui had been detained by authorities.
- Anbang, a Chinese insurance-holding company, owns Cedar Tree who recently purchased 23 of 25 facilities owned by Retirement Concepts (20 in BC, 2 in Alberta and 1 in Quebec). The sale was subject to federal approval. Under the Investment Canada Act (ICA) it is the Federal Minister that is responsible to approve the sale to a non-Canadian if over \$600m (increases to \$800m in 2017).

- BC's Assisted Living and Residential Care regulations outline requirements of applicants for registration or licensing when there is a change in ownership. These regulations are in place to protect the health and safety of residents and persons in care irrespective of ownership.

- The Terraces is one of two facilities that were not part of the federally approved sale and is still owned by Retirement Concepts.
- After significant media attention, Retirement Concepts rescinded its notice and worked with VCH to find a solution to allow residents to stay until the original agreement end date of March 2019.
- In response to concerns raised about Retirement Concepts and other providers suddenly
 ending contracts in the future the Board of Directors of the BC Care Providers
 Association struck an internal "Assisted Living Tenancy Task Force" to review this matter
 and provide recommendations to prevent future sudden terminations and evictions.

DISCUSSION/ADVICE:

 - NDP health critic Don Davies called the Anbang deal a "foreign takeover of vital healthcare and seniors facilities" in B.C., and asked the Liberals whether the purchase was ever discussed at one of their cash for-access fundraisers.
 - New Democratic Party MP Nathan Cullen said Retirement Concepts as a health care provider should be considered a "critical asset" for Canada to protect. "You would think any government would reject this proposal."
- On November 29, 2016, the HEU put out a news release calling on the federal and provincial government to reject the takeover of Retirement Concepts by Anbang.

ADVICE AND RECOMMENDED RESPONSE:

If asked about Chinese Government takeover of Anbang:

- We are aware of the Chinese government's actions on February 23 regarding Anbang.
- Our government is reaching out to our contacts in Beijing to discuss any potential implications this may have for Anbang-operated facilities in B.C.
- Our focus will continue to be the health and safety of persons in care regardless of ownership.
- We need to be scrupulous about the type of foreign investments that we support in B.C.
- It is important to remember that although the federal government has exclusive jurisdiction for matters of international trade we believe that communication with patients, families, and the general public on these types of matter should be done more transparently.
- We also need to ensure we have the regulatory framework in place, to protect the health and well-being of seniors in care.
- As part of our focus on seniors, Budget 2018 will invest \$548 million over the next three years to improve care for seniors – including investments in primary care, home and community care, residential care and assistive living.
- Legislation in place allows the health authorities and the Registrar to continue to monitor these facilities.
- Medical Health Officers and the Assisted Living Registrar monitor care provided in these facilities and can require:
 - Reports on the operation of licensed facilities,
 - Results of any investigations, or investigations of complaints,
 - o Inspection of books, records or premises in connection with the operation,
 - o Require an audit of the operations of a community care facility, and
 - Specify policies and standards of practice.

- Health authorities have used these powers in situations where facilities have not been in compliance.
- The Office of the Seniors Advocate has been and will continue to monitor the care being provided in these facilities to make sure Cedar Tree and Retirement Concepts are providing their residents with appropriate and quality care.
- This situation is a significant reminder of the importance of public ownership and operation in health care.
- When facilities are publicly owned and operated, the focus of the facilities will be the care of patients and not the bottom line of the operator.

 the inspection of a residence at any time if it is felt there is a risk to the health and

BC Services Card – Naming Issues Solution Announcement

Background: The Civic Education Society released a statement to media that says that changes to the BC Services Card process will make it difficult for immigrant Canadians.

Copyright

- This is an issue that we have had raised with us by many constituents.
- In 2010, the previous government started work on creating a BC Services Card – combining the BC Care Card, BC Driver's License and BC ID to have one piece of core ID for British Columbians.
- In February 2013, the previous government announced the plan to roll out the BC Services Card—forcing all British Columbians to re-enroll in the Medical Services plan over the next five years, tying it to the renewal of their driver's license.
- In 2016 ICBC changed their policy regarding the use of hyphenated and anglicized names on Driver's Licenses to keep in step with the Name Act.

- When our government came into power last year, we soon realized that the Services Card project had not taken into account the challenges this legislation posed for people with hyphenated or anglicized names.
- People were told they needed to legally change their name to reflect the name they had been using legally, on their provincial identification, for years.
- There were some British Columbians who had to spend their hard-earned days and dollars to change their name so that the name on their identity documents matched the name they used and were known by.
- The technology incorporated into the Services Card was supposed to improve services for all British Columbians, but it has not.

New Brunswick covers insulin pumps for people up to 25

Background: New Brunswick is expanding the program which helps diabetics purchase insulin pumps and supplies to include young adults up to 25 years old. This may raise questions about governments campaign promise and mandate letter commitment to expand coverage in BC beyond 25 years of age. In NB the change will come into effect on April 1. The current program assists parents of children 18 years old or younger. The Department of Health will invest \$ 300,000 to expand the program. To be eligible for the program, a person must:

- 1. have a valid New Brunswick Medicare number;
- 2. be a permanent New Brunswick resident:
- 3. be 25 years old or younger effective April 2, 2018;
- 4. have Type 1 diabetes; and
- 5. meet the criteria as outlined in the Insulin Pump Program Policies and Procedures Manual. Applications will be assessed to determine the applicant's contribution based upon their income, with the remainder of the cost being covered by the provincial government.
- British Columbians spend more on prescription drugs than the national average, with 6.6 per cent of households spending just over \$1,000.
- No family should have to make the difficult decision between buying prescriptions and putting food on the table.
- We are committed to making life more affordable by working to reduce the cost of prescription drugs.

- That is why in this Budget we are investing \$105 million in Fair Pharmacare to eliminate or reduce the deductibles for 240,000 B.C. families.
 - All families with household incomes under \$45,000 will benefit, but the biggest impact will be felt by families with incomes of between \$15,000 and \$30,000 — they will have no deductible as of January 1, 2019.
- PharmaCare helps cover one pre-approved insulin pump every 5 years for patients 25 years of age or younger, who have type 1 diabetes or another form of diabetes requiring insulin and who meet the medical criteria.
- In 2016/17, 424 patients received PharmaCare coverage for insulin pumps.
- We continue to focus on how we can enhance support to British Columbians living with – and at risk of – diabetes.
- We are working to bring relief to families from the high costs associated with this illness – from medication and blood glucose testing to insulin delivery devices.
- This includes looking at removing the age restriction on coverage of insulin pumps for those over age 25.
- We are also looking at enhancing evidence informed decision making for new and existing diabetes medications.

Facts on Diabetes Management

- It is estimated that 445,436 British Columbians were living with diabetes in 2016/17.
- PharmaCare is the Ministry of Health program that helps BC residents to pay the eligible costs of many prescription drugs and certain medical supplies.
- PharmaCare spent over \$73 million on diabetes medications and supplies in 2016/17.
- PharmaCare provides British Columbians with diabetes coverage for:
 - oinsulin and other diabetes medications;
 - o insulin pump supplies (infusion sets and reservoirs);
 - oblood glucose testing strips; and
 - o needles and syringes for insulin use.
- PharmaCare is currently reviewing several newer Type 2

diabetes drugs.

- In addition the majority of family doctors in B.C. now use the provincial guidelines for treating and managing diabetes, which were developed by the ministry and Doctors of BC.
- In 2016/17, 3,329 family doctors received B.C.'s diabetes management incentive payment for 203,977 patients. This payment encourages doctors to offer diabetes patients continuous care that meets the provincial guidelines.
- The province spent \$25.5 million on these payments in 2016/17.

Doctors Charging for Referrals to Allied Health Professionals

Background: CBC Kelowna will be running a story on Monday morning on doctors charging patients for referral to allied health professionals, such as physiotherapists and massage therapists. They have come to the Ministry/Medical Services Commission wondering if this is allowed. Have spoken to the Docs of BC, who indicate that while they do not recommend it, there is nothing legislatively that explicitly bars the practice -- that it is a bit of a grey area.

They will be having the BC Health Coalition on the program on Monday morning and would like the chair of the Medical Services Commission on as well, to speak to the legality of this practice.

- Upon initial review, it appears to the Medical Services
 Commission that the practice of a doctor charging a patient for a referral to an allied medical professional would ordinarily be a violation of section 17 of the Medicare Protection Act.
- Section 17 of the *Medicare Protection Act* prohibits charges for or in relation to the rendering of a "benefit".
- In most cases, referral by a doctor to an allied medical professional relates to the rendering of a benefit (i.e. a medically required visit to the physician for diagnosis, etc.).
 As such, it is contrary to s. 17 of the Act to charge for the referral.
- This is similar to a circumstance where a patient sees a physician for back pain (a benefit of the Medical Services Plan (MSP)) and is a referred to an orthopedic surgeon. In such case, the patient is not charged for the referral.

- An exception to this rule may be where a patient goes to the doctor solely for a referral due to a third-party insurance requirement. If so and the visit is for an insurance reason (*i.e.* it is not medically required, so it is not a "benefit"), then the physician cannot charge MSP and a charge to the patient for the referral may be appropriate. This situation is comparable to a request for a doctor to give a patient a letter confirm that the patient is sick because it is required by the patient's employer.
- We would encourage any patient who is concerned that they are being charged a fee which is in contravention of the Act, contact the Medical Services Commission.
- The Medical Services Commission reviews every complaint that it receives, and this independent commission would make any determination on an issue like this.

Richmond Hospital/Capital Projects Not in the Budget

Background: Richmond First councillors held a press conference at 10:30 a.m. on February 13th releasing a public petition calling on government to create a new acute-care tower at Richmond hospital as part of the upcoming budget.

- This government is committed to providing the public health care British Columbians need.
- That includes planning for a new Richmond Hospital Acute Care Tower to replace the current North Tower.
- I know that this project has immense support within the community, and I thank them for their passion and dedication to local, public health care.
- I want to assure all of those supporters that we are committed to continue working with local government, Vancouver Coastal Health and the Richmond Hospital Foundation to further develop their plans – this is a project that we support wholeheartedly.
- It is important to point out that, while those projects like
 Richmond are developing, they do not appear in the budget.
 That is simply because, as part of the capital planning
 process, projects are not included in the budget until they have
 an approved business plan in place.
- Other hospitals also in the planning stages, like a new hospital for Surrey & St. Paul's and were also not in budget.
- This is not a reflection of a lack of commitment by government
 it is simply the way the budget process is structured.
- We are making progress on the list of health care capital projects that we know are needed across the province – for example, we recently announced that we were moving forward with the plans for Cariboo Memorial Hospital in Williams Lake, and Mills Memorial Hospital in Terrace.

If asked about commitment from previous government

- During the campaign the Liberals committed to developing a business case for Richmond hospital with the potential of additional specialized residential care spaces for Chinese-British Columbians and space for practitioners of Chinese Traditional Medicine.
- On April 4, 2017, the Liberal government put out a news release stating that up to \$3 million will be allocated to support the development of a business plan, once the concept plan is approved.
- The news release wording indicates the development of a business plan is dependent on approval of Vancouver Coastal Health Authority's concept plan for Richmond Hospital and that this approval, as well development of a business plan, would happen sometime in the future (i.e. "could begin in fall 2017"). The news release also indicates the development of a business plan would start "after a concept plan is approved by government". It is important to note the news release use of the future tense, i.e. "funding will be allocated" going forward.
- Vancouver Coastal Health submitted a concept plan for the replacement of the North Tower to the Ministry of Health in January 2017.
- Assuming government approves the concept plan, the next step would be for Vancouver Coastal Health to proceed with the development of a business plan for the project.

Historical Planning Timeline

 In 2013, the Richmond Community of Care High Level Master Plan was undertaken to produce an Integrated Service and Master Concept Plan that forecasts needs to 2030.

- The High Level Master Plan was completed in March 2015.
- In February 2014, a structural assessment of the North Tower was conducted and the building was determined to be a vulnerable structure; at highest risk of widespread damage or structural failure after an earthquake.
- In June 2016, the then-government announced plans to proceed with a concept plan in support of potential development of a new replacement patient care tower at Richmond Hospital.
- In January 2017, VCH submitted a concept plan to the Ministry of Health for a new acute care facility at Richmond Hospital.

Federal Budget - Pharmacare/Extrabilling

Background: Budget 2018 proposes legislative amendments (page 175) to allow Canada Health Transfer deductions to be reimbursed when provinces and territories have taken the steps necessary to eliminate extra-billing and user fees in the delivery of public health care. While the amounts are modest, BC tends to have the highest deductions. See attached notes for additional information.

UBC's Steve Morgan rxn: The language isn't as strong as UBC's Doctor Steve Morgan would like, but he's still pleased the government is starting a discussion on whether it should cover the cost of pharmaceutical drugs. To get the talks going, an advisory council is being formed. Morgan, who heads up Canada's Pharmaceutical Policy Research Collaboration, says he's optimistic the talks will lead to action.

Steve Morgan: This is referred to as an advisory council on the implementation, not an advisory council on whether Canada should have national pharmacare. The reason that that is important is that that we have had commission after commission.

Johnston: Morgan says he'd love to see the Liberals roll out a pharmacare program in time for next year's budget, but he concedes the party could make this an election issue, heading into 2019.

- We appreciate the federal government's commitment to a conversation on national Pharmacare.
- But we also need action.
- That's why we are helping 240,000 families in our budget by expanding Fair Pharmacare coverage.
- We took a major step to eliminate deductibles for low income people to help them get the prescription medicines they need but are struggling to afford.
- I look forward to talking with the federal government because Canadians can't afford to wait any longer for affordable medicines.

If asked about extrabilling

- Everyone has the right to medically-neessary, publicly funded health care, based on need – not ablity to pay.
- This is the fundamental principle of the Medicare Protection Act and we expect people to follow the law.
- This government has made it a priority to support our public health care system and we are taking steps to ensure we have a

health system that works for everyone.

 Part if this is moving forward with extra billing audits that have been outstanding since 2008. The ministry has hired additional staff to do this work and contracted with EY to provide an extra level of assurance on this work.

RHD Funding

Background: Former Health Minister Terry Lake has commented in media that Lower Mainland residents don't contribute to hospital/health construction

Shane Woodford: A former provincial Health minister is calling foul on a tax regime in this province which sees Interior residents pay for hospitals while those in the Lower Mainland get a pass.

Angelo Iacobucci: Terry Lake thinks it's time for an objective evaluation of property tax contributions to capital projects in transportation and health. Lake insists taxpayers on the Lower Mainland don't pay anything for hospital construction.

Terry Lake: People in the Lower Mainland have forgotten that in 1998, they were relieved of their obligation to pay 40% of hospital construction in lieu of paying for transportation projects, and we've seen time after time that they're been relieved of that obligation. Meanwhile, people in the rest of BC have to pay towards hospital construction.

lacobucci: Lake admits it is a rather divisive issue.

Lake: I think there's a growing divide between the Lower Mainland and the rest of BC in the way money is flowing from Victoria, and I think that's a concern for people outside of the Lower Mainland. [xrz, zpz, tran, hlth]

- In 1967 regional hospital districts (RHDs) were created with the proclamation of the Hospital District Act (the Act) as separate entities from regional districts, with the purpose to fund and share the financial burden of increasingly expensive hospital projects between the Province and the municipal governments, while ensuring equitable access to health service throughout the Province.
- The South Coast British Columbia Transportation Authority Act, passed in 1998, removed all RHDs from the Metro Vancouver Regional District (MVRD). The rationale for doing so was that Metro Vancouver would instead pay a greater share of transit and transportation infrastructure costs.
- From 1967 to 2003, the Act explicitly referenced the Province's contribution to capital costs for health facilities at a proportion of 60%, with the balance of 40% provided by RHDs.

- In 2003, amendments to the Act and the Hospital Insurance Act Regulations eliminated explicit reference to a percentage of the Province's contribution.
- Projects that are eligible for cost sharing usually include capital investments in local health care facilities and equipment that provide general care to residents of a specific geographic area. For large acute care projects, the Province still normally expects a 40% RHD contribution, and on most major projects RHDs still do contribute 40%.
- However, in some areas of the Province where the tax base is small and may not be able to support a 40% cost share on a large hospital project, the Province has on occasion considered a smaller percentage RHD contribution.
 - An example of this is the Mills Memorial Hospital, which was recently announced. In that instance, the North West Regional Hospital District will be contributing 30%, up to a maximum of \$113,700,000.
- RHDs typically do not provide funding for projects related to provincial programs and services such as: BC Cancer Agency, BC Transplant, Cardiac Services BC, BC Renal Agency and educational facilities in hospitals for the University of British Columbia, Faculty of Medicine, to support the training of physicians in B.C. The rationale is that these programs and services are generally not restricted within the geographic area of an RHD and therefore, should be fully funded by the Province.

Health Tax

Background: Budget 2018 introduced the Health Tax and plan to eliminate MSP premiums. The Opposition has claimed that because the employer payroll tax comes into effect in 2019 and MSP is fully eliminated in 2020, some businesses will be double paying for a year. Some businesses are saying that the \$500,000 threshold is too low, and some small businesses will be impacted.

• See attached note.

Ilaris Exceptional Coverage – Shriner's Comments

Background: British Columbia will be funding Ilaris as a last-resort treatment option for one patient — it is not the patient who has been in media from Vancouver Island. Tom Bumer and the Shriners of BC and Yukon are providing support to Landen Lanthier. BC Shriners will send Landen Alexa to Minneapolis free of charge for a three day assessment. Bumer suggests a visit to doctors in the US may eventually force the province to reverse its controversial decision.

- British Columbia will be funding llaris for one patient on an exceptional case basis.
- This drug coverage decision was recommended by the Ministry's specialist rheumatologist advisory committee, which reviewed details of the patient's condition put forward by the requesting physician.
- It is an independent recommendation, made by specialists who review all of the clinical information available on an individual patient, and make a recommendation based on that information.
- This is the process for all cases.

If asked why not Landen:

- We cannot speak to the individual patient details of any patient.
- That said, the Ministry of Health, through PharmaCare's Special Authority program, reviews every exceptional drug coverage request submitted by a patient's physician.
- When reviewing certain coverage requests, PharmaCare uses physician specialist committees to review requests and provide coverage recommendations on a case-by-case basis.
- In cases related to arthritis, these are independent specialist rheumatologists who review the detailed facts of each patient's case including all appropriate treatment options available to the

patient and what treatments have already been explored that PharmaCare provides coverage for.

 Tocilizumab is the first-line treatment for this type of juvenile arthritis, and is fully covered under BC's PharmaCare. B.C. also covers other treatment options including anakinra, on an exceptional, case-by-case basis.

Ocean Park Laboratory Closure

Background: Some community members are upset that FH and PHSA are planning to close Ocean Park laboratory, and there was a community public meeting between stakeholders and FH/PHSA on Friday -. at Ocean Park Community.

Approximately 130 people attended the meeting. The first question was if there was an opportunity to change the decision, and when it was confirmed there was not about half the people left.

Mary Martin was there circulating a letter that she is sending/has sent to MD about how this is a removal of services. She also said that FH forbid her to speak. They did not they said that the discussion was to be about finding solutions for barriers and if she wanted to talk about that she could but she wanted to present a presentation on how this is a removal of services which was not the point of the meeting

Effective March 2, 2018, the Ocean Park Collection Centre at 1673 128th Street, Surrey, BC is moving its services to the Peace Arch Hospital laboratory and collection centre. Due to low use of this location and the close proximity to other full service laboratory collection centres it is the best use of our resources to centralize our collection services at the Peace Arch Hospital lab.

Peace Arch Hospital Laboratory is a full service lab nearby that is able to meet all patient testing needs. There are two other labs within an eight minute drive (5.9km) of the Ocean Park location should patients not wish to go to the Peace Arch Hospital location.

- I understand that there are some community members who are upset that the Ocean Park Collection Centre is moving its services to Peace Arch Hospital.
- I recognize that, for patients, where they access their local health services is an important part of their overall care experience – and there are some patients who use the services at Ocean Park regularly, and for whom this will be a change in service.
- I understand that onFriday Fraser Health and PHSA held a public meeting with the community, where people could speak directly with them about the change.
- The meeting was an opportunity for the health authorities to hear from the community about their concerns and make sure people are able to access the services they need following the change.

- It is important that we take a holistic view of our public health services, to make sure that we are able to meet the needs of the most patients possible, while ensuring that care is available for all.
- On average, less than 30 patients visit Ocean Park each day and the ECG had already moved to Peace Arch, to integrate with existing technology.
- In addition the staff member at the collection centre will also be moving to the Peace Arch Hospital Lab to expand availability of existing lab services.
- The health authorities have committed to working with the community to answer their concerns and questions.
- That began with the first communications to patients about this on January 15 – which included a poster and information at the site, followed by mailed letters to all patients. There was also information placed in the local newspaper on January 18.
- Lab services at Peace Arch Hospital provide longer hours of operation than Ocean Park Lab, do not close on breaks and over lunch and provide a greater diversity of testing including ECGs for heart patients, pediatric testing and special handling for lab samples.
- Additional lab collection services are also available to people living in White Rock and South Surrey at three additional Life Lab locations.

If asked about Councillor Martin not being able to speak:

 Friday's meeting was an opportunity for the community to voice their concerns and for the health authorities to ensure that people are able to access the services they need.

- The format was a number of tables at which senior leadership from both Fraser Health and PHSA were sitting to engage with the community, hear their concerns, and ensure all of their care needs are met as we move forward.
- Councillor Martin was invited to attend and share her thoughts with the various tables, and she did.
- She also had a formal opportunity to speak at Fraser Health's Public Board meeting a few weeks ago.

College of Physicians Patient Attachment Feature Disabled

Background: As of March 1, the College of Physicians is removing the feature on their website whereby they refer patients to physicians who are looking for a doc, as it was not updated regularly.

Instead, patients who contact them looking for a doc will be referred to either the local Division of Family Practice (if that division has a patient attachment mechanism) or to HealthLink BC to provide a list of local walk in clinics in their area.

Pamela Fayerman wrote a piece on this on the Vancouver Sun website late Tuesday.

- We are aware the College of Physicians and Surgeons of BC plans to disable the feature on their website which shows which doctors were accepting new patients, as of March 1.
- We understand from the College that the information generated from the "accepting new patients" feature was frequently inaccurate as it was not updated regularly either because practices were at capacity for new patients or physicians worked at multiple locations-- this understandably has caused frustration for patients seeking a family physician.
- The College's physician directory will continue to assist patients and others who wish to confirm whether a physician is currently registered and licensed with the College, and provide information as required by the Health Professions Act, including a business address and phone number.
- The College of Physicians and Surgeons of BC will now do one of two things:
 - refer those looking for a family doctor to local divisions of family practice that have patient attachment programs in place, or
 - o refer to Health Link BC for walk-in clinics in their area
- Health Link will also maintain a listing of all divisions of family practice and where appropriate can also refer people to divisions which have patient attachment programs in place.

Secondary

- We know there are too many British Columbians who do not have a primary care provider -- 16.2 percent of British Columbians, up from 15.1 percent in 2014.
- Too many people continue to face the endless search for a family doctor or rely on walk-in clinics and emergency departments for their health care.
- That is why strengthening primary care is a priority for this government.
- Budget 2018 is providing \$150 million over three years to expand the coverage of primary care providers and teambased care so that more people can get access to care when they need it.
- Team-based care has great potential to help more people access care and is one of our top priorities.
- By bringing teams of family doctors, nurse practitioners, nurses and other health-care professionals together we can better address everyday health issues and support long-term health needs like home care.
- Team-based care has been shown to reduce hospitalizations and doctor visits while improving outcomes for patients with chronic diseases.
- It also reduces duplication and streamlines care, increasing the efficiency and sustainability of the health system. And it enhances the care experience for both patients and providers.
- Team-based care will be foundational to our efforts to increase access to urgent primary care services - including the

introduction of Urgent Primary Care Centres, and other expanded primary care access options in B.C.

Retirement Concepts/Anbang

Background: On February 23, 2018, Reuters reported that the Chinese government seized control on Anbang Insurance Group Co Ltd, and said its chairman had been prosecuted. In a statement, the China Insurance Regulatory Commission (CIRC) said Anbang had violated laws and regulations which "may seriously endanger the solvency of the company."

Anbang will be taken over for the period of at least one year and will be managed by a group of officials from the CIRC. An announcement says the group will seek to undertake an equity restructuring of the company. The CIRC also said that Anbang's debt's and obligations will not be impacted by the takeover.

A statement from Retirement Concepts to Business in Vancouver confirmed that an interim management group from the Chinese government agency will oversee Anbang's operations for one year. The statement also confirmed the Retirement Concepts' operations remain regulated by B.C. laws and will not be affected by Anbang's management change.

"No potential change is coming," said Sheri Brown, marketing director for Pacific Reach Seniors Housing Management, the company in charge of Retirement Concepts' local operations. "And all our residents are quite happy

- We are aware of the Chinese government's actions on February 23 regarding Anbang.
- It is early days, and we will be expecting that more information be provided in the near future about any impacts to the residential care sector resulting from this action.
- We are in contact with our federal counterparts, who have jurisdiction around international sales of this nature, under the Investment Canada Act, and will be working closely with them as additional information and clarity becomes available.
- It is important to remember that the federal government has exclusive jurisdiction for matters of international trade and approved the purchase by Anbang in spite of significant concerns in B.C. We believe that communication with patients, families, and the general public on these types of matter should be done more transparently.
- The Ministry has also reached out to Cedar Tree, the BC business operating Retirement Concepts, and they have committed that the change in management at Anbang will not

impact the operations of Retirement Concepts, its staff or residents.

- The Ministry and the Office of the Seniors Advocate has been and will continue to monitor the care being provided in these facilities to make sure Cedar Tree and Retirement Concepts are providing their residents with appropriate and quality care.
- Our focus will continue to be the health and safety of persons in care – regardless of ownership.
- We also need to ensure we have the regulatory framework in place to protect their health and well-being. Part of that includes our Budget 2018 investment of \$548 million over the next three years to improve care for seniors – including funding for primary care, home and community care, residential care and assisted living.
- The care and well-being of residential care clients must be at the centre of our efforts, not the ownership status of the operator. This situation is a significant reminder of the importance of public regulation in health care.
- Last year the ministry took steps to make amendments to the Community Care and Assisted Living Act to provide better protections for seniors including the inspection of a residence at any time if it is felt there is a risk to the health and safety of a resident, and increased oversight protections for incidences of senior's abuse.

MAiD

Background: Fraser Health has recently communicated to hospice providers that they will be starting the final phase of implementing the provision of MAiD across the health authority including in hospice and palliative care, though at this time there is no hard and fast date for hospice care. Conservative MP Mark Warwara has been vocal on social media of his opposition to any MAiD at facilities. Delta Hospice has also been in media expressing their opposition to MAiD at their hospice facility.

- In recent weeks, we have heard from people and organizations that bring a variety of perspectives on this topic

 from those who feel that we should be providing more access, more quickly to medical assistance in dying, to those who feel that we should be providing less and restricting the locations where it is available. These are just two sides of this many-sided debate.
- This is a profound cultural shift, as well as a major change in health care policy which has happened only since June 2016 – and at about 19 months in we are still working to fully integrate it within the broader system.
- Here in B.C, we have made that change more quickly than the rest of the country, as more British Columbians have availed themselves of this service, per capita, than any other region of Canada.
 - As of December 31, 2017, there have been 871 medical assistance in dying deaths in B.C. (8 of these deaths were prior to June 17, 2016, during the period of court application to access medical assistance in dying) and there are 103 MAiD providers as of August 31, 2017, in the province as follows: 12 in Fraser, 35 in Interior, 8 in Northern, 18 in Vancouver Coastal, and 30 in Vancouver Island.
- And, I believe that our health care system has responded to meet that need.

- That said, there is still more work that needs to be done to help people who are facing this very personal choice, and to make sure that our health care system is there when and where they need it to be.
- With respect to where MAiD is offered within our health care system, the previous government implemented a policy requiring that all facilities which received the bulk of their funding from the Province would be required to provide access to MAiD.
- We have not changed this policy, which seeks to strike a balance between the autonomy of private providers within a largely publicly funded health care system.
- This service cannot just be available at publicly owned and operated facilities – that would not represent patient-centred care. This is a challenge that my predecessor Terry Lake recognized, and is why he set out the policy that he did.
 - In June 2016 and again in March 2017, the Ministry of Health directed all health authorities to ensure eligible people have safe, accessible access to medical assistance in dying across a range of non-denominational health-care settings and services.
- The health authorities have done a very good job in providing medical assistance in dying throughout the province, as we address the inevitable challenges of a new area of services and policy.
- The majority of health authorities have already implemented medical assistance in dying in owned and operated facilities, including palliative care, hospice and residential care.
- We recognize that some providers and organizations feel that medically assisted dying conflicts with their core philosophy of

palliative and end-of-life care — to alleviate suffering as patients reach their natural deaths.

- Our greatest role as caregivers is to ensure we are listening to what our patients want and doing our best to provide it, especially in their final moments.
- It is crucial that we do not get mired in philosophical arguments, and forget that people are really at the centre of all of this. We do not want the patients to get lost in the debate.
 - Quote from: Peace Arch Hospice society executive director Beth Kish who told Peace Arch News that neither Fraser Health, or the PAH society, would ever request volunteers to be part of the MAiD process.

Copyright

- We continue to work with health authorities, through the provincial working group on MAiD, as they work with their contracted facilities to decide how best to provide this care to patients within these facilities.
- And Fraser Health continues to work with their contracted providers to have MAiD available to patients who may request the service in the future in those facilities.
- Right now each health authority has a Care Coordination Service in place to assist patients and health-care providers in navigating access to this service.

 Ultimately, our focus is now and will continue to be on patients and their families, and we will work to minimize disruption for patients at a time in their end-of-life care when it may not be ideal to be physically transferred.

Fair PharmaCare Announcement

Background: On February 9, the Ministry announced an enhanced Fair PharmaCare program, which will provide enhanced coverage to lower income British Columbians for everyday drugs. On Feb. 13 a UBC study noted that B.C. residents are far more likely to face struggles with medication costs, especially drugs prescribed for mental-health conditions. One of the co-authors (Law) noted the following about governments announcement "The changes will make a substantial impact for households in the targeted income bands that need prescription drugs" and "I think it's great to see policy changes that consider the research evidence available"

- No one should have to make the difficult decision between their family's health and putting food on the table.
- As outlined by a recent UBC study too many families in B.C. are having to make that choice.
- That study showed that:
 - More than 900,000 Canadians reduced their spending on basic necessities like food and heat to pay for prescription drugs in 2016.
 - Using data from Stats Can Community Health Survey, they estimated that 730,000 reduced their spending on food and 238,000 reduced their spending on home heating due to the cost of prescription drugs.
 - An estimated 1.69 million Canadians, or 8.2 per cent of those who received a prescription in 2016, did not fill prescriptions, skipped doses, or otherwise did not take medication as prescribed because of the cost, the study found.
 - In addition, an estimated 374,000 Canadians reported using extra health-care services because they found medication unaffordable, including more than 300,000 people who reported visiting the doctor again and 93,000 who went to the emergency room.

- Young adults, people with lower incomes, and those with no prescription drug insurance were more likely to report problems affording their medicines.
- Those are choices that nobody should have to make. That is why we are investing \$105 million in Fair Pharmacare to eliminate or reduce the deductibles for 240,000 B.C. families.
- All families with household incomes under \$45,000 will benefit, but the biggest impact will be felt by families with incomes of between \$15,000 and \$30,000 — they will have no deductible as of January 1, 2019.
- We know that in families earning under \$30,000, needed prescriptions go unfilled too often because Pharmacare deductibles are too high.
- This investment will make life more affordable for British Columbians while making sure they get the care they need.

What is the change?

- \$105 million over three years is being invested in Fair Pharmacare to eliminate or reduce the deductibles for 240,000 B.C. families.
- All families with household incomes under \$45,000 will benefit.
- Families with incomes of between \$15,000 and \$30,000 will have no deductibles.
- In addition the family maximums, or co-payments, will also be eliminated for families and seniors aged 79 and older with net incomes below \$13,750.
 - Previously, the family maximum for those families or seniors was up to \$250.

The changes take effect beginning January 1, 2019.

If asked about confidential documents being shared:

- The information was sent in error to an opposition MLA in the course of my (the minister's) office supporting that MLA on a constituency matter.
- In this email age, I think most people have either mistakenly sent an email, or almost done so, and in those instances, you always hope that the individual on the receiving end will be the better person and delete or ignore the message.
- Unfortunately, in this instance that was not the case.
- We decided to make the announcement last week, so that we were able to properly explain these positive changes first-hand to British Columbians and keep the focus on helping working families.

FACT SHEET

Sale of Retirement Concepts

ISSUE

Retirement Concepts is a large provider of Residential Care, Assisted Living, and Independent Living services in British Columbia, many of which are provided in a Campus of Care environment. Retirement Concepts is in the process of selling its shares for most of these operations to a unique limited liability partnership. Retirement Concepts will continue to manage the affected residences and facilities on behalf of the new owner.

KEY FACTS

- Retirement Concepts (RC) owns and operates independent living, assisted living and complex care facilities in British Columbia (BC), Alberta and Quebec. In BC, 24 sites are operated in all regional health authorities (HAs), except Northern Health. Twenty-three sites are licensed/registered under the Community Care and Assisted Living Act (CCALA); one site is licensed under the Hospital Act.
 - Retirement Concepts operates 15 Registered Assisted Living Residences, 13 of which are part of the proposed sale.
 - Retirement Concepts operates 17 Residential Care Facilities, 16 of which are part of the proposed sale.
- Each of the residences and facilities will be owned by a unique limited liability partnership that will be operated by Retirement Concepts.
- The new ownership group has indicated there will be no changes to the management, staffing and operations of the residences as a result of the sale.
- The sale was completed February 15, 2017, and the applicable licenses/registrations certificates have been processed.

Approval of Sale to Foreign Investors

- The federal government has exclusive jurisdiction for matters of international trade, under various trade agreements entered into by Canada and under the Investment Canada Act.
- The People's Republic of China is a member of the World Trade Organization and is eligible to make larger investments in Canada, as provided in s. 14.1 of the Investment Canada Act. As the proposed sale was over the \$600 million threshold set out in the Investment Canada Act, the proposed investment was reviewed by the Federal Minister.
- In making a determination as to whether a proposed investment "...is likely to be of net benefit to Canada....", the Federal Minister is obliged to consider the economic/financial factors set out in section 20 of the Investment Canada Act; any other considerations are not within the purview of the Federal Minister under the Investment Canada Act
- There is no statutory requirement for Canada to consult with a province respecting a proposed investment under the Investment Canada Act; as a matter of practice, good government, and courtesy, the federal government will consult with a province if a proposed sale to a foreign corporation or other legal entity could have a negative effect on, among other things, a health care program operated by that province.

FACT SHEET

Residential Care Regulations

Section 9(3) of the Residential Care Regulations sets out the requirements for the sale of a
facility. A licensee is unable to sell, lease or otherwise transfer control without providing
the medical health officer at least 120 days' notice AND the medical health officer must be
satisfied that operations will continue for at least 12 months from the date of sale, lease or
transfer and that the new purchaser, lessee or transferee is qualified to be a licensee.





Anbang – Retirement Concepts

BACKGROUND:

On Feb. 23, 2018, Reuters reported that the Chinese government seized control of Anbang Insurance Group Co Ltd, and said its chairman had been prosecuted. In a statement, the China Insurance Regulatory Commission (CIRC) said Anbang had violated laws and regulations which "may seriously endanger the solvency of the company."

Anbang will be taken over for the period of at least one year and will be managed by a group of officials from the CIRC. An announcement says the group will seek to undertake an equity restructuring of the company. The CIRC also said that Anbang's debt's and obligations will not be impacted by the takeover.

There is no statutory requirement for the Government of Canada to consult with a province respecting a proposed investment under the Investment Canada Act; however, consultation is routinely conducted as a matter of policy.

The federal government reviews economic/financial issues; any other matters (e.g. health care implications) are not within the purview of the Federal Minister. They have jurisdiction over foreign investment in excess of \$1 billion.

Through the former BC Ministry of International Trade, Ministry of Health staff was contacted to determine whether there were any concerns with non-compliance with provincial regulations.

On June 13, 2017, a Globe and Mail a reporter contacted the Ministry of Health to inform the ministry that Chinese media were reporting Anbang's chairman Wu Xiaohui had been detained by authorities. Anbang, a Chinese insurance-holding company, owns Cedar Tree who recently purchased 23 of 25 facilities owned by Retirement Concepts (20 in BC, 2 in Alberta and 1 in Quebec). The sale was subject to federal approval. Under the Investment Canada Act (ICA) it is the Federal Minister that is responsible to approve the sale to a non-Canadian if over \$600m (increases to \$800m in 2017).

ADVICE TO MINISTER

BC's Assisted Living and Residential Care regulations outline requirements of applicants for registration or licensing when there is a change in ownership. These regulations are in place to protect the health and safety of residents and persons in care irrespective of ownership.

Under the partnership agreement, Retirement Concepts retains a minority stake and will continue to manage the day-to-day operations of all of the facilities. Retirement Concepts committed that there is to be no change to staffing plans, the quality of care provided to residents, or to policies, procedures and other operating standards.

The complete terms of the transaction are not available due to confidentiality agreements both at the federal level with Investment Canada and between Retirement Concepts and Cedar Tree. Retirement Concepts provides assisted living and residential care services through contract with the health authorities.

In 2015/16, BC's five regional health authorities paid \$86.52 million combined to Retirement Concepts for contracted assisted living and residential care services. Out of 130 providers, Retirement Concepts was the highest paid across the province; however, health authorities' amount of contracted services varied.

Following the approval of the sale, on March 1, Vancouver Coastal Health (VCH) was given sixmonth's notice by Retirement Concepts to end its contract with VCH for 20 Assisted Living (AL) units (housing 21 residents) at the Terraces on 7th in Vancouver by September 30, 2017.

The Terraces is one of two facilities that were not part of the federally approved sale and is still owned by Retirement Concepts.

After significant media attention, Retirement Concepts rescinded its notice and worked with VCH to find a solution to allow residents to stay until the original agreement end date of March 2019.

In response to concerns raised about Retirement Concepts and other providers suddenly ending contracts in the future the Board of Directors of the BC Care Providers Association struck an internal "Assisted Living Tenancy Task Force" to review this matter and provide recommendations to prevent future sudden terminations and evictions.

SHOULD MINISTRY STAFF ATTEND THIS MEETING: Doug Hughes, Assistant Deputy Minister, Health Services Policy Division; Sharon Stewart, Executive Director, Seniors Services

BACKGROUND:

Retirement Concepts (RC) owns and operates independent living, assisted living and complex care facilities in British Columbia (BC), Alberta and Quebec. In BC, 24 sites are operated in all regional health authorities (HAs), except Northern Health. 23 sites are licensed/registered under the *Community Care and Assisted Living Act* (CCALA); one site, Dufferin Care Centre in Coquitlam, is licensed under the *Hospital Act*.

On July 27, 2016, the Ministry of Health (the Ministry) facilitated a conference call between Azim Jamal (AJ), President and CEO of RC and the four HAs; RC shared, in confidence, that they were selling all, but two sites (Qualicum Gardens and Terraces on 7th) to an international investor. RC noted there would be no change to the day to day operations; the new owner will contract with RC to remain as the administrator for five years, with an option to renew for an additional five years. AJ indicated on the call that he was aware that the sale would require all facilities to be re-licensed/re-registered. The HAs agreed to a coordinated approach to information gathering, where possible.

On September 7th, AJ contacted the Ministry requesting that it facilitate a conference call with HA Medical Health Officers (MHO). For purposes of licensing, the MHOs are considered independent Statutory Decision Makers under the legislation and the Ministry cannot be seen to be interfering in their decision making process.

On September 13th, the Ministry held a conference call with the HA MHOs to understand how they would proceed with the new licensing request. The MHOs indicated that, where feasible, they would coordinate the approach for information required for re-licensing. The MHO noted that they were arranging for a joint call with AJ early the following week.

On September 23rd, AJ contacted the Ministry and raised concerns regarding recent changes to the Residential Care Regulations that added the need to provide 120 days notification to residents/their families, as well as to the MHO. Concerns included implications to business operations and the lack of industry consultation. AJ indicated that he had requested a shorter notification period for residents and families from the MHOs, but had not yet heard their decision. The MHOs later denied the request and RC was providing residents, as well as staff, notification of the sale (see Appendix A and B).

The fundamental purpose of the CCALA is to ensure that operators of licensed community care facilities "operate the community care facility in a manner that will promote the health, safety and dignity of persons in care, and...the rights of those persons in care." (Section 7, CCALA). In considering any amendments, government must always consider the best interests of persons in care as well as their health and safety.

Prior to these specific amendments being made, if an operator wished to give less than 120 days' notice of a change in ownership, they could apply to the MHO for an exemption to these requirements. The person requesting the exemption must demonstrate to the MHO that they have consulted with persons affected by the decision, and the MHO then must take the views of those persons (typically persons in care/family/resident council) into consideration prior to making their decision. Any decision to approve an exemption request could be appealed to the Community Care and Assisted Living Appeal Board.

The changes recently made to the Residential Care Regulation were in response to a number of Ombudsperson's recommendations to improve the quality of care for seniors in care and their families. Recommendation 171 asked that the Ministry take the necessary steps to amend the Residential Care Regulation to require facility operators to notify residents, families and staff promptly of a decision to close, reduce, expand or substantially change the operations at their facility, or to transfer residents from their facility because of funding decisions.

The purpose of the recent regulatory changes is to promote transparency, as well as to ensure that persons in care and their families are treated in an administratively fair manner. The 120 days' notice gives protection to residents and their families, allowing them time to consider how the pending sale may affect them and allows them time to make any decisions they need to make about their accommodation.

Broader, industry consultation did not occur; however, as part of the Ministry's process to respond to the Ombudsperson's recommendations, staff did discuss the proposed changes with the Home and Community Care Council and industry associations (note: this would have occurred prior to Daniel Fontaine joining the BC Care Providers Association). Impacts to operations were raised, but needed to be considered against the protection of residents and their families (also large scale sales, such as RC, are not typical). The BC Care Providers Association did enquire, on behalf of a member, about the recent regulatory change. The Ministry responded (see Appendix C) and there have been no further inquiries.

FINANCIAL IMPLICATIONS:

RC will likely raise concerns that the 120 days notification period will have financial implications to industry (e.g. impacts on bargaining, staff turnover).

ADVICE:

It is likely that AJ will raise a concern that given the administration of the day to day business is not changing; the MHOs have incorrectly interpreted the regulation. The Ministry should commit to doing a review once the process has completed, including working with the MHOs to review the need to set principles to identify if/when the 120 day notice to families could be shortened.

Changes to ownership and/or operations can have significant impact to residents and staff. In this instance, although there are processes to ensure there are no immediate changes to the operations, there is likely to be significant attention given to the fact the sale is to foreign investors.

In 2012 the Office of the Ombudsperson released 2 reports (see Appendix D). Report 40 – Closing of Cowichan Lodge found that VIHA did not properly inform families and persons in care of the proposed closure of the lodge, and did not apply for an exemption to the Medical Health Officer until very late in the day. There was then the perception when they did apply that the MHO was pressured in his decision making. Report 33 - Fraser Health Authority's Transfer of Seniors from Temporarily Funded Residential Care Beds. The Ombudsperson found that the FHA acted unfairly in deciding to move the residents out of temporarily funded beds in light of its prior written commitment. Two of the seven recommendations included:

- Provide at least 60 days' notice to residents and families of decisions to cease funding beds
- Take action to ensure operators are in compliance with the requirement to provide notice of a decision to close or substantially change a residential care facility.

Hi Mike

The requirement of 120 days notice to the Medical Health Officer has been in the regulations since the mid-1990's, if not longer. What was added was the need to also include notification of family/contact person in the 120 days' notice. The fundamental purpose of the Community Care and Assisted Living Act is to ensure that operators of licensed community care facilities "operate the community care facility in a manner that will promote the health, safety and dignity of persons in care, and...the rights of those persons in care." (Section 7, CCALA). In considering any amendments, government must always consider the best interests of persons in care as well as their health and safety.

The changes recently made to the Residential Care Regulation were in response to a number of Ombudsperson's recommendations to improve the quality of care for seniors in care and their families. Recommendation 171 asked that the Ministry of Health take the necessary steps to amend the Residential Care Regulation to require facility operators to notify residents, families and staff promptly of a decision to:

- close, reduce, expand or substantially change the operations at their facility
- transfer residents from their facility because of funding decisions.

The purpose of the recent regulatory changes is to promote transparency, as well as to ensure that persons in care and their families are treated in an administratively fair manner. The 120 days' notice gives protection to residents and their families, allowing them time to consider how the pending sale may affect them, and allows them time to make any decisions they need to make about their accommodation.

In regards to the consultation process, the legislative and regulatory development process is at all times subject to the rules of Cabinet confidentiality, whereby details of proposed legislation and regulation are protected until such time as they are introduced as a bill by government in the Legislative Assembly (in the case of legislation), or considered and approved by Cabinet (in the case of regulations and Orders in Council). It is not necessarily the case that policy concepts or proposals on which feedback is sought will ultimately be adopted and enacted by government. At times, policy proposals are revised in response to consultations, and it is often the case that some elements of a proposal or policy will not be the subject of public consultation.

I can advise that as part of the Ministry's process to respond to the Ombudspersons'

recommendations, staff did discuss the proposed changes with the Home and Community Care Council and stakeholders, although this may have been prior to Daniel Fontaine joining the BC Care Providers Association (the actual drafting took some time). I understand that impacts to operations were raised, but needed to be considered against the protection of residents and their families.

With these changes to the regulations, the requirement of providing administrative fairness to those affected by a decision (persons in care/families) has been codified, and made explicit, as noted, on the recommendation of the Ombudsperson in her investigations. The same provisions apply for notification and the same consultation process is needed if an operator requests an exemption to the Medical Health Officer to waive the 120 days' notice.

On Short Notice: An Investigation of Vancouver Island Health Authority's Process for Closing Cowichan Lodge¹

On February 14, 2012 the Ombudsperson released Public Report No. 48 *On Short Notice: An Investigation of Vancouver Island Health Authority's Process for Closing Cowichan Lodge.* The report was the result of 46 complaints from people in the Cowichan area who were concerned about and directly affected by Vancouver Island Health Authority's (VIHA) announced closure of a long established seniors' residential care facility in Duncan.

The investigation focused on the following issues:

- Informing residents and family members of the decision to close Cowichan Lodge
- Notifying staff of the decision to close Cowichan Lodge
- The process followed in requesting and granting an exemption to the 12 month notice requirement

The Ombudsperson made six findings and six recommendations. Key recommendations include:

- Developing a publicly available policy that sets out the process to follow when closing a facility (Recommendation 1)
- Considering all relevant factors including employment opportunities and recruitment needs at other facilities that residents might transfer to and where staff might wish to apply when determining a schedule to announce a facility's closure (Recommendation 2)
- Fulfilling the legal obligation to provide 12 month's notice or seek an exemption to regulatory notice periods when planning a facility closure (Recommendation 3(b))
- Establishing a process to ensure an alternate decision maker, not directly affiliated with VIHA, considers VIHA's request for exemption to the 12 month notice requirement (Recommendation 3(c))

Update on Recommendations

VIHA accepted and agreed to implement five of the six recommendations. VIHA indicated it could not accept recommendation 3(c) as it believes it is statutorily bound to refer requests for exemption to the 12 month notice of closure of a residential care facility to VIHA medical health officers.

Honouring Commitments: An Investigation of Fraser Health Authority's Transfer of Seniors from Temporarily Funded Residential Care Beds²

On February 14, 2012 the Ombudsperson released Special Report No. 33 *Honouring Commitments: An Investigation of Fraser Health Authority's Transfer of Seniors from Temporarily Funded Residential Care Beds.* This investigation was the result of complaints received by the Ombudsperson after the Fraser Health Authority (FHA) reversed an earlier written commitment made to seniors at a residential care facility in Surrey.

People complained to the Ombudsperson about the actions taken by FHA beginning in 2008, when FHA made a written commitment to seniors in temporarily funded beds in a residential care facility in Surrey that they would not have to move from that facility. FHA later went back on its commitment and told seniors still living in that facility that the health authority could no longer fund the beds and that they would have to move within a month and a half.

The issues investigated included:

- Whether the decision to move residents was fair and reasonable given the earlier commitment
- Whether the notice provided to residents and families was adequate
- Whether FHA considered the risks to the health and safety of seniors being moved
- Whether the planning processes followed by FHA were sufficient
- Whether FHA required compliance with regulatory notice requirements

The Ombudsperson found that the FHA acted unfairly in deciding to move the residents out of temporarily funded beds in light of its prior written commitment. The investigation resulted in seven findings and nine recommendations.

Key recommendations to FHA included:

- Apologize to residents and families at Newton Regency affected by its decision (Recommendation 1.1)
- Provide at least 60 days' notice to residents and families of decisions to cease funding beds (Recommendation 2.1)
- Inform people whether an offered placement is temporary or permanent and explain the difference between them (Recommendation 2.2)
- When planning to transfer seniors, ensure sufficient flexibility to take individual circumstances into account and to minimize adverse effects (Recommendation 3)
- Take action to ensure operators are in compliance with the requirement to provide notice of a
 decision to close or substantially change a residential care facility (Recommendation 5.1)

Fraser Health Authority agreed to implement all of the recommendations.

 - a covenant from both Retirement Concepts and Cedar Tree to deliver the Transition Plan Framework under the Partner Transition Agreement once prepared, to provide concurrent notice to the Health Authorities of a notice of withdrawal given by a partner of the Operating LLPs pursuant to the Partnership Agreements and to provide the transition plan agreed to by the partners upon such a withdrawal; and

Sale of Retirement Concepts

BACKGROUND REGARDING THE ISSUE:

- On February 23, 2018, Reuters reported that the Chinese government seized control on Anbang Insurance Group Co Ltd, and said its chairman had been prosecuted.
- In a statement, the China Insurance Regulatory Commission (CIRC) said Anbang had violated laws and regulations which "may seriously endanger the solvency of the company."
- Anbang will be taken over for the period of at least one year and will be managed by a
 group of officials from the CIRC.
- An announcement says the group will seek to undertake an equity restructuring of the company. The CIRC also said that Anbang's debt's an obligations will not be impacted by the takeover.
- On June 13, 2017, a Globe and Mail a reporter contacted the Ministry of Health to inform the ministry that Chinese media were reporting Anbang's chairman Wu Xiaohui had been detained by authorities.
- Anbang, a Chinese insurance-holding company, owns Cedar Tree who recently
 purchased 23 of 25 facilities owned by Retirement Concepts (20 in BC, 2 in Alberta and 1
 in Quebec). The sale was subject to federal approval. Under the Investment Canada Act
 (ICA) it is the Federal Minister that is responsible to approve the sale to a non-Canadian
 if over \$600m (increases to \$800m in 2017).
- Criticism of the sale and its lack of transparency received media coverage:

- There is no statutory requirement for the Government of Canada to consult with a
 province respecting a proposed investment under the ICA; however, consultation is
 routinely conducted as a matter of policy.
- The federal government reviews economic/financial issues; any other matters (e.g. health care implications) are not within the purview of the Federal Minister.
- Through the BC Ministry of International Trade, Ministry of Health staff were contacted to provide an outline of the legislation and licensing process.
- BC's Assisted Living and Residential Care regulations outline requirements of applicants for registration or licensing when there is a change in ownership. These regulations are in place to protect the health and safety of residents and persons in care irrespective of ownership.

Under the partnership agreement, Retirement Concepts retains a minority stake and will
continue to manage the day-to-day operations of all of the facilities. Retirement Concepts
committed that there is to be no change to staffing plans, the quality of care provided to
residents, or to policies, procedures and other operating standards.

- The complete terms of the transaction are not available due to confidentiality agreements both at the federal level with Investment Canada and between Retirement Concepts and Cedar Tree.
- Retirement Concepts provides assisted living and residential care services through contract with the health authorities.
- In 2015/16, BC's five regional health authorities paid \$86.52 million combined to Retirement Concepts for contracted assisted living and residential care services. Out of 130 providers, Retirement Concepts was the highest paid across the province; however, health authorities' amount of contracted services varied.

 The table below shows the total amount paid to Retirement Concepts by health authority for 2015/16 and the relative ranking:

- Following the approval of the sale, on March 1, Vancouver Coastal Health (VCH) was given six-month's notice by Retirement Concepts to end its contract with VCH for 20 Assisted Living (AL) units (housing 21 residents) at the Terraces on 7th in Vancouver by September 30, 2017.
- The Terraces is one of two facilities that were not part of the federally approved sale and is still owned by Retirement Concepts.
- After significant media attention, Retirement Concepts rescinded its notice and worked with VCH to find a solution to allow residents to stay until the original agreement end date of March 2019.
- In response to concerns raised about Retirement Concepts and other providers suddenly
 ending contracts in the future the Board of Directors of the BC Care Providers
 Association struck an internal "Assisted Living Tenancy Task Force" to review this matter
 and provide recommendations to prevent future sudden terminations and evictions.

ADVICE AND RECOMMENDED RESPONSE:

- The role of the ministry and health authorities is the health and safety of persons in care – regardless of ownership. That is our number one focus and what we will work to ensure.
- Legislation in place allows the health authorities and the Registrar to continue to monitor these facilities.

- Medical Health Officers and the Assisted Living Registrar monitor care provided in these facilities and can require:
 - o Reports on the operation of licensed facilities,
 - Results of any investigations, or investigations of complaints,
 - o Inspection of books, records or premises in connection with the operation,
 - Require an audit of the operations of a community care facility, and
 - Specify policies and standards of practice.
 - Health authorities have used these powers in situations where facilities have not been in compliance.
- Last year the ministry also took steps to make amendments to the Community Care and Assisted Living Act to provide better protections for seniors including the inspection of a residence at any time if it is felt there is a risk to the health and safety of a resident, and increased oversight protections for incidences of senior's abuse.

If asked about Chinese Government takeover of Anbang:

- We are aware of the Chinese government's actions on February 23 regarding Anbang.
- Our focus will continue to be the health and safety of persons in care regardless of ownership.
- We will continue monitoring the care being provided in these facilities to make sure Cedar Tree and Retirement Concepts are providing their residents with appropriate and quality care.

There is no statutory requirement for the Government of Canada to consult with a province respecting a proposed investment under the Investment Canada Act; however, consultation is routinely conducted as a matter of policy.

The federal government reviews economic/financial issues; any other matters (e.g. health care implications) are not within the purview of the Federal Minister. They have jurisdiction over foreign investment in excess of \$1 billion.

Through the former BC Ministry of International Trade, Ministry of Health staff was contacted to determine whether there were any concerns with non-compliance with provincial regulations.

On June 13, 2017, a Globe and Mail a reporter contacted the Ministry of Health to inform the ministry that Chinese media were reporting Anbang's chairman Wu Xiaohui had been detained by authorities. Anbang, a Chinese insurance-holding company, owns Cedar Tree who recently purchased 23 of 25 facilities owned by Retirement Concepts (20 in BC, 2 in Alberta and 1 in Quebec). The sale was subject to federal approval. Under the Investment Canada Act (ICA) it is the Federal Minister that is responsible to approve the sale to a non-Canadian if over \$600m (increases to \$800m in 2017).

ADVICE TO MINISTER

BC's Assisted Living and Residential Care regulations outline requirements of applicants for registration or licensing when there is a change in ownership. Under the partnership agreement, Retirement Concepts retains a minority stake and will continue to manage the day-to-day operations of all of the facilities. Retirement Concepts committed that there is to be no change to staffing plans, the quality of care provided to residents, or to policies, procedures and other operating standards.

The complete terms of the transaction are not available due to confidentiality agreements both at the federal level with Investment Canada and between Retirement Concepts and Cedar Tree. Retirement Concepts provides assisted living and residential care services through contract with the health authorities.

In 2015/16, BC's five regional health authorities paid \$86.52 million combined to Retirement Concepts for contracted assisted living and residential care services. Out of 130 providers, Retirement Concepts was the highest paid across the province; however, health authorities' amount of contracted services varied.

Following the approval of the sale, on March 1, Vancouver Coastal Health (VCH) was given sixmonth's notice by Retirement Concepts to end its contract with VCH for 20 Assisted Living (AL) units (housing 21 residents) at the Terraces on 7th in Vancouver by September 30, 2017.

The Terraces is one of two facilities that were not part of the federally approved sale and is still owned by Retirement Concepts.

After significant media attention, Retirement Concepts rescinded its notice and worked with VCH to find a solution to allow residents to stay until the original agreement end date of March 2019.

In response to concerns raised about Retirement Concepts and other providers suddenly ending contracts in the future the Board of Directors of the BC Care Providers Association struck an internal "Assisted Living Tenancy Task Force" to review this matter and provide recommendations to prevent future sudden terminations and evictions.

In light of the Reuters story about Anbang this morning, I see that the GM and FP have sought comment on the implications for Retirement Concepts.

- It's worth noting that MJD spoke at length about this in 2016/17 when the initial sale went through and the province deferred the regulatory decisions to the federal government.
- Also worth noting that MDE raised a series of questions about the sale of Bental Centre to Anbang in 2016/17 insofar as the sale was completed as a bare trust and as a result no property transfer taxes were paid.
- Finally, it's worth noting that this will raise parallels to the proposed takeover of Aecon and their potential involvement in Site C construction.

I flag these because it may be best to respond to these from a single point like JTT on the higher level issues associated with the federal government's regulatory responsibility for such sales rather then get into the weeds about Retirement Concepts.
