Hi Kate,

So I tried stripping out all the sub-bullets and it started to look a bit 'thin' - which had me worried.

I don't want people to feel like a lot of good work was 'lost' in an oversimplification. ;)

So I'm giving you two things:

- one document labeled 'headers' with just the headers as we discussed today
- one document labeled 'questions' that has been revised from the original one I gave you to include:
 - the strategic directions
 - the goals (slightly revised from the original I sent)
 - a set of questions that emerged from the discussion at the meeting that could inform the work under that goal
 - some of these questions were in the original document and some I changed. Basically, I took anything that wasn't a question and reformulated it as a question and stripped out all the extraneous stuff.

I feel like including the questions in the report out to this group helps better reflect the work people put into the discussion we had that day, but it doesn't prescribe anything for the work ahead. That way, the questions just help guide people a bit more.

Does that make sense?

Have a look!

My recommendation would be to circulate the longer document, with the questions.

And if any of those questions don't match up with yours or Geoff's direction, they can just be removed from the equation as advice to the teams working on the different goals.

But it's totally your call!

Thx very much for your time last week, when we chatted about Comms doc assistance to MMHA, and perhaps eventually expanding that assistance out wider to other Comm shops.

As you'll recall, we focused in on your "frame more – explain less" doc, and agreed this would be useful and informative to dive into with Comms shops. In addition, I believe it will be really appreciated by more folks.

In further discussions, I'm advised that if we are to draw in entire Comm shops (which I prefer, versus just their CDs/Mgrs), we should try to limit these sessions to 2 hours.

As well, Fri AMs were flagged as not great, because of the # of people that are off Fridays.

So here's my Q's:

- Do-able in two-hour sessions?
- I'm thinking 3 sessions, each combining two Comm shops -- is a group of 21 too large?
 - (MoH and MMHA combined = 21) (the other two groups would only be 12 and 14 people each)
 - If 3 sessions aren't do-able on your end – we could do two sessions – 28 and 20 people
- s.22 – might it be possible to do the 3 Social ministry sessions within the next 3 weeks?

Next steps:

- If you could provide me with a brief summary that will get folks excited/keen about the session – I could canvas them for times that work best for each of the 3 groups.
- From there, I'll work with you to see what works in your schedule.
- After completion of the Social ministries – I'll leave it with my two other ED colleagues to coordinate with you for their shops, if they'd like.

Reporter would like a five minute interview with Minister Conroy in the next day or two. Wants to know about what we're doing in relation to this crisis and its impact on kids, Is this on our radar? What are we doing to support kids and their parents who are being impacted by the opioid crisis?

Background

Background

This is follow-up to a request we responded to on Jan. 9

Recommendation

Our ministry's priority is always to ensure the safety and well-being of a child. That's why anytime a concern is brought to the ministry's attention – for example, if a parent is using substances and may be neglecting a child – we look into the circumstances and assess the risk to the child, as well as the parent's ability to provide care.

We know that the opioid epidemic has had a devastating impact on families and communities throughout the province and we have taken a number of steps to support and respond to the crisis.

We have developed an MCFD Overdose and Prevention Response Plan, which is focused on the practice response to support children and families served by MCFD/DAA's who overdose and/or at risk of overdose.

Under the plan we've provided guidance on precautions for practitioners and caregivers, practice guidelines to support staff in responding to youth at risk and/or parents who may be using illicit drugs, and direction on access to and training on naloxone kits for front line practitioners, caregivers and at-risk families.

MCFD has coordinated overdose awareness and prevention and naloxone training in high-risk communities for front line practitioners, caregivers and youth at risk (12 sessions in the Lower Mainland; 13 sessions on Vancouver Island).

Further, the Provincial Director of Child Welfare is analyzing opioid overdose deaths involving youth served by MCFD/DAA's to potentially identify any learning to strengthen our practice response.

We continue to work across government – including with the Ministry of Mental Health and Addictions and with the BC Coroners Service – to collect and analyze data to better understand the impacts of the overdose crisis so that prevention strategies and policies, as well as resources, can be targeted.
