Recommendation - Provide background

- 1. How long would it take for the Attorney General to appoint an inquiry officer?
 - Under section 12 of the Expropriation Act, the Minister has 21 days within which to appoint an inquiry
 officer.
 - The Act was amended in 2012 to extend the minister's appointment window from 7 to 21 days and since that time, attorneys general have taken very close to if not the full 21 days to appoint an inquiry officer.
 - Once an inquiry officer is appointed, the Attorney General has no further control over the inquiry and its timeline.
- 2. How long would it take the inquiry officer to complete the task?
 - Section 12 of the Act states that an inquiry must occur within 21 days of the appointment of the inquiry officer by the AG.
 - Under Section 17, a report must be issued within 30 days of the first day of an inquiry.
 - Historically it usually takes an inquiry officer close to the full 30 days to complete and deliver their report.
 - Therefore, the entire timeline is a maximum of 72 days from start to finish (21+21+30).

- 2) Can either party dispute the inquiry officer's decision? If so, where would that take place and what does that process look like?

Background

Details on the Expropriation Act: http://www.bclaws.ca/civix/document/id/complete/statreg/96125_01 MAH has dealt with previous requests on the Balmoral/Regent hotels.

Request is a follow-up to earlier content provided:

- 1. How long would it take for the Attorney General to appoint an inquiry officer?
 - Under section 12 of the Expropriation Act, the Minister has 21 days within which to appoint an inquiry officer.
 - The Act was amended in 2012 to extend the minister's appointment window from 7 to 21 days and since that time, attorneys general have taken very close to if not the full 21 days to appoint an inquiry officer.
 - Once an inquiry officer is appointed, the Attorney General has no further control over the inquiry and its timeline.
- 2. How long would it take the inquiry officer to complete the task?
 - Section 12 of the Act states that an inquiry must occur within 21 days of the appointment of the inquiry officer by the AG.
 - Under Section 17, a report must be issued within 30 days of the first day of an inquiry.
 - Historically it usually takes an inquiry officer close to the full 30 days to complete and deliver their report.
 - Therefore, the entire timeline is a maximum of 72 days from start to finish (21+21+30).

Recommendation - Provide background (follow-up)

- 1. Where does the other party file its appeal if it wishes to fight the expropriation? In B.C. Provincial Court?
 - Generally, recourse to courts is not permitted, in accordance with subsection 4 (2).
 - The request for an inquiry is the only way to contest an expropriation. In order to request an inquiry, the "party" or person whose property is going to be expropriated must serve such a request (in writing) on the Attorney General. This is set out in section 10 of the Expropriation Act.
- 2. Can either party dispute the inquiry officer's decision? If so, where would that take place and what does that process look like?
 - With certain limitations, decisions under the Expropriation Act are subject to judicial review. Judicial reviews proceed in BC Supreme Court, and either party can request judicial review.
 - The Judicial Review Procedure Act generally sets out the procedure for requesting a review of an administrative decision. Refer to the following link for further details: www.bclaws.ca/civix/document/id/lc/statreg/96241_01
