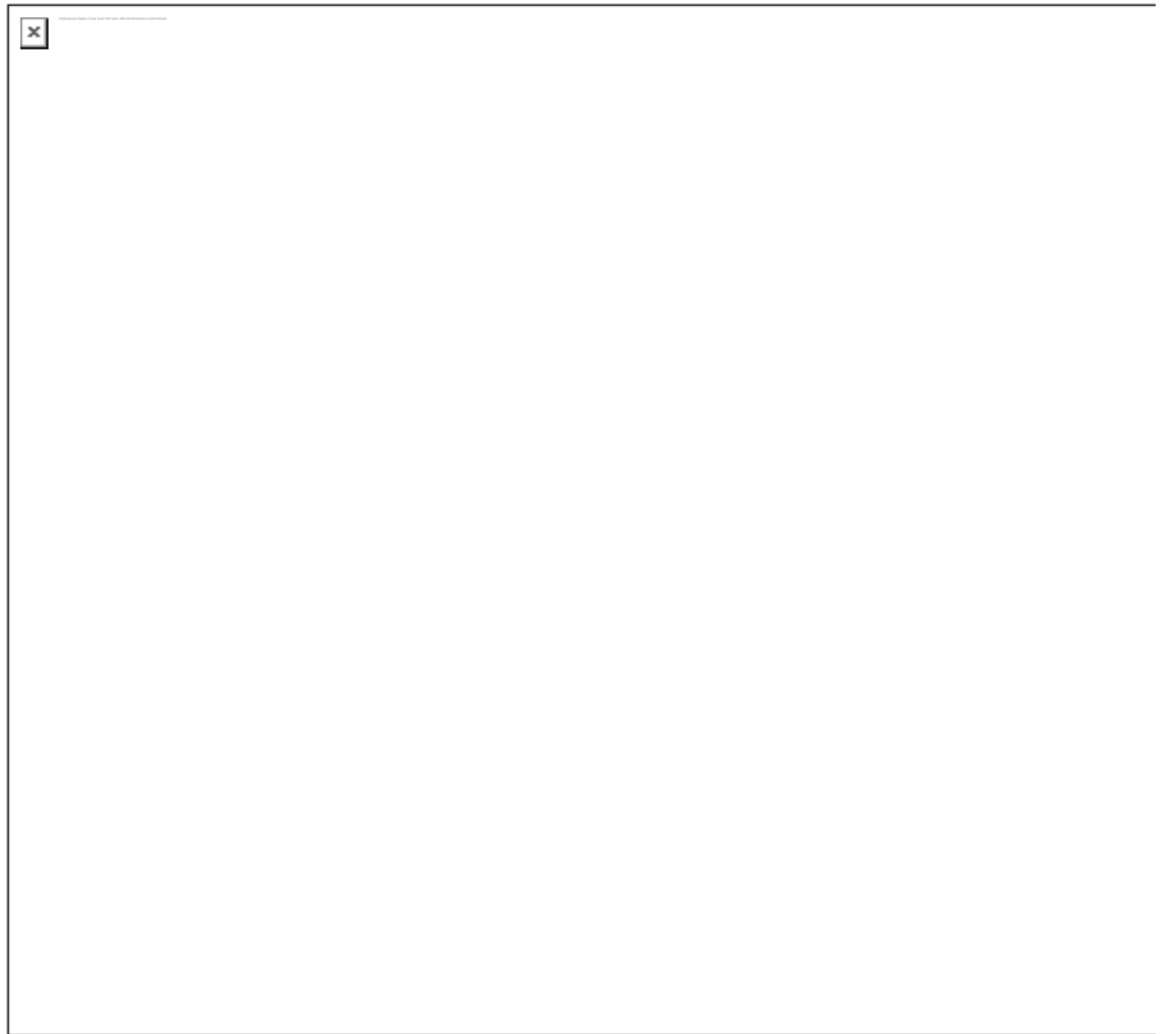

Recommendation: Have GCPE provide information on background by email.

Response:

1. *Is there any plan by the B.C. government to reduce the rolling tolls on the pipeline?*
 - The proposed North Montney Mainline Project would be a federal pipeline and, therefore, under the jurisdiction of the National Energy Board for setting of tolls.
2. *How is this dispute currently being addressed?*
 - According to the National Energy Board's hearing order, they will deliberate on all the evidence and make a decision regarding the North Montney Mainline variance application within 12 weeks of the hearing close of Feb. 20, 2018.
3. *How important to the B.C. economy is the North Montney Mainline extension?*
 - The project is important to B.C. because it allows B.C.'s natural gas resource access to Canadian and U.S. markets.
4. *Does this dispute have any connection to the current dispute between Alberta and B.C. on the Trans Mountain pipeline?*
 - The Alberta government has been clear that their Montney filings are unrelated to the trade dispute. This is the statement they provided to media outlets:

VANCOUVER – A major media outlet has done what the leader of the B.C. Liberals refused to do - released the full version of the B.C. Liberal-suppressed 2014 ICBC report that would have saved British Columbians billions of dollars at ICBC.

“British Columbians paid for this report and deserve to see the recommendations that the B.C. Liberals rejected and hid from the public,” said New Democrat MLA for Delta North Ravi Kahlon. “If the B.C. Wilkinson refused to ask Mike de Jong to exercise his authority as former Finance Minister to waive cabinet privilege so the public could read the report. The public was eventually able to see the pages only because the Vancouver Sun did what Wilkinson refused – released the pages.

B.C. Liberal MLA Todd Stone, who was the minister responsible for ICBC at the time, made it clear that Wilkinson bears significant responsibility for the B.C. Liberals’ bad choices at ICBC. At the November 19th B.C. Liberal leadership debate, Stone told Wilkinson:

“I would remind you that you were sitting at the cabinet table with me for the last four and a half years, as we discussed ICBC many many times.”

Kahlon said the Attorney General and New Democrat government have been working hard to fix the B.C. Liberal mess, and noted many of the recommendations that were rejected and kept secret several years ago match with some of the steps the New Democrat government has initiated.

“This emphasizes the fact that if the B.C. Liberals had just implemented those changes years ago, the mess wouldn’t have grown to such catastrophic proportions,” said Kahlon. “Those were several lost years that the province will have to work overtime to make up for and fix.”

ISSUE: Nanaimo City Hall Turmoil

STATUS: Provided Background

- 1. Has the Minister of Municipal Affairs spoken with the mayor or city council about this situation? Has she urged them to clean up their acts and get council back on track?

The ministry has been following the situation in Nanaimo. There is no formal role for the ministry but support and guidance would be considered if council collectively decides to formally request assistance from the ministry. Local governments are autonomous, responsible and accountable.

Council members have a great responsibility to support and represent the best interests of the community that elected them. The ministry expects Nanaimo city council to resolve any conflict amongst its members respectfully and professionally. Local governments have a range of tools to help elected officials conduct themselves in a responsible manner and provide opportunities for the public to be involved in local decision-making.

- 2. What kind of power does she hold, under the Municipal Act or otherwise, to step in when a council is dysfunctional? Could she, hypothetically, dissolve council, appoint a temporary head of government and call an election, similar to what was done with the Vancouver School Board?

The Minister has the power to intervene when council no longer has quorum and therefore cannot make decisions; this is not the case in this situation. The ministry expects staff and council members to conduct themselves with integrity and professionalism. Ministry staff will be checking in with Nanaimo's corporate officer and will provide assistance as needed.

- 3. If that is within her power, why hasn't she done it in Nanaimo yet? What would it take for her to step in in this situation?

As mentioned, there is no formal role for the ministry but support and guidance would be considered if council collectively decides to formally request assistance from the ministry.

Francesca Fionda - Discourse Media

ISSUE: Aboriginal Housing in BC

STATUS: Provided Background

- We know that adequate housing is an essential part of overall health and well-being for all people, including Indigenous people.

We have reviewed what has been done at the provincial level to date and are looking to expand on that work as part of Budget 2018.

The Province has set a target of creating 114,000 new units of affordable market rental, non-profit, co-op, supported social housing and owner-purchase housing that will include housing for Indigenous people. This will be accomplished in partnership with local governments, the federal government, First Nations and Indigenous organizations and the private and non-profit housing sectors.

The emphasis will be on creating more housing options, improving housing conditions and helping to build a strong Indigenous housing sector.

We are also working with our federal partners given their responsibilities with respect to Indigenous housing.

ISSUE: Rules Governing Municipal Officials in British Columbia

STATUS: Provided Background

- 1. If a mayor decides to run provincially or federally, does s/he have to resign as mayor or take a leave of absence?

There is no requirement for a council member (including the Mayor) to resign from council if they are running in a provincial or federal election; if they do resign, a by-election must be held as soon as is reasonably possible after a vacancy occurs.

- 2. If a leave of absence is a requirement (or even a possibility) would it be paid or unpaid?

There is no legislated concept of a "leave of absence" from the duties of municipal office; therefore, there is no legislated concept of unpaid/paid leave. A council member may request leave from their council to not attend one or more council meetings (Community Charter s. 110(1)(b)). If leave is granted by council, the member would not be subject to the potential disqualification for failure to attend 4 consecutive regular council meetings without leave of the council.

- 3. What if the mayor decides to run for the leadership of a provincial political party? If the mayor is permitted to retain his/her seat while running, and s/he wins, at what point must s/he resign as mayor?

There is no requirement for a council member to resign from council if he or she decides to run for the leadership of a provincial party or to run for provincial office. If an elected provincial or federal member chooses to hold both seats, it becomes a question of the practicality and capacity to fulfil all of his or her obligations to both offices.

4. Must a municipal councillor who wishes to run for mayor in a by-election resign his/her seat?

Under the Local Government Act section 83 (3), if a councilor decides to run for a vacant mayoral position, he or she cannot be nominated until they have resigned from office. This resignation must occur within 14 days of the chief election officer (CEO) being appointed for the by-election.

Premier, thank you for this reply – I apologize for the delay in responding but I wanted to think about this letter and my response.

I am sure you can appreciate, your rejection of our request is very disappointing from the perspective of my constituents who are faced with many dangerous chemicals traversing through their community on a daily basis. While it may be a federal rail issue, as Premier of the Province, you are responsible for the safety of British Columbians, are you not?

Given your government seems to approach every problem or issue by sending it to study, I am truly flummoxed that the Government cannot find \$300k to fund a study that is about working to protect the constituents of many parts of Surrey – White Rock, South Surrey, Panorama – supporting something that the two cities of White Rock and Surrey have expressed need to happen.

A number of your Surrey MLAs & North Delta have expressed support for this study to me as has Andrew Weaver.

As far as the high speed train and the vague reference as to whether or not it could go alongside the freight train, it is interesting as I was just speaking with Vince Lalonde the City Manager for Surrey who indicated it was very much envisioned that the commuter train and freight train could be built side by side (just on a different rail gauge) so could you please indicate who in Surrey your office has been speaking with as there appears to be a difference of opinion. Premier, lives are at risk here. I urge you to reconsider this decision on behalf of the citizens of White Rock and South Surrey who are at substantial risk. Only today we had an issue in Port Coquitlam where a truck hit a train causing a significant fire which burned for many hours. If that had happened in South Surrey, White Rock, we could have had fatalities. Just before Christmas we had the derailment south of the border. This isn't a matter about IF an accident will happen, it is only a matter of WHEN. Please think about this from a non-political, non-jurisdictional perspective and reconsider the decision.

Premier, first of all, many thanks for your willingness to look at this – and for getting right away the opportunity here on multiple fronts to not just improve safety and reduce risk but also to improve the movement of goods and people.

One thing that I didn't specifically mention but something I underlined to Minister Trevena is that the hi speed train could also be a commuter solution from South Surrey (say at the border area) and for Delta (say at the Town & Country area) which would take pressure off of HWY 99 and provide a greener solution. So this project could have many beneficial repercussions and would be a visionary approach to addressing some of the major challenges south of the Fraser.

I should also say that the Mayor of White Rock has invited you and the Minister to the City to see the rail issues and opportunities – if you could spare the time it would be great.

In addition, if Gord Hogg is the successful MP candidate in South Surrey White Rock, we will have another voice for this at the Federal level. Ken Hardie has also been very supportive and my understanding is that this is on the desk of Minister Garneau (I believe he is waiting to hear from Minister Trevena). Prime Minister Trudeau confirmed this when he was out a week or so ago in White Rock.

- the general purposes of the legislation: public bodies should make information available to the public; individuals should have access to personal information about themselves;
- the wording of the discretionary exception and the interests which the section attempts to balance;
- whether the individual's request could be satisfied by severing the record and by providing the applicant
- with as much information as is reasonably practicable;
- the historical practice of the public body with respect to the release of similar types of documents;
- the nature of the record and the extent to which the document is significant and/or sensitive to the public body;
- whether the disclosure of the information will increase public confidence in the operation of the public body;
- the age of the record;
- whether there is a sympathetic or compelling need to release materials;
- whether previous orders of the Commissioner have ruled that similar types of records or information should or should not be subject to disclosure; and
- when the policy advice exception is claimed, whether the decision to which the advice or recommendations relates has already been made.

VICTORIA – Last week, Andrew Wilkinson came out against the B.C. government's proposed measures to tackle speculation.

"After his B.C. Liberal government let the cost of housing soar out of reach for people, Andrew Wilkinson is still putting real estate speculators ahead of British Columbians trying to afford a home," said B.C. Government House Leader Mike Farnworth.

In a radio interview, Wilkinson criticized the government's proposed tax on real estate speculation. When asked what he would do to address the housing crisis, Wilkinson repeatedly emphasized the importance of building housing supply while refusing to even acknowledge that speculation was a problem.

"His government's bad choices led to this crisis, and now he's fighting against the new government's solutions," Farnworth said. "Letting speculation run wild might be good for people with 5 million dollar homes, but it's not good for the millions of British Columbians struggling with the cost of housing."

The full Simi Sara transcript from Feb 21 follows

Highlights:

Simi Sara interview, Feb 21 CKNW

They're increasing income taxes by a billion dollars. And that's an 11% increase in one year. That means about \$1,000 per family.

- This is entirely false. There are no personal income tax increases in this budget
- Total revenues from personal income tax are going up because of economic growth (Table 1.5, page 11)
- Only the top 2% are paying more, and that is from Budget Update 2017. That was only in effect for part of the last fiscal year.
- Otherwise the increase in revenues from PIT are a result of growth in the economy.
- Only the top 2% are paying more – as a result of the September 2017 update, everyone else is unchanged.

They're putting up the carbon tax and they're not reducing taxes in other places. So that's \$80 per vehicle this year and \$160 per vehicle next year.

- On carbon tax, the Budget documents are clear that the carbon tax increase will be about \$50 for a family of four with a \$50,000 annual income (p75)
- And we are giving enhanced rebates to low and moderate-income British Columbians. The maximum annual amount will increase by \$19.50 per adult and \$5.50 per child. So a family of four would get up to \$50 back.
- And we are eliminating MSP saving families up to \$1800

This idea of the speculation tax is going to hit everybody who owns a home. It's basically a minimum income tax.

- This is not true.
- Primary residences and any property that is a long-term rental will be fully exempt
- Rural areas are not covered by the speculation tax
- And BC residents who own a second home that is vacant would receive an income tax credit to offset.

They will provide... you can offset it with your income tax, so if, for instance, we'll guess that you're making \$100,000 a year at CKNW and you're paying \$30,000 income tax, they'll say that's okay. But if you're only paying \$20,000 income tax, maybe we'll just top that up.

- I'm not clear what he is actually suggesting here but pretty sure it isn't true.
