In going thru an FOI response to be approved - there is an email in this particular FOI package that had 6 Issue Notes on a wide variety of subjects attached to the one email.

Altho the FOI request is specific to a subject addressed in only one of the Issue Notes - all 6 Issue Notes must be released as part of the package because they were contained in that one captured email.

I did discuss this further today with the FOI person for clarity, and she said that FOI decision/ruling/process has changed from how it was done in the past, and is now applied in this all-encompassing way.

Just a friendly reminder - where possible, keeping emails to dealing with one subject at a time helps ensure cleaner/easier processing of related FOI requests.
