The following provides an update on the current Ministry of Agriculture response and impacts from the ongoing flooding situation in the province. A more detailed report is also attached.

NEA PREOC:

Feed & Livestock

- POTENTIAL EMERGING ISSUE: producers (~60 head beef cattle) in Punchaw region of Regional District Fraser Fort George (RDFFG, SW of Prince George) self-identified as impacted by flooding.
 - o AGRI has encouraged that producers and RDFFG connect regarding this issue to determine if official request will be developed and it is anticipated that field visit by RD will occur later today.
 - o AGRI is advance planning regarding potential hay sources and alternate routes as area roads are impacted/closed by current conditions. **This is not a confirmed request for assistance under EMBC at this time.**
- The two horses reported as lost on April 30th have been reported on social media/video as being rescued from floodwater by members of Nazko FN community.
 - o AGRI will seek confirmation from community leadership.

- AGRI is supporting Advanced Planning Unit looking at agriculture activity in vicinity of Baker Creek and Quesnel River

- Interactive agriculture mapping account is up and running and is being used in advanced planning. Link has been circulated.

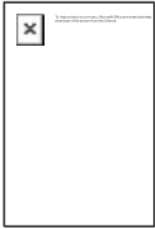

ISSUE: Indigenous Education

STATUS: Provided Background

- We are committed to closing the gap in student achievement and improving outcomes for indigenous students.
- While the graduation rate in B.C. is about 84%, the results for Indigenous students still lag behind by 18% at 66%.
- B.C. is implementing two major pieces -- the new curriculum with embedded Indigenous content, and the Calls to Action from the Truth and Reconciliation Commission.
- We are ensuring content in B.C.'s curriculum accurately and fairly reflects the rich history and significant contributions of indigenous people.
- We're acknowledging the painful legacy of residential schools.

- We are working with Indigenous peoples, language experts and school districts to develop full-course offerings in Indigenous languages.
- Budget 2018 provides a historic \$50 million investment for the preservation and revitalization of Indigenous languages in BC.
- We have approved 17 Indigenous language curricula to be taught in B.C. schools, and another six are under development.
- For 2017/2018, the ministry is providing an extra \$190,000 to support resource development for Indigenous language curricula of the 17 languages.
- 19 districts that have developed First Nations language curricula will each get \$10,000.
- We will work closely with FNEESC (the First Nations Education Steering Committee) and Metis Nation BC to increase the number of Indigenous teachers in the education system. We have already invested \$260,000 to enable UBC to pilot community-based delivery of its Indigenous Teacher Education Program to about 20 Indigenous students.

TRC Calls to Action and Ministry Responses

Call to Action #62 (4 sub-recommendations):

1. Make age-appropriate curriculum on residential schools, Treaties and Aboriginal peoples' historical and contemporary contributions to Canada, a mandatory education requirement for Kindergarten to Grade 12 students;
 - Kindergarten to Grade 9 curriculum, through collaboration with Aboriginal peoples, has been revised and implemented beginning in 2016-17. Grade 10 curriculum will be implemented this September with grades 11 and 12 being implemented at the start of the September 2019/20 school year.
 - The curriculum contains age appropriate content related to Aboriginal peoples' history, and includes the residential school era. To assist teachers to implement these aspects of the curriculum, the Ministry has also produced a teacher guide, *Aboriginal Worldviews and Perspectives in the Classroom: Moving Forward*, available for order or free download at https://www2.gov.bc.ca/assets/gov/education/administration/kindergarten-to-grade-12/aboriginal-education/awp_moving_forward.pdf
2. Provide the necessary funding to post-secondary institutions to educate teachers on how to integrate Indigenous knowledge and teaching methods into classrooms;
 - As of September 2012, all teachers graduating from BC teacher education programs must complete three credits related to the historical context of First Nations Inuit and Métis learners.
3. Provide the necessary funding to Aboriginal schools to utilize Indigenous knowledge and teaching methods in classrooms; and,
 - While the funding responsibility for First Nations based-operated schools on reserve rests with the federal government, the Province is contributing in several ways:

- o The Province pays reciprocal tuition to these schools whenever they serve students otherwise eligible for a free BC public school education.

- o BC, Canada, and First Nations, as represented by the First Nations Education Steering Committee (FNESC), are implementing the Tripartite Education Framework Agreement (TEFA), which has provided First Nations on-reserve schools with federal funding comparable to what the Province provides public schools.

- o Moreover, through TEFA, BC is sharing expertise and learning resources with the federal government and First Nations to help build capacity in the First Nations education system.

- o The Ministry has implemented the Equity in Action project specifically to look at ways to improve Indigenous student results and combat the “racism of low expectations” faced by Indigenous students.

4. Establish senior-level positions in government at the assistant deputy minister level or higher dedicated to Aboriginal content in curriculum.

- The Assistant Deputy Minister, Learning Division, and the Executive Lead, Learning Transformation Division, who is responsible for the learning modernization project, share the responsibility of ensuring that Aboriginal content is embedded in all curricula.

Call to Action #64:

Asks all levels of government that provide public funds to denominational schools to require such schools to provide an education on comparative religious studies, which must include a segment on Aboriginal spiritual beliefs and practices developed in collaboration with Aboriginal Elders.

- All faith-based schools in BC follow the BC curriculum, which includes specific aspect and references to Aboriginal cultures, languages, history and spirituality.
