Our vision for a transformed community health-care system is about making choices that give people more access to the care they need – it focuses on the needs of patients and families and considers the needs of our valued health care providers.

To improve access and deliver better care we will:

- **Work in teams.** In teams, doctors and nurse practitioners will be able to accept more patients into their practices because they will be supported by other professionals such as nurses, social workers, pharmacists, psychologists, physiotherapist, and dieticians, who can help manage everyday health issues.
- **Build networks.** When health authorities, health-care providers, and community-based health and social service organizations are linked together in community networks, coordinating care for patients will be seamless, making it easier for people to receive referrals to all the services they need.
- **Establish Urgent Primary Care Centres.** These centres will be open evenings and weekends and use a team of providers to provide same-day, urgent, non-emergency care.
- **Link patients and providers.** A provincial waitlist will be established to attach patients to available health-care providers. As well, people will be able to use digital technology to connect with their care team through websites, email, text and video conference.
- **Include Community Health Centres.** The community health centre model of health promotion and social services will be integrated into the delivery of primary care.
- **Specialized services.** Each network will be connected to specialized programs with coordinated referral systems for key areas: older seniors, mental health and substance use, cancer care and surgical and diagnostic programs.

To support this transformation in community health care, Budget 2018 provides \$150 million over three years.

Keep in mind that in all cases, we can rearrange whatever furniture that is not bolted to the floor.

Our **first choice** would be 2039, 2040 attached

- Pros: bright, open space, wide lanes, in new, renovated space on the first floor, dynamic backdrop, looks/feels like tech, surrounded by people at work though not in a space that will be disruptive to employees. Great location from which to begin the media tour
- Cons: a distance from the main doors. Route is wheelchair accessible but guests will need to be escorted from reception. Might look a bit empty if employees are shy/move away from their desks. We could plant a few people at surrounding desks if this is the case

**Second choice** 2036

- Pros: Open space, wide lanes, dynamic backdrop, looks/feels like tech, surrounded by people at work though not in a space that will be disruptive to employees, preferred from an office security perspective (located immediately beside reception), will not require an escort
