For your per diem claims, you have to put in the time your trip began (when you left the office or home) and the time your trip ended (the time you arrived back home or the office) in the "justification" section for the expense to show that you qualify for the claim. This is only required in the justification on your first day of per diem claim and your last, not for the claims in between. Just a reminder, in order to qualify for breakfast, your trip must have had to start before 7am, lunch before 12pm, and dinner before 6pm.

I've also included the travel allowances for your reference.

New benefit helps 60,000 more families with child care expenses

BURNABY - With the launch of its new Affordable Child Care Benefit, the provincial government is making child care more affordable for 80,000 B.C. families.

This is four times the number of families that benefited from the previous child care subsidy.

"Parents throughout this province have been struggling with rising child care costs, and it's clear that we need to make child care more affordable for more middle-income families," said Premier John Horgan. "Our hope is that this makes a big difference for families, and that they can get a little further ahead every month. When more parents can choose to rejoin the workforce if they want to, that's good for people and the economy.

In making the announcement, Premier Horgan said the new benefit program will expand the household income threshold for qualification to \$111,000, up from \$55,000 under the old subsidy.

The new Affordable Child Care Benefit is part of government's ChildCare BC plan, released in Budget 2018. Combined with the Child Care Fee Reduction Initiative announced earlier this year, this benefit means some B.C. families may end up paying no fees for the child care they need.

"The new, expanded benefit will give parents more options - whether they choose to join or return to the workforce, find quality child care, or just have a bit more breathing room in their monthly budgets," said Katrine Conroy, Minister of Children and Family Development. "Parents have been clear that this benefit - either alone or in combination with this spring's fee reduction initiative - will make life better for their families."

Over 80,000 B.C. families are now eligible for some level of support through the benefit. Under the previous subsidy, only 20,000 families were eligible. The benefit amount for infant/toddler care has also been increased, with some families now eligible for up to \$1,250 a month per child, up from \$750 per child, marking a 67% increase.

"Child care was neglected for too long in this province, leaving families worried and scrambling. We're listening to what families need and our priority is affordable, accessible, and quality child care for people around the province," said

Katrina Chen, Minister of State of Child Care. "We've made a lot of changes since announcing our \$1-billion ChildCare BC plan in February, and there's more to come."

Parents can apply now for the new benefit through My Family Services, a new online process that makes it faster and easier to apply for support. Parents can also use an online estimator to see if they are eligible for the benefit and how much they may be able to save each month.

The Affordable Child Care Benefit is the second affordability measure to be launched under ChildCare BC. The first, the Child Care Fee Reduction Initiative, was launched in April 2018, and is helping licensed child care providers reduce their fees by up to \$350. As of Aug. 24, nearly 3,000 providers have so far been approved for fee reductions, representing more than 50,000 spaces.

Under ChildCare BC, the Province is investing more than \$1 billion in child care over the next three years, to lay the foundation for a universal child care system.

In the coming weeks, the B.C. government will announce the child care facilities that have been selected as prototype sites to offer child care at \$10 a day or less.

  - \* welcoming 1,837 children and their families who are newly eligible for support.
- \* Since the My Family Services tool for the benefit was launched, more than 3,235 applications have been submitted.
- \* During the last week of August, B.C. families used My Family Services to submit approximately 500 new applications and benefit renewals per day.
- \* The number of applications for funding usually peaks in September of each year. To make sure families and child care providers are well supported through the launch of the benefit, the ministry has hired 82 additional staff to process applications and answer calls. #### BACKGROUND

80,000 B.C. parents will save under Affordable Child Care Benefit

The Province's \$630-million investment to make child care more affordable for B.C. families comes as part of a three-year, \$1-billion investment in ChildCare BC.

This is the most significant child care investment in B.C.'s history. This historic investment makes important changes in affordability, accessibility and quality.

#### Affordability

The Province has moved quickly to support parents who are struggling with the high cost of child care. The Affordable Child Care Benefit replaces the existing Child Care Subsidy, expands eligibility to families with a pre-tax income of up to \$111,000 (up from \$55,000 under the previous subsidy), and will support around 86,000 families by 2021.

The new Affordable Child Care Benefit complements the Child Care Fee Reduction Initiative, introduced in April 2018, which helps lower the cost of child care for parents at approved licensed child care facilities by up to \$350 a month per child.

To date, more than 50,000 spaces have been approved for a reduction in fees, and the initiative has put more than \$35 million back in parents' pockets. Providers who have been approved for the initiative are listed online: [www.gov.bc.ca/childcare/optin](http://www.gov.bc.ca/childcare/optin)

## Accessibility

The ChildCare BC New Spaces Fund is helping to address the shortage of child care spaces throughout the province by supporting the creation of up to 22,000 new licensed spaces over the next three years: [www.gov.bc.ca/childcare/newspacesfund](http://www.gov.bc.ca/childcare/newspacesfund)

The new ChildCare BC Maintenance Fund, introduced in June 2018, will help eligible child care providers to maintain existing spaces by providing funding to help them with minor repairs or to replace equipment in order to meet licensing standards. The fund also helps cover relocation costs for eligible providers so they can quickly move their operations, if needed, and continue to support B.C. children and their families: [www.gov.bc.ca/ccmaintenancefund](http://www.gov.bc.ca/ccmaintenancefund)

In June 2018, the Province launched the Start-Up Grant program to support individuals and unlicensed child care providers to become licensed. Applicants can apply for funding to help them cover the costs of becoming licensed, including training and application fees for licensing, hiring replacement staff while taking a course and buying equipment for a child care facility. Becoming licensed allows providers to care for more children, and will help to enhance the quality of child care in B.C.: [www.gov.bc.ca/childcare/startupgrants](http://www.gov.bc.ca/childcare/startupgrants)

Over the coming months, the Province will also look to build and strengthen partnerships with local governments to create new child care spaces. Working together will help leverage existing public spaces to build new child care facilities more quickly.

## Quality

A key goal under ChildCare BC is to improve the quality of B.C.'s child care system through enhanced supports for early childhood educators (ECEs) and other child care professionals. Quality will be achieved by enhancing training and development opportunities, as well as addressing the issue of wages and recruitment in the sector.

Early childhood educators are an essential part of the Province's goal to deliver quality child care to B.C. families. To this end, ChildCare BC is delivering \$136 million to better support ECEs over the first three years of its 10-year plan. On Sept. 5, 2018, the Province launched an Early Care and Learning Recruitment and Retention Strategy that lays out the key aspects of the quality pillar of ChildCare BC.

Starting in January 2019, ECEs working in licensed child care facilities that have opted in to the Child Care Fee Reduction will receive a wage enhancement of \$1 per hour, followed by another \$1-per-hour increase in April 2020.

The Ministry of Children and Family Development, in partnership with Early Childhood Educators of BC, provides a bursary for students who are enrolled in early childhood educational programs at one of 32 approved post-secondary institutions in B.C. The Early Care and Learning Strategy includes a \$10-million expansion of this bursary, with support from the Government of Canada under the federal-provincial Early Learning and Child Care Agreement: [www.ecebc.ca/programs/student\\_bursary.html](http://www.ecebc.ca/programs/student_bursary.html)

In order to increase training and development opportunities for ECEs throughout the province, the Ministry of Advanced Education, Skills and Training is investing \$7.4 million over the next three years to fund an additional 620 early childhood educator seats at B.C.'s public post-secondary institutions.

Early Learning and Child Care Agreement with the Government of Canada

Investments under ChildCare BC are complemented by the Province's three-year, \$153-million Early Learning and Child Care Agreement (ELCC) with the Government of Canada, which was signed in February 2018.

Under ELCC, the Province is investing \$60 million to create Universal Child Care prototype sites in B.C. Launching in Fall 2018, this project will fund approximately 1,800 child care spaces to offer child care at a cost of \$200 a month, or less, per child:

The Province has also committed \$30 million to expand Aboriginal Head Start programs in B.C. These programs provide culturally based, inclusive child care and early learning, family bonding and prevention services. In May 2018, the Province announced an additional \$3 million over three years, on top of its annual funding of \$1.6 million, to boost the monthly funding amount available to eligible young parents to up to \$1,500 a month per child. New benefit helps 60,000 more families with child care expenses

BURNABY - With the launch of its new Affordable Child Care Benefit, the provincial government is making child care more affordable for 80,000 B.C. families.

This is four times the number of families that benefited from the previous child care subsidy.

"Parents throughout this province have been struggling with rising child care costs, and it's clear that we need to make child care more affordable for more middle-income families," said Premier John Horgan. "Our hope is that this makes a big difference for families, and that they can get a little further ahead every month. When more parents can choose to rejoin the workforce if they want to, that's good for people and the economy.

In making the announcement, Premier Horgan said the new benefit program will expand the household income threshold for qualification to \$111,000, up from \$55,000 under the old subsidy.

The new Affordable Child Care Benefit is part of government's ChildCare BC plan, released in Budget 2018. Combined with the Child Care Fee Reduction Initiative announced earlier this year, this benefit means some B.C. families may end up paying no fees for the child care they need.

"The new, expanded benefit will give parents more options - whether they choose to join or return to the workforce, find quality child care, or just have a bit more breathing room in their monthly budgets," said Katrine Conroy, Minister of Children and Family Development. "Parents have been clear that this benefit - either alone or in combination with this spring's fee reduction initiative - will make life better for their families."

Over 80,000 B.C. families are now eligible for some level of support through the benefit. Under the previous subsidy, only 20,000 families were eligible. The benefit amount for infant/toddler care has also been increased, with some families now eligible for up to \$1,250 a month per child, up from \$750 per child, marking a 67% increase.

"Child care was neglected for too long in this province, leaving families worried and scrambling. We're listening to what families need and our priority is affordable, accessible, and quality child care for people around the province," said Katrina Chen, Minister of State of Child Care. "We've made a lot of changes since announcing our \$1-billion ChildCare BC plan in February, and there's more to come."

Parents can apply now for the new benefit through My Family Services, a new online process that makes it faster and easier to apply for support. Parents can also use an online estimator to see if they are eligible for the benefit and how much they may be able to save each month.

The Affordable Child Care Benefit is the second affordability measure to be launched under ChildCare BC. The first, the Child Care Fee Reduction Initiative, was launched in April 2018, and is helping licensed child care providers reduce their fees by up to \$350. As of Aug. 24, nearly 3,000 providers have so far been approved for fee reductions, representing more than 50,000 spaces.

Under ChildCare BC, the Province is investing more than \$1 billion in child care over the next three years, to lay the foundation for a universal child care system.

In the coming weeks, the B.C. government will announce the child care facilities that have been selected as prototype sites to offer child care at \$10 a day or less.

- \* Since the My Family Services tool for the benefit was launched, more than 3,235 applications have been submitted.
- \* During the last week of August 2018, B.C. families used My Family Services to submit approximately 500 new applications and benefit renewals per day.
- \* The number of applications for funding usually peaks in September of each year. To make sure families and child care providers are well supported through the launch of the benefit, the ministry has hired 82 additional staff to process applications and answer calls. More staff will be hired through the fall as volumes increase.

#### BACKGROUNDER

80,000 B.C. parents will save under Affordable Child Care Benefit

The Province's \$630-million investment to make child care more affordable for B.C. families comes as part of a three-year, \$1-billion investment in ChildCare BC.

This is the most significant child care investment in B.C.'s history. This historic investment makes important changes in affordability, accessibility and quality.

#### Affordability

The Province has moved quickly to support parents who are struggling with the high cost of child care. The Affordable Child Care Benefit replaces the existing Child Care Subsidy, expands eligibility to families with a pre-tax income of up to \$111,000 (up from \$55,000 under the previous subsidy), and will support around 86,000 families by 2021.

The new Affordable Child Care Benefit complements the Child Care Fee Reduction Initiative, introduced in April 2018, which helps lower the cost of child care for parents at approved licensed child care facilities by up to \$350 a month per child.

To date, more than 50,000 spaces have been approved for a reduction in fees, and the initiative has put more than \$35 million back in parents' pockets. Providers who have been approved for the initiative are listed online:

#### Accessibility

The ChildCare BC New Spaces Fund is helping to address the shortage of child care spaces throughout the province by supporting the creation of up to 22,000 new licensed spaces over the next three years:

The new ChildCare BC Maintenance Fund, introduced in June 2018, will help eligible child care providers to maintain existing spaces by providing funding to help them with minor repairs or to replace equipment in order to meet licensing standards. The fund also helps cover relocation costs for eligible providers so they can quickly move their operations, if needed, and continue to support B.C. children and their families: [www.gov.bc.ca/ccmaintenancefund](http://www.gov.bc.ca/ccmaintenancefund)

In June 2018, the Province launched the Start-Up Grant program to support individuals and unlicensed child care providers to become licensed. Applicants can apply for funding to help them cover the costs of becoming licensed, including training and application fees for licensing, hiring replacement staff while taking a course and buying equipment for a child care facility. Becoming licensed allows providers to care for more children, and will help to enhance the quality of child care in B.C.: [www.gov.bc.ca/childcare/startupgrants](http://www.gov.bc.ca/childcare/startupgrants)

Over the coming months, the Province will also look to build and strengthen partnerships with local governments to create new child care spaces. Working together will help leverage existing public spaces to build new child care facilities more quickly.

## Quality

A key goal under ChildCare BC is to improve the quality of B.C.'s child care system through enhanced supports for early childhood educators (ECEs) and other child care professionals. Quality will be achieved by enhancing training and development opportunities, as well as addressing the issue of wages and recruitment in the sector.

Early childhood educators are an essential part of the Province's goal to deliver quality child care to B.C. families. To this end, ChildCare BC is delivering \$136 million to better support ECEs over the first three years of its 10-year plan. On Sept. 5, 2018, the Province launched an Early Care and Learning Recruitment and Retention Strategy that lays out the key aspects of the quality pillar of ChildCare BC.

Starting in January 2019, ECEs working in licensed child care facilities that have opted in to the Child Care Fee Reduction will receive a wage enhancement of \$1 per hour, followed by another \$1-per-hour increase in April 2020.

The Ministry of Children and Family Development, in partnership with Early Childhood Educators of BC, provides a bursary for students who are enrolled in early childhood educational programs at one of 32 approved post-secondary institutions in B.C. The Early Care and Learning Strategy includes a \$10-million expansion of this bursary, with support from the Government of Canada under the federal-provincial Early Learning and Child Care Agreement: [www.ecebc.ca/programs/student\\_bursary.html](http://www.ecebc.ca/programs/student_bursary.html)

In order to increase training and development opportunities for ECEs throughout the province, the Ministry of Advanced Education, Skills and Training is investing \$7.4 million over the next three years to fund an additional 620 early childhood educator seats at B.C.'s public post-secondary institutions.

## Early Learning and Child Care Agreement with the Government of Canada

Investments under ChildCare BC are complemented by the Province's three-year, \$153-million Early Learning and Child Care Agreement (ELCC) with the Government of Canada, which was signed in February 2018.

Under ELCC, the Province is investing \$60 million to create Universal Child Care prototype sites in B.C. Launching in Fall 2018, this project will fund approximately 1,800 child care spaces to offer child care at a cost of \$200 a month, or less, per child: [www.gov.bc.ca/childcareprototypesites](http://www.gov.bc.ca/childcareprototypesites)

The Province has also committed \$30 million to expand Aboriginal Head Start programs in B.C. These programs provide culturally based, inclusive child care and early learning, family bonding and prevention services. In May 2018, the Province announced an additional \$3 million over three years, on top of its annual funding of \$1.6 million, to boost the monthly funding amount available to eligible young parents to up to \$1,500 a month per child.
