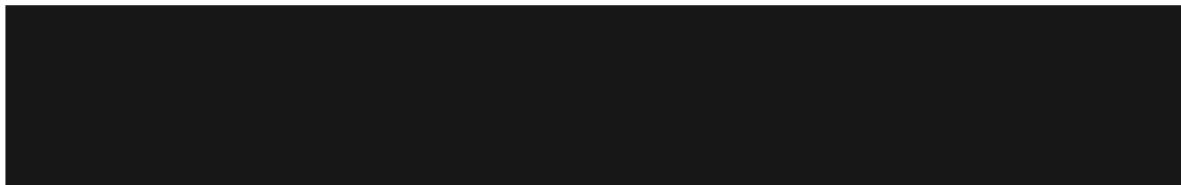

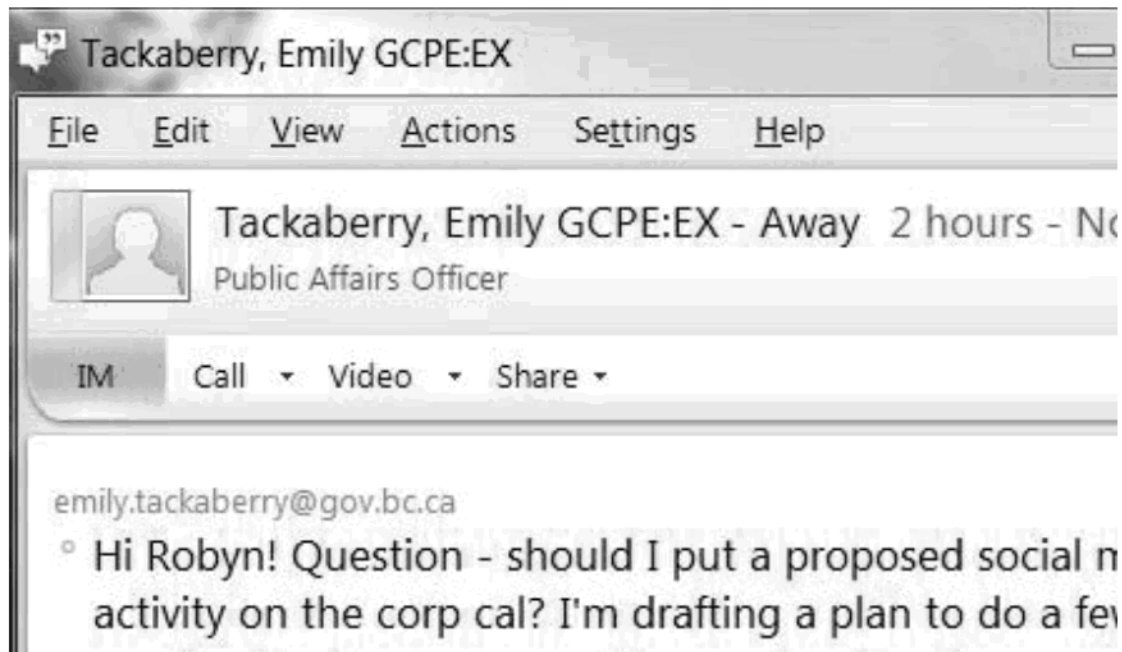

Purpose of Review

Given the Ministry of Forests, Lands, Natural Resources Operations and Rural Development's current forest inventory program priorities, direction, resourcing, available technologies, and the social license required to manage BC's forest resources, the purpose of the review is to determine:

- Is the forest inventory program meeting the current and future needs of users?
- And if not, what recommended changes can be made to optimize the program to meet those needs?

Why the Review

The last forest inventory program review was completed in 2009 – nearly 10 years ago – and there have been significant changes in inventory approaches since that review. There have also been significant forest changes due to the mountain pine beetle and wildfire – leading to concerns about the currency of the inventory, and assessments of mid-term timber supply and impacts on forest dependent communities. The needs of key clients may also have changed. The provincial government wants to expand investments in reforestation and modernize land-use planning – this requires a useful and reliable forest inventory.

Half-Masting period: Pursuant to Section 12 of the British Columbia policy on half-masting, flags will be flown at half-mast from now until sunset February 3, 2018 and again from sunrise to sunset on the day of the funeral or memorial service (to be determined) to honour the memory of Dave Barrett, former Premier of British Columbia, who passed away in Victoria on February 2, 2018.

Mr. Barrett, a member of the Order of Canada and the Order of British Columbia, served as Premier from 1972-1975.

Other information will be forwarded once it becomes available.

Occasion: Death of former British Columbia Premier Dave Barrett, O.C., O.B.C

Half-Masting locations: Legislative Building in Victoria and on all British Columbia government buildings and establishments.

Notes: Where a Canadian flag and a British Columbia flag fly near to one other, both flags should be lowered to half-mast.
Whereas February 3 is on a weekend, if there are no maintenance staff working that day it is acceptable to lower flags to half-mast at the end of the day on Friday and return them to full mast on Monday morning.
