Good afternoon

The Ministry is adding a new authority under the *Forest Act* to allow the Minister to reject a cutting or road permit application if it will compromise BC Timber Sales (BCTS) ability to provide adequate, representative price and cost information for the Market Pricing System (MPS). This authority will only apply in BCTS operating areas that are established by regulation.

BCTS was established in 2003 to provide price and cost information to the MPS by planning, developing and auctioning Crown timber for approximately 20% of the provincial annual allowable cut (AAC). BCTS was allocated 20% of the provincial AAC as it represents a statistically defensible sample size for use of information in the MPS. They work in specified operating areas that represent the timber profile and operating conditions found throughout the province and which is experienced by the forest licensees in harvesting the remaining 80% of the AAC. The cost and price data in the MPS is used to calculate stumpage rates across the province and the auction price information is considered to reflect the fair market value of BC timber so supports BCs argument under the Softwood Lumber Dispute that BC does not subsidise its forest industry.

When cutting or road permits are issued, within BCTS operating areas, that prevents BCTS from meeting that target of 20% of the AAC each year it weakens our argument that we don't subsidise our forest industry and increases the variability in the stumpage rates leading to some companies being over charged and others under charged. This reduces industry confidence in the MPS and increases uncertainty in the market.

This new authority to reject a cutting or road permit in specific circumstances will help to ensure BCTS achieves its auction target and the MPS stays strong, the market stable and jobs in local communities continue.

We are targeting the June 20th cabinet meeting for approval so that the regulation may be implemented on July 1st.

It appears that this amendment may have connection to item 2 (k) in the CASA. Please let me know if you have any questions or there is any other information required.
