For your reference, this is what the Ministry has provided to reporters over the last week. James is calling you about this specific request shortly.

Response:

We know people want more options for getting around quickly, safely and affordably. The Province is committed to bringing in a safe, fair and accessible, "made in B.C." solution for taxis and other passenger directed vehicles in B.C.

The existing framework for taxi service in B.C. is outdated and needs to be modernized before ride hailing becomes available.

That's why, last fall, government hired industry expert Dr. Dan Hara to consult with stakeholders including the taxi and ride hailing industry, and to make recommendations on how to improve the existing framework for taxi services so that when ride hailing is introduced in B.C. the taxi industry can thrive and compete.

Out of respect for all of the stakeholders that took the time to provide feedback, we will take the necessary time to thoroughly review both Dr. Hara's report and that of the all-party committee, and as promised will publicly report out this spring on this government's next steps for taxi and ride hailing.
