- **They have also provided communications systems, disaster psycho-social supports, HEPA filters to increase indoor air quality, and emergency social services (ESS) for all ordered evacuees.**
- **On Wednesday, we opened a group lodging centre in Burns Lake for 200 people, including members from Cheslatta, Nee-Tahi-Buhn, and Skin-Tyee First Nations.**
- **We are having daily calls with affected First Nation communities to answer questions, provide assistance and support, including helping with forms, resource requests and notifications and expense eligibility.**
- **Response agencies have put in place a number of new processes and resources to improve how we engage and partner with Indigenous communities, including Indigenous liaisons in Provincial Regional Emergency Operation Centres.**
- **First Nations have extensive knowledge and a deep connection to the forests, waters and lands of their territories. We are working to include this wisdom and experience in our approach to planning around – and responding to – wildfires.**

- Given the unpredictable behaviour of this year's wildfires and the number of significant wildfires in all areas of the province, we're bringing in the additional resources we need to keep people and communities as safe as possible.
- We heard that some First Nations expressed concern about communication on wildfires between the Nations and the Province.
- As a result, we have increased our communication with First Nations, and reached out to specific nations that have expressed concern. The Provincial Regional Emergency Operation Centre has been communicating daily with Nadleh Whut'en Nation, and provincial staff met with community leaders August 16th.
- The BC Wildfire Service, Emergency Management BC, and Ministry of Indigenous Relations and Reconciliation staff are working closely with the First Nations Health Authority, Indigenous Services Canada, First Nations community members and members of the First Nations Leadership Council to find ways to provide support to communities in the ways they need.
- The BC Wildfire Service is doing risk assessments and connecting with representatives from First Nations communities.
- In addition, in support of the provincial emergency structure, the Ministry of Indigenous Relations and Reconciliation staff are working at the Provincial Emergency Coordination Centre in Victoria and the Provincial Regional Emergency Operation Centres (PREOCs) in Prince George and Terrace, as well as at a joint Emergency Operation Centre with the Tahltan Nation in Dease Lake, to assist PREOCs in ensuring appropriate support for Indigenous communities and to address all requests and concerns as promptly as possible.
- Emergency Management BC has been coordinating daily, regional calls to ensure that wildfire experts, First Nations emergency management professionals and First Nations leaders are equipped with the most up-to-date information.
- Ensuring the safety of First Nations members and communities, and supporting the health needs and basic essentials for evacuees from their communities, remains a top priority for all of the agencies involved.
