Hi Caitlin and Donna,

I was just going through Bill 37 – Land Statutes Amendment Act and a few questions came up that I wanted to confirm prior to second reading tomorrow. Since it's pretty short notice to arrange a briefing I've written the questions here – would it be possible to receive confirmation / details from FLNRORD? We would really appreciate it so that we can more accurately speak to the proposed changes.

1) In regards to the change to section 50 of the *Land Act*:

- a. It is our understanding that this change will increase flexibility for Treaty negotiations, allowing for treaties to include more self-governance and control of resources such as mineral reserves that might be on Treaty land. Is this correct? Would it be possible to get some more background on what this change will offer and what its potential limitations could be?
- b. Could this change be applied to an agreement that has already been finalized? I.e. could a Treaty First Nation use this amendment to reclaim authority that was not provided for previously?
- c. How have First Nations been engaged in this process?

2) What is the significance of the changes made by this bill not being phased in until 2020? Does that just refer to the start date for the e-filing system?

Thanks in advance for your help on this, and feel free to let me know if there's any clarification needed.

B.C. and UBCM work together to advance reconciliation

WHISTLER - The Province and the Union of B.C. Municipalities (UBCM) have reaffirmed their commitment to working together toward reconciliation with Indigenous peoples in British Columbia.

"A fundamental truth of reconciliation is the need to work together to right past wrongs and move forward in a direction that will benefit everyone," said Scott Fraser, Minister of Indigenous Relations and Reconciliation. "This agreement strengthens the partnership between our government, municipalities and Indigenous communities so we can take that journey together."

A renewed memorandum of understanding (MOU) between the Ministry of Indigenous Relations and Reconciliation and UBCM underscores the importance of the provincial government's relationship with local governments in fulfilling the commitment to reconciliation. It now supports working in partnership with Indigenous peoples in B.C. and in implementing the United Nations Declaration on the Rights of Indigenous Peoples and the Truth and Reconciliation Commission's Calls to Action.

"Local governments are a key partner in the Province's efforts for reconciliation with Indigenous peoples," said Selina Robinson, Minister of Municipal Affairs and Housing. "This agreement affirms the importance of strong relationships between all levels of government that are needed to gain a better understanding of Indigenous priorities and begin the process of true reconciliation that benefits everyone."

In addition to reflecting governments' commitments to reconciliation, the MOU reaffirms both parties' commitment to regular discussions on matters that affect local government jurisdictions, including treaty negotiations and non-treaty agreements, as well as other initiatives with Indigenous communities.

The agreement highlights the need for local governments to continue developing relationships at a grassroots level with Indigenous governments and communities to create conversations and partnerships that will benefit everyone at the community level.

"The level of consultation that has gone into the renewal of this MOU gives us confidence that its intent will be fulfilled," said Wendy Booth, UBCM president. "We welcome a stronger collaborative relationship in the vital undertaking of reconciliation with Indigenous peoples, and are ready to fulfil our role in this partnership."
