- To date there have been no cases of it being found in B.C. or North America.
- The Ministry of Agriculture is working with the federal government and B.C.'s pork producers to take
 preventative action to reduce the risk of African Swine Fever from entering BC farms.
- The B.C. government has invested in and worked with industry to have biosecurity infrastructure disinfectant equipment on farm and at abattoirs so they are prepared for contagious diseases.
- B.C.'s commercial hog producers have disinfectant equipment on site to prevent the virus spreading, with training in place for their workforce
- BC pork producers take great care in providing for their animals, and I expect they will take the
 precautions to protect their animals here.

Background

- The virus can be carried in pork products, or on the clothing or objects of people who visit infected farms.
- It has recently been found and is continuing to spread in China and Eastern Europe in increasing numbers.
- ASF is a deadly disease of pigs that is contagious and causes high mortality. There is no vaccine or treatment available, so preventative actions are key.



Why now? Why is this the first time BC livestock have died due to anthrax?

- Anthrax occurs naturally in livestock on the Canadian Prairies and in Northern Alberta, and is established in Alberta's Wood Buffalo National Park.
- The soil types in the Peace Region, where the livestock were infected, has similar soil types as (neighboring) Northern Alberta, and it is not surprising the soil has anthrax bacteria too.
- The bacteria can remain dormant in soil under certain conditions for many years.
- The spores are present in the soil. As a result of feeding and rooting around the animals ingest the spores.
- Once ingested the spores germinate into bacteria within the digestive tract and enter the blood stream, resulting in dissemination throughout the body and widespread infection.

Are other BC livestock in danger? Why or Why not? How could we help prevent these animals from being poisoned?

- Anthrax is only found in some soil types that are common to the Peace area, and is not found frequently in soil types common to other regions such as the Okanagan, Lower Mainland or Cariboo.
- An effective vaccine for anthrax for livestock is available and animals that have been exposed to anthrax spores in soil are often successfully treated if diagnosed early.
- Livestock producers seeking advice on the prevention, diagnosis and treatment of anthrax cases in their herd are encouraged to contact their veterinarian.

Are other animals in the region such as deer in danger of being exposed to Anthrax as well?

- Wildlife in the Peace area are at the same risk level as previous years, in that they live in an environment with anthrax bacteria in the soils.
- Based on only the one confirmed location with affected animals in our province, the risk remains very low.

Key Messages

- These farms have been impacted by the flooding, and the BC government is looking at available options to see what help can be provided.
- We want to act quickly, so these farms can continue their recovery efforts, and prepare for next year and season, but to find the right solution takes time.
- Ministry of Agriculture and Emergency Management BC staff continue to work together to ensure all available opportunities to support the farmers are being carefully considered.

• We recognize the current measures do not provide coverage for farmers in these specific situations, and in addition to looking for ways in which we can support these farms, we are also reviewing program criteria for future years to consider how we can prevent these types of situations from happening again.

Background

- A nursery and a few farms in the Grand Forks area and an organic vegetable farm in the Similkameen valley experienced significant damages following flooding in the spring of 2018.
- The flooding resulted in the fields being covered in debris, which requires clean up, as well as repairs to dykes
- Initiative can lead to coverage of extraordinary expenses experienced by farmers in extreme weather events with regional impacts (wildfires, widespread rains and floods), but not for events that cause isolated and localized damages such as these farms experienced.
- The farms do not qualify for Emergency Management B.C.'s Disaster Financial Assistance programs meant to help in these situations because they fall outside of programs criteria:
 - They are excluded from support provided to individuals (and farmers) because their farms are incorporated as businesses
 - They don't qualify for support from the small business program, because their annual revenues exceed the criteria limit of \$1 million
- Provincial government staff continue to work together to develop options under which support could be provided.

Anthrax confirmed in Peace-area livestock

FORT ST. JOHN - A diagnosis of naturally acquired anthrax has been confirmed in the death of 13 livestock on a farm near Fort St. John.

The animals are thought to have contracted the disease from exposure to dormant anthrax spores in the soil of a feeding site, which is no longer being used. No further losses on the farm, which has a herd of more than 150 animals, have been reported.

Anthrax occurs naturally in livestock on the Canadian Prairies and in Northern Alberta, and is established in Alberta's Wood Buffalo National Park. The bacteria can remain dormant in soil under certain conditions for many years,

An effective vaccine for anthrax for livestock is available and the rest of the herd on the infected farm will be vaccinated. Animals that have been exposed to anthrax spores in soil are often successfully treated if diagnosed early. Livestock producers seeking advice on the prevention, diagnosis and treatment of anthrax cases in their herd are encouraged to contact their veterinarian.

Though anthrax can affect humans, infection is very rare and there have been no indications of anyone in contact with the animals being infected. Public health officials have identified individuals who might have been in contact with the source of infection, and are following up with those individuals directly to assess their health and provide health advice. There is no health risk to the general public.

People handling infected animals or contaminated products may contact anthrax spores through cuts or scrapes on their skin, resulting in sores and infection that can be treated with antibiotics.

Quick Facts:

- * The anthrax found in soil poses a greatly reduced risk compared to anthrax spores treated to disperse in air where they can be inhaled. These so-called weaponized versions of anthrax can lead to severe lung infections.
- * The most recent cases of human anthrax were in Saskatchewan in 2006 and involved people with skin infections, all of whom recovered fully.
