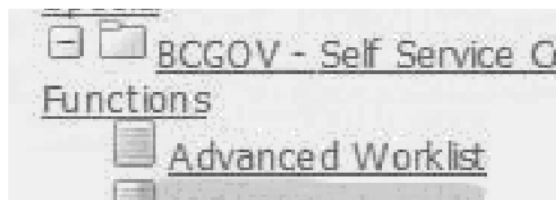

Wanted to bring you into this discussion for advice and to see if you agree with my suggested path forward. Below is an email chain where we have sought clarity on the options and timelines for the insert.

To summarize the emails –

1. Paper option: #80 text stock paper (satin or dull) is the only paper that has been tested with the envelope stuffing machines at Queen's Printer. We will need to select either 'satin' or 'dull' by Nov. 23.
 - a. My recommendation – seek advice from the marketing firm at our earliest opportunity next week which paper option (satin or dull) we should order.
2. Format: A "C" fold of 8.5 x 11" size paper has been tested and is strongly recommended.
 - a. Recommendation – proceed with content development based on this option, so that we have the content nailed by the time the firm is able to start working on layout. They will need to deliver final, approved version to us by the middle of December to meet Queen's Printer's deadline for printing.

Hello,

Sorry for the delayed response, I was waiting to hear back from the Queen's Printer. Below are answers to your questions:

1. What are the paper options – the #80 text stock paper (satin or dull) that we tested can still be delivered in time. If we go with any other paper type or size, there would need to be additional testing at BC Mail and I don't believe there is time to obtain samples and conduct testing.
2. What size and fold format was tested - two types of 8.5 x 11" size paper were tested at BC Mail; a #80 dull finish (similar to the rural property tax insert in 2017) and, at GCPE's request, a #80 100% recycled Canadian produced "satin" finish paper.

A "C" fold (or tri-fold) was strongly recommended as the best option for BC Mail's machinery. At the time of testing we asked Brad Benoit, our eTax developer who coordinates the testing with BC Mail, about the flexibility of the paper size changing and he said "a "C" fold is crucial for them [BC Mail] to have a single edge to machine insert into the envelopes, a "Z" fold leaves two edges which results in paper jams which means delays and possibly us [eTax] needing to regenerate letters manually. A different size of paper would also likely cause some concern so we would want to consult them [BC Mail] if there is a different paper size." Unfortunately, I haven't been able to get a hold of Brad today.

3. Any hard deadlines – Yes, Queen's Printer has confirmed that it is still possible to obtain the #80 text stock paper (satin or dull) if we order it by Friday, November 23 (at the VERY latest) . The sooner QP can do an invitation to quote, the better chances we have of securing the paper. The paper takes 6 weeks to come from the mill. The final insert artwork would need to be to QP/printing company by the middle of December.

VICTORIA - British Columbians are invited to provide input to a fact-finding review of potential money laundering in horse racing, real estate and luxury car sales by reporting information through an anonymous tip portal.

"British Columbians want their government to crack down on money laundering, wherever it takes place. We agree and we also believe that British Columbians can help," said David Eby, Attorney General. "That's why we're providing people in B.C. with a secure and anonymous way to share what they know."

In June 2018, the attorney general released the Peter German report on anti-money laundering in Lower Mainland casinos. Following this work, in September 2018, the Province launched two subsequent probes into money laundering in the real estate sector. One probe, led by German, is investigating instances of illicit activity on behalf of the Ministry of Attorney General. The other probe, led by Maureen Maloney and the Ministry of Finance, is looking for legislative, regulatory and other actions that can be taken to prevent money laundering.

German now is seeking information and submissions from British Columbians related to the areas identified in his official terms of reference:

- * connections between organized crime and money laundering in the horse racing and luxury car industries;
- * money laundering in the real estate sector connected to criminal enterprises in B.C. or elsewhere, including analysis of the extent of the problem;
- * the use of lawyers' trust accounts to mask sources of funds in real estate transactions;
- * money laundering in the construction industry, including abuse of builders' liens; and
- * any other conduct in which there may be an identifiable link between organized crime and real estate transactions in B.C.

If German identifies instances of money laundering in any of these areas, he is to inquire into the nature, extent and history of these issues and deliver findings to government.

Individuals can anonymously report suspicions of money laundering through a tip portal until Jan. 31, 2019.
