# Update on RCMP's enforcement of injunction in Houston, BC

Over the last few days since January 7, 2019 when the RCMP began their enforcement of the court ordered injunction, there has been ongoing dialogue between the Wet'suwet'en Hereditary Chiefs, Coastal GasLink (CGL) and RCMP.

During an extended meeting on January 10, 2019 which lasted 4 and a half hours, the parties were able to come to an understanding on several items:

- From this point forward, the camp set up by the Unist'ot'en across the Morice River Bridge will be officially referred to as the "Unist'ot'en Healing Centre";
- The temporary exclusion zone set up by the RCMP will be removed in the morning of January 11, 2019 once access to the Morice River Bridge is established;
- There will be continued police presence conducting roving patrols of the Morice West Forest Service Road to ensure the safety of the individuals at the Healing Centre and of CGL employees;
- In our commitment to ensuring the safety and security of all individuals involved, a Community-Industry Safety Office (C-ISO) will be placed in the Morice West Forest Service Road corridor as a temporary RCMP detachment. It will remain in place as long as deemed necessary by all parties;
- Police officers working out of the C-ISO will be General Duty police officers and will undergo cultural awareness training on the Wet'suwet'en traditions and will have enhanced training in conflict resolution.

We would like to once again emphasize that the RCMP's focus remains on creating an environment conducive to getting all parties to come to the table and continue to participate in these fruitful discussions. We will do everything possible to facilitate and support those meetings moving forward, while maintaining peace and keeping everyone safe.

Excellency,

I would like to inform you that in the course of its 97th Session, the Committee on the Elimination of Racial Discrimination considered information received related to Site C dam and its impact on affected indigenous peoples in the Province of British Columbia, in Canada.

According to the information received, the provincial government of British Columbia announced, in December 2017, that construction of the Site C dam would continue. In this regard, the Union of British Columbia Indian Chiefs (UBCIC) has launched a civil suit against the construction of the dam and asked for an interim injunction, subsequently denied, to halt construction until the case is settled.

The Committee is concerned about the alleged lack of measures taken to ensure the right to consultation and free, prior and informed consent with regard to the Site C dam, considering its impact on indigenous peoples control and use of their lands and natural resources.

The Committee is further concerned that the realization of the Site C dam without free, prior and informed consent, would permanently affects the land rights of affected indigenous peoples in the Province of British Columbia. Accordingly, it would infringe indigenous peoples' rights protected under the International Convention on the Elimination of All Forms of Racial Discrimination.

The Committee would like to recall paragraph 20 of its 2017 concluding observations (CERD/C/CAN/CO/21-23), and

requests the State party to provide information on the steps taken to suspend the Site C dam until free, prior and informed consent is obtained, following the full and adequate discharge of the duty to consult. In this regard, the Committee encourages the State party to consider engaging with the United Nations Expert Mechanism on the Rights of Indigenous Peoples (EMRIP) that is mandated by the Human Rights Council (resolution 33/25, paragraph 2), to provide States with technical advice on the rights of indigenous peoples and facilitate dialogue between States, indigenous peoples and/or the private sector. In accordance with article 9 (1) of the Convention and article 65 of its Rules of Procedure, the Committee requests the State party to submit its response before 8 April 2019.

Allow me, Excellency, to reiterate the wish of the Committee to continue to engage in a constructive dialogue with the Government of Canada, with a view to ensuring the effective implementation of the Convention.

Given the explicit commitment to UNDRIP in this letter, the permits which were given to Coastal GasLink to build pipeline infrastructure on unceded Wet'suwet'en territory — which ultimately resulted in Wet'suwet'en defiance of a Supreme Court injunction and police enforcement on Monday at kilometre 44 of Morice West forest service road — appear to be responsible for a situation in which, according to Article 10 of UNDRIP, the RCMP performed illegal arrests and transportation (removal) of Indigenous people from their territories.

It appears that Coastal GasLink's project also denies Wet'suwet'en access to or destroys historically significant aspects of their land (the Kweese war trail) and fails to protect that land to their standards — the land being a critical part of Wet'suwet'en identity and culture — which likewise violates UNDRIP, specifically Articles 8a and 8c. If you could address these claims, I would appreciate it.

#### Suggested Response:

- The Coastal GasLink Project received its environmental assessment certificate on October 24, 2014.

In response to a number of queries, Premier John Horgan has reviewed the transcript of his remarks during the news conference of January 9, 2019 regarding the events in Unis'tot'en territory.

The passage that raised concern reads: "And the challenge for government, federal and provincial, is determining how we bring together these historic band councils modelled with, as I understand it, the emerging hereditary model that's very much manifesting itself in Wet'suwet'en territory."

The Premier's comments regarding the hereditary model were intended to refer to the traditional, long-standing and now "re-emerging hereditary model," in contrast to the Indian Act band council model imposed in the 19th century. The use of the word "emerging" during the news conference has caused confusion.

In the Premier's view, it is the mutual responsibility of all governments to shift their relationships and arrangements with Indigenous peoples to one that is based on recognition for and support of implementation of their right to self determination, including the inherent right of self-government for Indigenous nations.

Given the explicit commitment to UNDRIP in this letter, the permits which were given to Coastal GasLink to build pipeline infrastructure on unceded Wet'suwet'en territory — which ultimately resulted in Wet'suwet'en defiance of a Supreme Court injunction and police enforcement on Monday at kilometre 44 of Morice West forest service road — appear to be responsible for a situation in which, according to Article 10 of UNDRIP, the RCMP performed illegal arrests and transportation (removal) of Indigenous people from their territories.

It appears that Coastal GasLink's project also denies Wet'suwet'en access to or destroys historically significant aspects of their land (the Kweese war trail) and fails to protect that land to their standards — the land being a critical part of Wet'suwet'en identity and culture — which likewise violates UNDRIP, specifically Articles 8a and 8c.
