Opportunity: Zero Emission Vehicle (ZEV) Mandate

- In its Clean Transportation Intentions Paper that was presented for public feedback over the summer, the Province referenced a ZEV mandate as one of the measures it was considering to reduce GHG emissions from the transportation sector. There was strong support for a ZEV mandate among respondents.
- Similar mandates are in effect in Quebec, California and other U.S. states and jurisdictions.
- A ZEV mandate will help to address a shortage of ZEVs in BC dealer lots that was identified in a report from Clean Energy Canada in October 2018. The study found that a majority of the 322 B.C. car dealerships that qualify for the province's ZEV rebate program don't have any ZEVs on the lot, that only 40% of dealerships had a single ZEV on the lot, leading to wait times of as much as 18 months before somebody would be able to get a ZEV without even getting a chance to test drive it.
- A ZEV mandate will also help ensure that British Columbians have more choices in the ZEV models available here – some ZEV models are going to other jurisdictions with mandates and not coming here.
- In conjunction with establishing a ZEV mandate for B.C., the government intends to roll out a new vehicle incentive program, with the details to be included in the upcoming strategy and February Budget.

Hi,

Further to our conversation the other day, our MO has confirmed that our remaining misc bill will go forward the week of Nov 19.

It will include:

- Civil Resolution Tribunal (gives tribunal jurisdiction over MVA disputes up to \$50,000)
- Class Proceedings Act (requires 50% of undistributed awards and settlement to be disbursed to the Law Foundation of BC to facilitate access to justice)
- Gaming Control Act (materials attached)
- Legal Profession Act (expand the professionals who are able to provide legal services to include licensed paralegals)

Our understanding is that all this legislation will be introduced together, but we had originally planned for gaming to be a standalone – and it still might be. As such, there are two calendar entries related to this:

- AG-89926 (catch-all statute amendments/misc bill)
- AG-89546 Gaming Control Act

We already have draft material for gaming (attached) and should have a drafts for the catch-all early next week.
